

FEDERAL COURT OF AUSTRALIA - FINANCIAL YEAR 2007-08 SENATE ORDER ON DEPARTMENTAL AND AGENCY CONTRACTS LISTING RELATING TO THE PERIOD 1 JULY 2007 TO 30 JUNE 2008

Pursuant to the Senate Order on departmental and agency contracts the following table sets out contracts entered into by the Federal Court of Australia which provide for a consideration to the value of \$100,000 or more and which:

- (a) have not been fully performed as at 30 June 2008; or,
- (b) have been entered into during the 12 months prior to 30 June 2008.

Most of the contracts listed contain confidentiality provisions of a general nature that are designed to protect the confidential information of the parties that may be obtained or generated in carrying out the contract. The reasons for including such clauses include:

- (a) ordinary commercial prudence that requires protection of trade secrets, propriety information and the like; and/or,
- (b) protection of other Commonwealth material and personal information.

Estimated cost of complying with this order: \$1,000 for the Financial Year 2007-08 listing.

Basis of method used to estimate the cost: application of appropriate salary costs to the estimated time taken to collect, analyse and compile the required information on the Court's Internet site.

NOTES TO TABLE

Note 1: The Amount of Consideration: The amount of consideration is an anticipated contract value, including GST, based on an assessment of the total price for the services over the expected life of the contract. The actual value for services based contracts may vary from time to time.

Note 2: Proportional Contribution: The amount of consideration is a Federal Court of Australia proportional contribution to a multiple Agency Agreement with a supplier and not a Contract which is entered into solely by the Federal Court of Australia.

Note 3: Whole of Government Agreement: The amount of consideration is the Federal Court of Australia estimated aggregate total value of vehicle leases entered into for the nominated Financial Year (ref FMB 10/04 of 23-04-2004 at www.finance.gov.au).
