Hi John,

As discussed, Coca-Cola Europacific Partners Australia has recently conducted a pricing review on our product range. Following this review, there will be an increase in the standard wholesale pricing for some of our products effective for deliveries on and from **Monday, 31 January 2022**. Please find letter outlining these changes with an updated price list to follow next week.

Additionally, we have received notification from Exchange for Change (NSW) Pty Ltd and Exchange for Change (ACT) Pty Ltd that it will be reducing the pricing it charges to beverage manufacturers from 31 January 2022. As a result, Coca-Cola Europacific Partners Australia will decrease the CDS Rate applicable for New South Wales and Australian Capital Territory. Please find details of these changes attached also.

I will provide further updates next week and we will continue to work with your team on ensuring all necessary information is provided as required.
