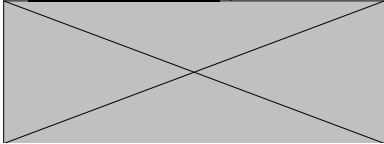

I have sent the below cases back to you so we can align on timing Monday and you can edit the dates to ensure they line up.

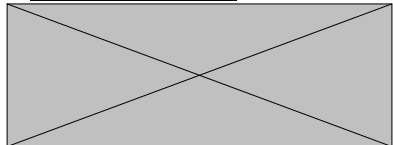

To rectify this, James has now updated the sell price to the correct sell price before moving onto the dropped program effective tomorrow 02/04. Woolworths will ensure that the new deferred deals are not accepted for these lines until they are put onto the dropped program. We can discuss how we address the diminished margin on these lines post CPI next week.

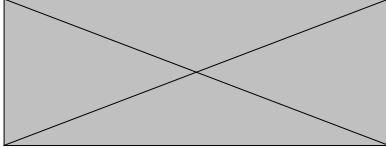

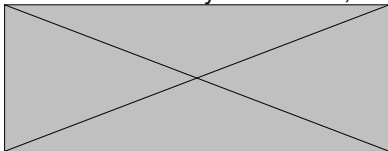
