Expert report on Faruqi v Hanson - Federal Court of Australia proceedings no. NSD 372 of 2023



#### Qualifications

- 2. I have a PhD in Composition and Cultural Rhetoric from Syracuse University. Currently, I am an Associate Professor with Tenure at the University of Houston where I have taught rhetoric and writing courses for 15 years. My areas of research generally focus on political and legal rhetoric, and more specifically on how politicians and news media use repetitive phrases and memes to impact public opinion and voting practices. My scholarship draws from rhetorical scholars who see language use as more than persuasion and debate, but as central to how people come into understanding and shape their lives. Aristotle in *Book II* of *The Rhetoric* discusses how political persuasion is not tied to logic, but instead the stirring of emotion. Aristotle asserts that emotions are not illogical but have their own predictable processes which can urge people to act.
- 3. Additionally, I subscribe to the notion that rhetorical meaning is not predicated on intention, but instead the power of rhetoric resides in its affects. This means instead of verifying *why* a public figure makes certain claims, I look at those claims or statements within the politician's public archive which includes interviews, social media, and statements made in session; how the statement fits with political party history and beliefs; and finally, how the politician's statements are circulated and responded to by media, social media, and/or other public figures. In other words, I seek to understand a full picture of a public figure's rhetorical statements to determine if statements align with their public persona or brand. And then, I seek to understand how those statements and beliefs sway legislation or public opinion on a particular issue.
- 4. For example, my first monograph *Branded Bodies, Rhetoric, and the Neoliberal Nation-State* (Lexington 2013) analyzed how both the U.S. Republican and Democratic parties used repetitive phrasing to disenfranchise immigrant and LGBTQ communities, resulting in the passing of oppressive legislation which impacted each group. I have published my analyses of how statements made by public figures circulate and impact public opinion and legislation at the city, state, and national level in several peer reviewed articles, and I have been interviewed or asked to write opinion pieces by several US national media outlets focusing on the impact of President Donald Trump's anti-immigrant and LGBTQ rhetoric. I have included my full CV as Appendix 1.

#### Statement of Facts and Assumption of Facts

5. I draw upon a collection of Australian legal documents pertaining to the legal proceedings Faruqi vs Hanson; select interviews by Senator Hanson; select publicly circulated social media posts by Senator Hanson and Senator Faruqi; numbers of likes and/or shares for said posts; and evidence of threats of violence against Senator Faruqi received after Senator Hanson's Tweet directed at Senator Faruqi. I have included my Letter of Instruction as Appendix 2. A supplement to my Letter of Instruction is included as Appendix 3.

#### Expert Opinion

- 6. The phrase "go back to where you came from" has stood in for anti-immigrant sentiment in Western countries since nation-states began limiting immigration. Even the United States, with its cultivated image of a "melting pot," has not made immigration easy or accepted across its history. As early as 1798 *The Alien and Sedition* acts were a way to not only limit immigration from certain countries using quotas, but also to allow the removal of immigrants if they were deemed to be anti-American. The phrase "go back to where you came from" may have circulated between neighbors prior to 1798, but once immigrants and anti-American sentiments were tied together, the phrase began circulating in print and in political speeches.<sup>1</sup>
- 7. Ever since, the phrase "go back to where you came from" has been used to remind immigrants that they don't truly belong in the US. Whether it be because of sheer numbers the US is too populous with too few resources to allow a new influx of immigrants or because immigrants are seen as diluting the national imaginary<sup>2</sup> with their different histories and cultures, the idea that immigrants should "go back to where they came from" has circulated colloquially.
- 8. But most damaging is when the phrase has risen to the level of national political discourse. In July 2019, President Donald Trump told four junior representatives who were critical of his policies to "go back to where they came from."<sup>3</sup> This sparked not only a renewed discussion of the US immigration policy, but also a backlash against Reps. Alexandria Ocasio-Cortez of New York, Ilhan Omar of Minnesota, Ayanna Pressley of Massachusetts, and Rashida Tlaib of Michigan. Each minority congressperson saw an increase in threats of violence and verbal harassment on their social media accounts. It is my opinion that the President Trump's use of "go back to where you came from" gave implicit consent to his followers who did not agree with the congresspersons' opinions *and* to those who are anti-immigrant to harass these women.
- 9. The above example demonstrates just how intertwined anti-immigrant sentiments and the anti-American label are, *and* how they can be signaled with one simple phrase "go back to where you came from." This phrase has become a shorthand that not only resonates with current debates about immigration, but also draws upon long held assumptions and historical debates about immigration.<sup>4</sup> The phrase becomes a *palimpsest* that carries with it all connotations the phrase has carried through history. Like a paper that has been erased but maintains the shadow and/or indentations of previous writings, a palimpsest never loses previous markings, and instead the new writings become imbued and carry with them previous markings.
- 10. "Go back to where you came from" is a phrase that carries with it historical anti-immigrant and nativist beliefs. It is so ubiquitous across history, it merely needs to be uttered and people understand that the recipient is being flagged as not belonging, either because there is no room and/or resources for them or because their beliefs do not align with those of the receiving country's citizens. I recognize I am repeating the link between Anti-Immigrant and Anti-American, but I do so to show

that although the first legislative maneuver to link the two sentiments in the US was in 1798, the linking of the two sentiments persists even today. Like a palimpsest, the sentiments remain even though the circumstances, groups of immigrants, and political stakes have changed.

- 11. I would now like to turn my attention to how anti-immigrant sentiment is also embedded in the phrase "go back to where you came from" in Australia. Whereas the US oscillates between assimilation rhetoric (e.g. the melting pot) and nativist rhetoric (e.g. Mexicans are thieves; Muslims are terrorists), Australia focuses on the rhetoric of multiculturalism and due process for all citizens. In fact, unlike the US, Australia has enshrined the rights of citizens to be treated fairly regardless of race with *The Racial Discrimination Act.*<sup>5</sup> The arguments above about how "go back to where you came from" is used in the US are not exactly the same as how the phrase is used in Australia. But even though Australia has a different national context than the US, the presence of anti-immigrant sentiment can be felt and tied to specific legislative practices.
- 12. In his book *White Nation*, Ghassan Hage claims Australia's multicultural policy is a response to the "need to control marked bodies" within its boundaries. The multicultural policy allows for immigrants to be defined as acceptable or dangerous. According to Hage both types of immigrants function to help define the Australian nation state as a benevolent white nation.<sup>6</sup> Those immigrants who are deemed acceptable are admitted into the nation state, and are often reminded that this recognition is a gift (the gift of citizenship).<sup>7</sup> To be accepted even though one is marked as an immigrant functions not only to put the immigrant in his/her place within the nation state, but it serves to allow those who have granted the immigrant entrance into Australia the ability to think of themselves as liberal and benevolent. What this situation presupposes is the dominant class within the community will always control the acceptance of immigrants who will never be fully equal. They will always be marked.
- 13. Hage's theory of "the gift of citizenship" discerns between immigrants based on the perceived threat they pose to the nation-state. And part of that threat lies how different an immigrant's looks, language, and cultural practices are from that of the receiving country. In fact, Australia's *1901 Immigration Restriction Act*, colloquially known as the "White Australia Policy" served to prohibit non-British immigration to Australia, thus enshrining racialized immigrants as dangerous to the newly formed Federation of Australia.<sup>8</sup>
- 14. I am not a lawyer, immigration advocate, or legal scholar of Australian immigration law. My interest in the "White Australia Policy" lies in the historical importance of Australia determining its initial immigration policy based on keeping out immigrants who look and act different than Australians of British decent. Attorney-General Alfread Deakin's 12 September 1901 statement "That end, put in plain and unequivocal terms ... means the prohibition of all alien coloured immigration, and more, it means at the earliest time, by reasonable and just means, the deportation or reduction of the number of aliens now in our midst" makes clear that Australia will not only not allow immigrants of color, but also Australia will begin deporting those immigrants of color already in Australia. Like most immigration laws globally, this law specified categories of immigrants to help determine who could and could not stay in Australia. And as Hage argues, even when an immigrant is deemed acceptable, those immigrants are supposed to feel lucky to have a spot in the nation state. And the specter of the dangerous immigrant and the consequences of that title, non-acceptance and/or deportation, are always looming.
- 15. And those consequences are seen in Senator Hanson's tweet in response to Senator Faruqi on September 9, 2022. Senator Hanson tweeted: "Your attitude appalls and disgusts me. When you immigrated to Australia you took every advantage of this country. You took citizenship, bought

multiple homes, and a job in a parliament. It's clear you're not happy, so pack your bags and piss off back to Pakistan."<sup>9</sup> Within this Tweet, Senator Hanson shifts Senator Faruqi's history from one of a lawful non-citizen who has been granted Australian citizenship to that of an unlawful citizen by not only telling her to "piss off back to Pakistan" but by pointing out how her comments on the death of Queen Elizabeth II make her an ungrateful immigrant, rather than an acceptable one. Senator Hanson's tweet implies that Senator Faruqi was "gifted" Australian citizenship, has enjoyed all the nation state has had to offer, but now Senator Faruqi is ungrateful and therefore should "go back to where she came from."<sup>10</sup>

- 16. Senator Hanson's tweet not only illustrates Hage's critiques of how immigrants are either acceptable or dangerous in Australian multiculturalism, but it also asserts the phrase "piss off back to Pakistan" which can work as a palimpsest that carries with it the historical meanings of "go back to where you came from." In fact, as stated above, we don't need to go too far back in history to see this phrase used against a young Muslim congressperson (see my discussion of President Trump above). It could be argued that Senator Hanson may not have knowledge of President Trump's statement, but I find that hard to believe in the age of media proliferation and social media. President Trump's tweets and public statements have circulated far past the US.
- 17. Additionally in viewing Senator Hanson's public statements over the past three decades, she is clearly invested in the idea of a "White Australia." As I will discuss, Senator Hanson has been vocal about the threat Asian and Muslim immigrants pose to Australia. And even if Senator Hanson claims that this particular tweet was not meant to invoke anti-immigrant sentiment, the fact that her tweet has circulated amongst far-right conservative media, Senator Faruqi received threats invoking her religious and racial identity, and Senator Hanson doubled down in a future tweet offering to drive Senator Faruqi to the airport shows that she understands the impact of her statement and is allowing it to stand perhaps because it aligns with her far-right conservative views.
- 18. Senator Hanson is quite public about her views. She has focused much of her career asserting the need to protect Australia from Southeast Asians and Muslims. After the London bombings in March 2017, Senator Hanson changed #PrayforLondon to #Pray4MuslimBan.<sup>11</sup> She received backlash, but she did not apologize or change the hashtag back.<sup>12</sup> Many in parliament on both sides of the aisle pointed out how her hashtag went against Australian multicultural values, but Hanson furthered her resolve in an interview with Australian news wherein she stated that "Islam is a disease that Australia must be vaccinated against."<sup>13</sup>
- 19. I want to include Senator Hanson's defense of this statement. She said: "[The issue] is about immigration. I am listening to the Australian people." Within a media cycle as parliament and the Prime Minister were sending messages of support and solidarity to their kinfolk in London, Senator Hanson focused on the perceived Islamic threat to western nations. By taking a firm stand in the wake of tragedy and tying her comments directly to immigration, it is my opinion that Senator Hanson used her platform to attempt to sway political debates surrounding immigration in Australia.
- 20. In her popular book *The Shock Doctrine: The Rise of Disaster Capitalism* (Picador 2008), US journalist Naomi Klein writes that in times of large-scale disaster or crisis, political parties attempt to change economic and social policies in the name of protection or rebuilding from said disaster. She discusses the almost unanimous passage of *The P.A.T.R.I.O.T. A.C.T* less than six weeks after 9/11 by

both the house and senate in the United States.<sup>14</sup> She then demonstrates how political parties jockeying for support will use global disasters to sway public opinion. <sup>15</sup> In my opinion, Senator Hanson's comments about Islam and #pray4MuslimBan was a way to use shocking events to sway public opinion on current immigration debates in Australia.

21. I am not claiming that Senator Hanson made these comments capriciously.

However, her comments signal a version of Australia that no longer and never did exist. Hage calls this "The White Nation Fantasy,"<sup>16</sup> and that fantasy relies on the myth that Australia was an uninhabited continent until British settlers discovered and founded it. This myth does not reconcile with the work Australia is now doing to acknowledge and support its Aboriginal First Nations people. Nor does it allow for immigrants to hold any other place than grateful recipients of the gift of citizenship within the social imaginary.

- 22. When these fantasies are invoked, it is done by isolating particular immigrant groups through rhetoric that shifts them from acceptable to dangerous. In *Branded Bodies*, I describe how Mexican immigrants became representative of all Latinx immigrants and US citizens of Latinx descent. The claim that Mexican immigrants were stealing US jobs and culture was central to the Republican Party platform for forty years. Instead of highlighting the worker programs the US put in place to assist farmers and large corporations, politicians and the media focused on the supposed criminal nature of Mexican immigrants. And because of this perceived threat to our culture and economy, the US saw several targeted laws which allowed policing of anybody that looked Mexican and therefore "illegal."<sup>17</sup> Many police and immigration law enforcement agents ended up attempting to detain US citizens because they "looked like illegals."<sup>18</sup> As such, many of these laws were struck down by appellate courts across the country because they impinged on the rights of citizens who were targeted because of their race, not their immigration status.
- 23. It is the embedded racism of the fantasy of the white nation that makes statements like "go back to where you came from" so dangerous for immigrants and citizens of color. Far-right conservatives often claim that they "don't see race" to use benevolent multicultural tropes to defend their (unexamined) racial biases. In fact, Senator Hanson has used the phrase "I don't care if you are black, white or brindle" several times in public fora and in interviews on Sky News.

Yet, her softened version is almost more offensive because she includes a type of animal coat coloring as a racial distinction. The collapsing of racial distinctions with animal traits has a long history in anthropology. As western countries began to explore and colonize foreign shores, there were texts written about Native people describing their traits in terms of animals known in the west, implying that these people were not fully human or were evolutionarily behind the humans in the west.<sup>19</sup>

- 24. Senator Hanson may not have meant to imply that racialized people are animals, but again, language is not neutral. When it comes to statements drawing parallels between racial categories and animals, there is a long history with which those who hear that statement can make a connection. Again, these phrases are palimpsestic and carry national and social histories even when those histories are not explicitly uttered.
- 25. "I don't care if you're black, white or brindle" and "It's okay to be white" which Senator Hanson as continued to repeat, are statements that work in similar ways to the now ubiquitous #alllivesmatter which was coined in response to the #blacklivesmatter

movement after the death of George Floyd in May 2020. #allivesmatter and the more defiant #bluelivesmatter (which is a pro-police hashtag) were phrases that served to usurp the popularity of #blacklivesmatter and undermine the reinvigorated civil rights movement taking place across the US. #allivesmatter is an attempt at softening and/or universalizing #whitelivesmatter which was deemed white supremacist hate speech by the Anti-Defamation League.<sup>20</sup> These two hashtags were circulated across social media, placed on bumper stickers, and reiterated across conservative media to reinforce myth that white men and white men in uniform were under attack. Far-right conservatives in the US used hashtags developed by white supremacist and neo-Nazi groups to suppress Black people from organizing against police violence.

- 26. But even in moderate circles, these statements #alllivesmatter, "It's okay to be white," and "I don't care if you are black, white, or brindle" attempt to minimize discussions of race. These phrases are *thought terminating clichés*.<sup>21</sup> "Thought-terminating clichés are seemingly harmless and commonly used words and phrases that act to limit or stop conversation, discussion, or questioning." The invocation of All Lives Matter in the light of systemic violence against Black bodies in the US is a move to end discussions of race in public. Senator Hanson's statements about race function in much the same way. Instead of engaging with issues of race in Australia, her use of "It's okay to be white," and "I don't care if you are black, white or brindle" allows her to discount and terminate those discussions without claiming that race doesn't matter. Instead, she can use these clichés to end the conversation because who would disagree that she doesn't care about a person's race? And who would argue that a particular racial identity is okay to identify with?
- 27. But these thought terminating clichés prevent systematic engagement with race and how marked bodies function within the nation-state. When these clichés are invoked, conversations about racialized violence, systemic poverty, and lack of opportunities provided for racialized citizens and immigrants are eclipsed. Instead, the focus is turned to claims about economics and/or personal responsibility. I have argued that personal responsibility is yet another concept that allows the farright to vilify immigrants and those who are deemed other within the nation state due to their race, class, sexuality, and/or religion.<sup>22</sup> Especially in times of economic insecurity or national crisis, the difference between who is acceptable and who is dangerous becomes blurry, and those differences which are lauded as making the nation-state great become a liability.
- 28. This shift is seen in Senator Hanson's tweet to Senator Faruqi. In it she discusses all of the assets (e.g. her citizenship, her homes, her seat in the Senate) which Australia bequeathed to Senator Faruqi. One can assume that because Senator Faruqi has lived in Australia for thirty years, gained citizenship, purchased property, and ran a winning campaign for Senate, she is an acceptable immigrant. But in one tweet, Senator Hanson redefines Senator Faruqi as ungrateful, dangerous, and an immigrant who needs to "piss off and go back to Pakistan."
- 29. Though I found no evidence of Senator Hanson publicly recognizing Senator Faruqi as Muslim, she has publicly made derogatory statements about Muslim immigrants throughout her political career (some cited earlier in this opinion).

And she has maintained her anti-Islam position over the course of her political career. She has also been photographed and retweeted by Mr. Elijah Schaffer, a public figure who recently migrated to Australia from the United States. Mr. Schaffer is a well-known far right conservative blogger and reporter. Mr. Schaffer and Senator Hanson have exchanged tweets

and likes on far-right conservative topics including immigration. And shortly after news broke of Senator Faruqi's lawsuit, Mr. Schaffer reposted a photo with Senator Hanson with the text "plotting."

- 30. The company Senator Hanson keeps may not seem like something of which is worthy to remark. However, Senator Hanson has been interviewed on similar right leaning podcasts and radio shows, and her public record on anti-Islam and anti-immigration sentiment runs parallel to many of Mr. Schaffer's public statements, interview topics, and social media posts. And even if the tweeting, liking, and retweeting are political posturing by Senator Hanson, her repeated comments, statements, and posts on her own social media accounts align with Mr. Hanson's far-right conservative views. The exchange of likes and retweeting amplifies one another's platforms and serves to link far-right conservative messaging in the US and Australia.
- 31. And this linking of far-right conservative movements through social media circulation, interviews, public statements, and photographs works to support Senator Hanson's position as a far-right conservative voice in Australia. Furthermore, her support of Mr. Schaffer's public postings creates a link between his opinions and Senator Hanson. I have not seen evidence of Senator Hanson retweeting or liking any of Mr. Schaffer's neo-Nazi or expressly white supremist guests. The fact that Senator Hanson has made a point to like the public statements of Mr. Schaffer could link her to these individuals by proxy.
- 32. In conclusion, after reviewing Senator Hanson's public record, media interviews, **Security** and social media activity, I see no other way to read her tweet in response to Senator Faruqi as an attempt by Senator Hanson to redefine Senator Faruqi as a dangerous, Muslim, immigrant. The fact that she was sure to include Senator Faruqi's former country while articulating the accomplishments of her thirty years in Australia implies that Senator Faruqi is not a *real* Australian even though she is a citizen who owns property and is a sitting senator. Although Senator Hanson has not ever invoked the phrase "white nation" in reference to Australia, her anti-Islam and anti-immigrant rhetoric over the course of her career and her fellowship with other far-right conservative public figures allows me to read the tweet she sent to Senator Faruqi as discriminatory based on Senator Faruqi's identity as an immigrant and Muslim.

## *Faruqi v Hanson* – Federal Court of Australia proceedings no. NSD 372 of 2023 Letter of instruction for preparation of expert evidence

- 1. We act for Australian Senator, Mehreen Faruqi, in relation to the above Federal Court of Australia proceedings which allege a breach of section 18C of the *Racial Discrimination Act* 1975 (Cth).
- 2. The proceedings have been set down for hearing between 29 April 2024 to 3 May 2024.
- 3. Thank you for agreeing to act as an independent expert in the proceedings. We confirm that Senator Faruqi's expert evidence is due to be filed and served on 30 September 2023.

## Background to the proceedings

- The proceedings were commenced by Senator Faruqi against another Australian Senator, Pauline Hanson, on 3 May 2023. The proceedings were commenced under the <u>Racial</u> <u>Discrimination Act 1975 (Cth)</u> (Act).
- 5. The proceedings relate to the below Tweet which was published by Senator Hanson to her public-facing Twitter account @PaulineHansonOz on 9 September last year, and which directed Senator Faruqi to "pack [her] bags and piss off back to Pakistan" (<u>Hanson Tweet</u>). Senator Faruqi immigrated to Australia from Lahore, Pakistan in 1992.

Faruqi motion to Australian Senate in response to the Hanson Tweet<sup>1</sup>

- 6. On 27 September 2022, in response to the Hanson Tweet, Senator Faruqi moved the Australian Senate to, amongst other things, censure Senator Hanson for "*her divisive, anti-migrant, and racist statement telling Senator Faruqi to 'piss off back to Pakistan', which does not reflect the opinions of the Australian Senate or the Australian people*" (Faruqi Motion).<sup>2</sup>
- 7. In response to the Faruqi Motion, Senator Hanson denied that the Hanson Tweet was racist, instead referring to it as "*criticism*".<sup>3</sup> Senator Hanson also confirmed to the Australian Senate that she refused to retract the Hanson Tweet and stated that Senator Faruqi "*can go and do what I've said. I make the offer, also, to take her to the airport.*"<sup>4</sup>
- 8. Australian Senators Wong and Birmingham moved the Australian Senate to amend the Faruqi Motion to (amongst other things) remove the proposed censure of Senator Hanson, replacing it with a general call on Senators to "engage in debates and commentary respectfully, and to refrain from inflammatory and divisive comments, both inside and outside the [Senate] chamber at all times.<sup>5</sup> The amended version of the Faruqi Motion was agreed to by the Australian Senate.<sup>6</sup>

### Faruqi complaint to the Australian Human Rights Commission

- On 27 September 2022, Senator Faruqi made a complaint to the Australian Human Rights Commission (AHRC) in an attempt to engage Senator Hanson in a conciliation process for the purpose of resolving matters relating to the Hanson Tweet.<sup>7</sup>
- 10. Senator Hanson declined to participate in the AHRC conciliation process.
- 11. As a result of Senator Hanson's lack of engagement in the AHRC conciliation process, Senator Faruqi's complaint to the AHRC was terminated on 8 March 2023 pursuant to section 46PH(1B)(b) of the Australian Human Rights Commission Act 1986 (Cth) (AHRC Act) on the basis that the delegate of the President of the AHRC was satisfied that there was no reasonable prospect of the matter being settled by conciliation.

### Court proceedings

- 12. On 3 May 2023, Senator Faruqi commenced proceedings no. NSD 372 of 2023 in the Federal Court of Australia. It is a requirement under section 46PO of the AHRC Act that the AHRC process be concluded prior to proceedings being commenced in relation to alleged breaches of the Act.
- At paragraph [3] of the Originating Application filed by Senator Faruqi on 3 May 2023 (Schedule C, document no. 2), Senator Faruqi alleges that the Hanson Tweet is unlawful under section 18C of the Act on the basis that:
  - the publication of the Hanson Tweet was reasonably likely in all the circumstances to, and did, offend, insult humiliate or intimidate Senator Faruqi, and other people that share Senator Faruqi's attributes; and
  - (b) the publication of the Hanson Tweet was done because of race, colour or national or ethnic origin of Senator Faruqi, and other people that share Senator Faruqi's attributes.<sup>8</sup>
- 14. Part of Senator Faruqi's position in the proceedings is that the words used in the Hanson Tweet are a variation of the phrase "go back to where you came from".<sup>9</sup>
- 15. At paragraph [6] of Senator Hanson's Concise Response dated 27 June 2023 (Schedule C, document no. 4), Senator Hanson denies that the publication of the Hanson Tweet contravenes section 18C of the Act. Senator Hanson relies on, amongst other things, a defence under

section 18D of the Act in this regard.<sup>10</sup> We have set out this provision in full at Schedule A to this letter of instruction.

- 16. At paragraph [39] of Senator Hanson's Concise Response dated 27 June 2023, Senator Hanson alleges an alternative defence that sections 18C and 18D of the Act are invalid on the basis that they infringe the implied freedom of political communication which has been held by the High Court of Australia to exist in the Australian Constitution. Broadly, and by way of background, the implied freedom of political communication is a protection which restricts Australia's laws from interfering with free communication about government and political matters, where those laws do not serve a legitimate end.
- 17. Following the publication of the Hanson Tweet, Senator Faruqi received abusive phone calls, emails and direct messages on social media and was also the subject of abusive social media posts. Examples of these communications have been included at Schedule C, Annexure A of this letter of instruction.

#### **Background on Senator Hanson**

- Senator Hanson was elected as a Member of Parliament in 1996, and continued in this position until 1998. Senator Hanson presently sits as an Australian Senator following her successful election to the Senate in 2016 and re-election in 2022.
- 19. Over the course of her career, Senator Hanson has been the subject of extensive media coverage, including regular appearances on Australian television and news media programs. She has also been involved in and/or has been accredited with the publishing of three books including an autobiography and a collection of parliamentary speeches.
- 20. Since 1996, Senator Hanson has had a significant public platform. As at today's date:
  - (a) Senator Hanson's official Twitter profile, @paulinehansonoz, has over 104,400 followers on Twitter;<sup>11</sup>
  - (b) Senator Hanson's public Facebook page entitled 'Pauline Hanson's Please Explain' has over 479,000 followers;<sup>12</sup> and
  - (c) Senator Hanson's Instagram profile @senatorpaulinehanson has over 63,800 followers.<sup>13</sup>

- 21. Senator Hanson has used her public platform to communicate controversial opinions. Examples of the types of rhetoric Senator Hanson has deployed publicly are as follows.
  - (a) "It is ok to be white," which is a statement that Senator Hanson initially presented as a part of a Motion to the Australian Senate in 2017, and which she has publicly repeated outside of Parliament on numerous occasions including a press conference<sup>14</sup> and in a television interview on the Sky News program entitled Paul Murray Live.<sup>15</sup>
  - (b) Variations of the phrase "*I don't care if you are black, white or brindle*," which she stated in public fora on several occasions including in a television interview on the Sky News program entitled Paul Murray Live .<sup>16</sup>
  - (c) She has said "Islam is a disease and we need to vaccinate ourselves against that"<sup>17</sup> and variations of that notion on several occasions, most notably in response to the 2017 London Terror Attacks;
  - (d) She has promoted the hashtag "#Pray4MuslimBan," purportedly in solidarity with victims of the London Terror Attacks. She proposed this hashtag be used instead of #Pray4London, saying "People are feeling sorry for these people over there and I've seen the hash tags 'pray for London'. Look I have my own hash tag and you won't need to be praying for this place, or that place. Put a ban on it and then let's deal with the issues here."<sup>18</sup>

- (ii) in what contexts has the phrase "go back to where you came from" been used in history?
- (iii) what, if anything, is the social and/or cultural significance of the phrase "go back to where you came from"?
- (iv) what, if anything, does the phrase "go back to where you came from" signal, both to white supremacists/racists and/or targeted minorities? Does it have a coded meaning?
- (v) what, if anything, does the phrase "Islam is a disease and we need to vaccinate ourselves against that" signal, both to white supremacists/racists and/or targeted minorities? Does it have a coded meaning?
- (vi) what, if anything, does the phrase / hashtag "#Pray4MuslimBan"? signal, both to white supremacists/racists and/or targeted minorities? Does it have a coded meaning?
- (vii) was Senator Hanson's direction in the Hanson Tweet for Senator Faruqi to "pack [her] bags and piss off back to Pakistan" a variation of the phrase "go back to where you came from?"
- (viii) what is your understanding of the empirical, historical roots of the phrases referred to at paragraph 21 above ("it's ok to be white" and "black, white or brindle")? How and by whom have these phrases been used in history?
- (ix) what if any legitimate political comment might be intended by the Tweet? Is there an available interpretation that would not qualify as racist or discriminatory speech?
- 23. We request that you set out your opinion in relation to the above in a written report with numbered paragraphs.
- 24. Your expert report must include the following.
  - (a) your name and address;
  - (b) your training, study and experience and also attach a detailed curriculum vitae to the report;
  - the facts, and assumptions of facts, on which the opinions in the report are based (a copy of this letter should be annexed to your expert report);
  - (d) your reasons for each opinion expressed;
  - (e) if applicable, that a particular issue falls outside your field of expertise;
  - (f) any literature or other materials used in support of your opinions, and the reasons for using this literature or other materials; and

- (g) any examinations, tests or other investigations on which you have relied, including details of the qualifications of the person who carried them out;
- (h) the extent to which any opinion which you express involves the acceptance of another person's opinion, the identification of that other person and the opinion expressed by that other person;
- a declaration that you have made all the inquiries which you believe are desirable and appropriate, and that no matters of significance which you regard as relevant have, to your knowledge, been withheld from the court.
- (j) any qualifications on an opinion expressed in the report without which the report is or may be incomplete or inaccurate;
- (k) whether any opinion expressed in the report is not a concluded opinion because of insufficient research or insufficient data or for any other reason; and
- (I) where the report is lengthy or complex, a brief summary of the report at the beginning of the report.
- 25. If, when preparing your report you require additional factual information to express an opinion in respect of the question, please also make this clear in the body of your report.
- 26. If this matter proceeds to trial, you may be required to attend Court and give evidence. If you are required to attend Court, we will contact you to discuss your availability and make the necessary arrangements.

### Schedule A Extracts from Racial Discrimination Act 1975 (Cth)

### 1. Section 18C Offensive behaviour because of race, colour or national or ethnic origin

- (1) It is unlawful for a person to do an act, otherwise than in private, if:
- (a) the act is reasonably likely, in all the circumstances, to offend, insult, humiliate or intimidate another person or a group of people; and
- (b) the act is done because of the race, colour or national or ethnic origin of the other person or of some or all of the people in the group.

Note: Subsection (1) makes certain acts unlawful. Section 46P of the Australian Human Rights Commission Act 1986 allows people to make complaints to the Australian Human Rights Commission about unlawful acts. However, an unlawful act is not necessarily a criminal offence. Section 26 says that this Act does not make it an offence to do an act that is unlawful because of this Part, unless Part IV expressly says that the act is an offence.

- (2) For the purposes of subsection (1), an act is taken not to be done in private if it:
- (a) causes words, sounds, images or writing to be communicated to the public; or
- (b) is done in a public place; or
- (c) is done in the sight or hearing of people who are in a public place.

(3) In this section: **public place** includes any place to which the public have access as of right or by invitation, whether express or implied and whether or not a charge is made for admission to the place.

## 2. Section 18D Exemptions

Section 18C does not render unlawful anything said or done reasonably and in good faith:

- (a) in the performance, exhibition or distribution of an artistic work; or
- (b) in the course of any statement, publication, discussion or debate made or held for any genuine academic, artistic or scientific purpose or any other genuine purpose in the public interest; or
- (c) *in making or publishing:* 
  - (i) a fair and accurate report of any event or matter of public interest; or
  - (ii) a fair comment on any event or matter of public interest if the comment is an expression of a genuine belief held by the person making the comment.







#### Schedule B Harmonised Expert Witness Code of Conduct

### 1. APPLICATION OF CODE

- 1.1 This Code of Conduct applies to any expert witness engaged or appointed:
  - (a) to provide an expert's report for use as evidence in proceedings or proposed proceedings; or
  - (b) to give opinion evidence in proceedings or proposed proceedings.

### 2. GENERAL DUTIES TO THE COURT

2.1 An expert witness is not an advocate for a party and has a paramount duty, overriding any duty to the party to the proceedings or other person retaining the expert witness, to assist the Court impartially on matters relevant to the area of expertise of the witness.

### 3. CONTENT OF REPORT

- 3.1 Every report prepared by an expert witness for use in Court shall clearly state the opinion or opinions of the expert and shall state, specify or provide:
  - (a) the name and address of the expert;
  - (b) an acknowledgment that the expert has read this code and agrees to be bound by it;
  - (c) the qualifications of the expert to prepare the report;
  - (d) the assumptions and material facts on which each opinion expressed in the report is based [a letter of instructions may be annexed];
  - (e) the reasons for and any literature or other materials utilised in support of such opinion;
  - (f) (if applicable) that a particular question, issue or matter falls outside the expert's field of expertise;
  - (g) any examinations, tests or other investigations on which the expert has relied, identifying the person who carried them out and that person's qualifications;
  - (h) the extent to which any opinion which the expert has expressed involves the acceptance of another person's opinion, the identification of that other person and the opinion expressed by that other person;
  - a declaration that the expert has made all the inquiries which the expert believes are desirable and appropriate (save for any matters identified explicitly in the report), and that no matters of significance which the expert regards as relevant have, to the knowledge of the expert, been withheld from the Court;







- (j) any qualifications on an opinion expressed in the report without which the report is or may be incomplete or inaccurate;
- (k) whether any opinion expressed in the report is not a concluded opinion because of insufficient research or insufficient data or for any other reason; and
- (I) where the report is lengthy or complex, a brief summary of the report at the beginning of the report.

## 4. SUPPLEMENTARY REPORT FOLLOWING CHANGE OF OPINION

- 4.1 Where an expert witness has provided to a party (or that party's legal representative) a report for use in Court, and the expert thereafter changes his or her opinion on a material matter, the expert shall forthwith provide to the party (or that party's legal representative) a supplementary report which shall state, specify or provide the information referred to in paragraphs (a), (d), (e), (g), (h), (i), (j), (k) and (l) of clause 3 of this code and, if applicable, paragraph (f) of that clause.
- 4.2 In any subsequent report (whether prepared in accordance with clause 4 or not) the expert may refer to material contained in the earlier report without repeating it.

#### 5. DUTY TO COMPLY WITH THE COURT'S DIRECTIONS

- 5.1 If directed to do so by the Court, an expert witness shall:
  - (a) confer with any other expert witness;
  - (b) provide the Court with a joint-report specifying (as the case requires) matters agreed and matters not agreed and the reasons for the experts not agreeing; and
  - (c) abide in a timely way by any direction of the Court.

#### 6. CONFERENCE OF EXPERTS

- 6.1 Each expert witness shall:
  - (a) exercise his or her independent judgment in relation to every conference in which the expert participates pursuant to a direction of the Court and in relation to each report thereafter provided, and shall not act on any instruction or request to withhold or avoid agreement; and
  - (b) endeavour to reach agreement with the other expert witness (or witnesses) on any issue in dispute between them, or failing agreement, endeavour to identify and clarify the basis of disagreement on the issues which are in dispute.

# *Faruqi v Hanson* – Federal Court of Australia proceedings no. NSD 372 of 2023 Supplementary letter of instruction for preparation of expert evidence

- 1. We refer to our letter of instruction dated 11 August 2023.
- 2. The purpose of this letter is to provide you with further background information regarding Senator Hanson's recent dealings in Australia. If you consider this information relevant, the information contained in this letter may be used for the purposes of informing any opinions expressed in your report.

## Senator Hanson's recent dealings with Mr Elijah Schaffer

- 3. On or about 20 August 2023, Senator Hanson was photographed with Mr Elijah Schaffer attending the Conservative Political Action Conference event in Australia (CPAC Australia).<sup>1</sup> Further background in relation to Mr Schaffer is set out at paragraphs 7 to 10 below.
- 4. The photograph of Senator Hanson and Mr Schaffer was subsequently posted by Mr Schaffer to his public Twitter account '@ElijahSchaffer' at 1:18pm on 20 August 2023 with the caption "Australia will rise again @CPACAustralia" (Schaffer Tweet). The Schaffer Tweet can be accessed via the following link;<u>https://twitter.com/ElijahSchaffer/status/169310027776590672</u> 2.<sup>2</sup>.

- 5. At 1:22pm on 20 August 2023, Mr Schaffer responded to the Schaffer Tweet with a comment which stated "*Plotting*". We interpreted this as meaning that he and Senator Hanson may have engaged in further discussions following the photograph being taken.<sup>3</sup> As at today's date, this comment remains published on Mr Schaffer's Twitter account. It has attracted 74 likes.
- To date, the Schaffer Tweet has attracted approximately 76,200 views, according to Twitter's view counter; 841 likes; and 154 comments. The Schaffer Tweet remains published on Mr Schaffer's Twitter account.

### Background on Mr Elijah Schaffer

- 7. Mr Elijah Schaffer is a public figure who recently migrated to Australia from the United States. He primarily works as a podcaster and reporter, and has a moderately sized public profile.<sup>4</sup>
- Mr Schaffer's public Twitter account can be accessed via the following link: <u>https://twitter.com/ElijahSchaffer</u>. As at today's date, Mr Schaffer has garnered approximately 634,600 followers on this account.
- 9. Mr Schaffer in part uses his public profile to advance his far-right conservative views. In doing so, he regularly deploys and/or endorses controversial rhetoric which is associated with, or can be linked to, white nationalist and white supremacist ideologies. Examples of the types of rhetoric deployed by Mr Schaffer are as follows.
  - (a) Variations of the phrase "rise again,"<sup>5</sup> which he has deployed in various posts on his Twitter account, including in the Schaffer Tweet and in posts dated 23 July 2021<sup>6</sup> and 20 August 2021.<sup>7</sup>
  - (b) Mr Schaffer posted a picture to his Twitter account on 12 August 2023 which included a picture of participants in the 'Unite the Right' rally held in Charlottesville in 2017 carrying torches. Mr Schaffer captained this post with the words "*Villains or heroes?*".<sup>8</sup>

- (c) Mr Schaffer appeared in an interview on the show "Andrew Says," hosted by Rebel News, which was entitled "How to Sell Your Soul w/ Elijah Schaffer & Sydney Watson" on 13 September 2021. In that interview, Mr Schaffer stated the following: ""The people who continue to defend Islam by saying 'well I know a good Muslim' ok I have too but when you look at the amount of people who are sympathetic in Islam to ISIS ... there are more UK Muslims fighting for Islam overseas than fighting for their own government. ... In military strength it looks like diversity was your weakness and didn't have a net positive that's why I'm not a fan of Islam. There's more of them overseas fighting against western values and that's not racist to say. That shows you what the ideology breeds which are enemies of western civilisation and freedom and the threats have been well documented. So destabilising the situation and bringing these people over to our countries is just absolutely ridiculously stupid. They don't want to be westerners, they don't want to blend in ... this is a disaster and they're using this to fundamentally change and transform western countries."<sup>9</sup>
- 10. Further, Mr Schaffer has recently been criticised for associating with, and using his platform to promote, individuals who identify as neo-Nazis, extremists and/or white supremacists. For example, on 4 August 2023, Mr Schaffer hosted Mr Joel Davis, a known neo-Nazi, on his podcast entitled '*Nightly Offensive*' in which Mr Davis (amongst other things) shared antisemitic conspiracy theories and spoke out about interracial marriage.<sup>10</sup>
