

## 6<sup>TH</sup> INITIATIVE EXECUTIVE COMMITTEE MEETING - RESOLUTIONS

Koror, Palau

**3 April, 2019**

The IEC resolved the following matters during the Sixth PJSI Initiative Executive Committee Meeting held in Koror, Palau on 3 April, 2019.

### **Resolution 1:**

The IEC **noted** and **approved** the PJSI Team's Progress Report and acknowledged the progress made under the PJSI to-date (attached in the **Annex One**).

### **Resolution 2:**

The IEC **noted** and **endorsed** *Chief Justices' Recommendations* (attached in the **Annex Two**). The meeting endorsed all Chief Justices' recommendations.

### **Resolution 3:**

The IEC **noted** and **approved** the *2-year Extension Plan* as presented to the Meeting, including the proposed additional activities made as part of the Chief Justices' recommendations. The Meeting acknowledged that some reallocations (within the available budget) will need to be made to allow for all proposed activities to be undertaken.

### **Resolution 4:**

The IEC **noted** the value of the sub-regional discussions between Chief Justices immediately preceding the IEC Meeting, and proposed to institutionalise this as part of the wrap-up of each Chief Justices' Leadership Forum in future.

### **Resolution 5:**

The IEC **noted** and **approved** the PJSI Team's Budget Report and the Indicative PJSI Phase 2 Budget.

### **Resolution 6:**

The IEC **approved** the publication of PJSI materials developed, on the website.

### **Resolution 7:**

The IEC **confirmed** that the next *IEC Meeting* will be a remote meeting held on 29 August, 2019 at Nuku'alofa-time 3pm; Wellington and Majuro-time 2pm; Honiara-time 1pm; Sydney and Brisbane-time 12pm; and Rarotonga on Wednesday 28 August at 4pm.

The following *Chief Justices' Leadership Forum* will be held between 27-29 April, 2020; and *IEC Meeting* will be held on 30 April, 2020. The location for both meetings will be held in Honiara, Solomon Islands.

**Resolution 8:**

The IEC **noted** that there is a need to include remote consultations with lay judicial and court officers using the webinar allocations in the budget prior to the next Chief Justices' Leadership Forum.

## Annex Two: Chief Justices' Recommendations

### Fourth Chief Justices' Leadership Forum Recommendations

Koror, Palau- 1-3 April, 2019

We, the Chief Justices and Chief Justices' Representatives of the Pacific Judicial Strengthening Initiative (PJSI) - in the absence of Tuvalu - comprising 13 Pacific Island Countries (PICs) being Federated States of Micronesia, Fiji, Kiribati, Nauru, Niue, Palau, Papua New Guinea, Republic of Marshall Islands, Samoa, Solomon Islands, Tonga, and Vanuatu - have convened at the Chief Justices' Leadership Forum held in Koror, Palau (1-3 April, 2018), make the following recommendations for the consideration of the Initiative Executive Committee (IEC) of the PJSI.

The Forum:

1. **Noted** the importance of PaCLII as a critical resource to courts in the Pacific, and requested a summary document explaining models that other Legal Information Institutes ('LII') have developed to ensure sustainable provision of services. Additionally, PaCLII will be requested to provide a breakdown (if possible) of jurisdiction-specific usage data.
2. **Noted** the UNODC *Draft Guidelines on the Use of Social Media by Judges*. The Forum further **noted** that each court will need to decide how best to use these guidelines within their respective jurisdiction, and may include these guidelines in judicial ethics training.
3. **Noted** the Mid-term Review and recommendations presented to the meeting. The Forum further **endorsed** the PJSI-Team's collegial approach to implementing PJSI, and the PJSI Team's responses to the recommendations made, as attached in the **Appendix**.
4. **Noted** and **endorsed** the *PJSI Progress Update* presented to the Forum.
5. **Noted** and **endorsed** the draft *Final Court Performance Trend Report* presented to the Forum.
6. **Noted** and **endorsed** the *Information and Communications Technology* update presented to the Forum.
7. **Noted** and **endorsed** the *Monitoring and Evaluation* update presented to the Forum.
8. **Noted** and **endorsed** the proposed *2-year Extension Plan*, activities, and related draft schedule, subject to necessary refinements to allow for effective implementation and the finalisation of contracting with MFAT. Specifically the Forum endorsed the:
  - Distribution of support and balance between regional, local, and remote support.
  - New activities focussing on: scoping the actions needed to progress towards achievement of Sustainable Development Goal (SDG) targets in the region; assessment/review of the regulatory capacity of bar associations to promote the competence, ethics and discipline of the legal profession; legal aid situation and needs analysis; and scoping options for PJSI to promote access to justice for citizens particularly in remote communities by building awareness and understanding of the respective roles and relationships of custom and law, including the role, functions and

jurisdiction of Courts. Chief Justices requested that PJSI explore options to include concepts for wellness and mindfulness.

- Draft schedule of activities (subject to some refinement of dates), as attached.

9. **Noted** concerns with the representative nature of existing programmatic governance structures, and requested that such structures are reviewed as part of a future programme design. Chief Justices committed to having an informal sub-regional meeting after the CJLF and include remote consultations with lay judicial and court officers using the webinar allocations in the budget.
