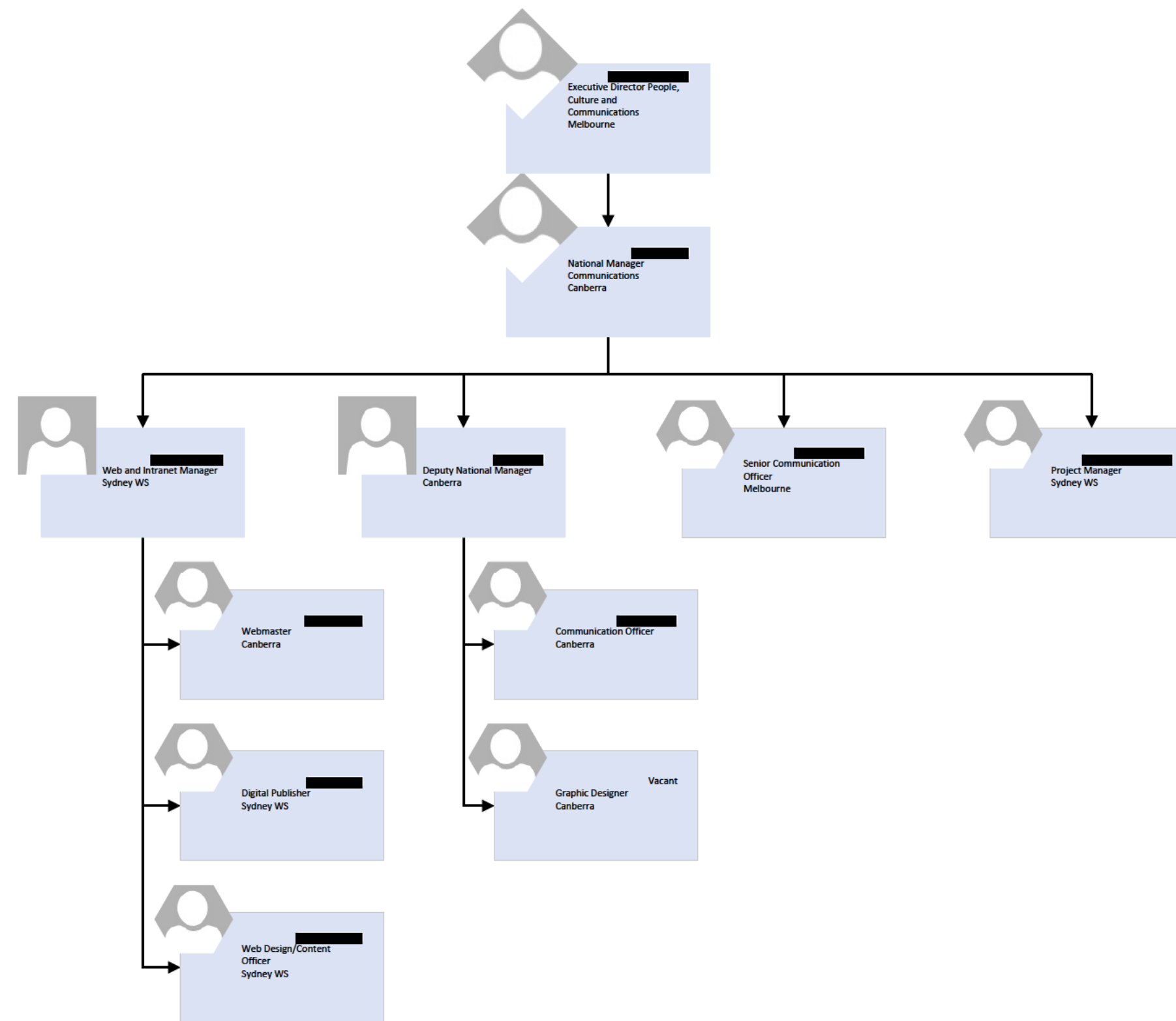

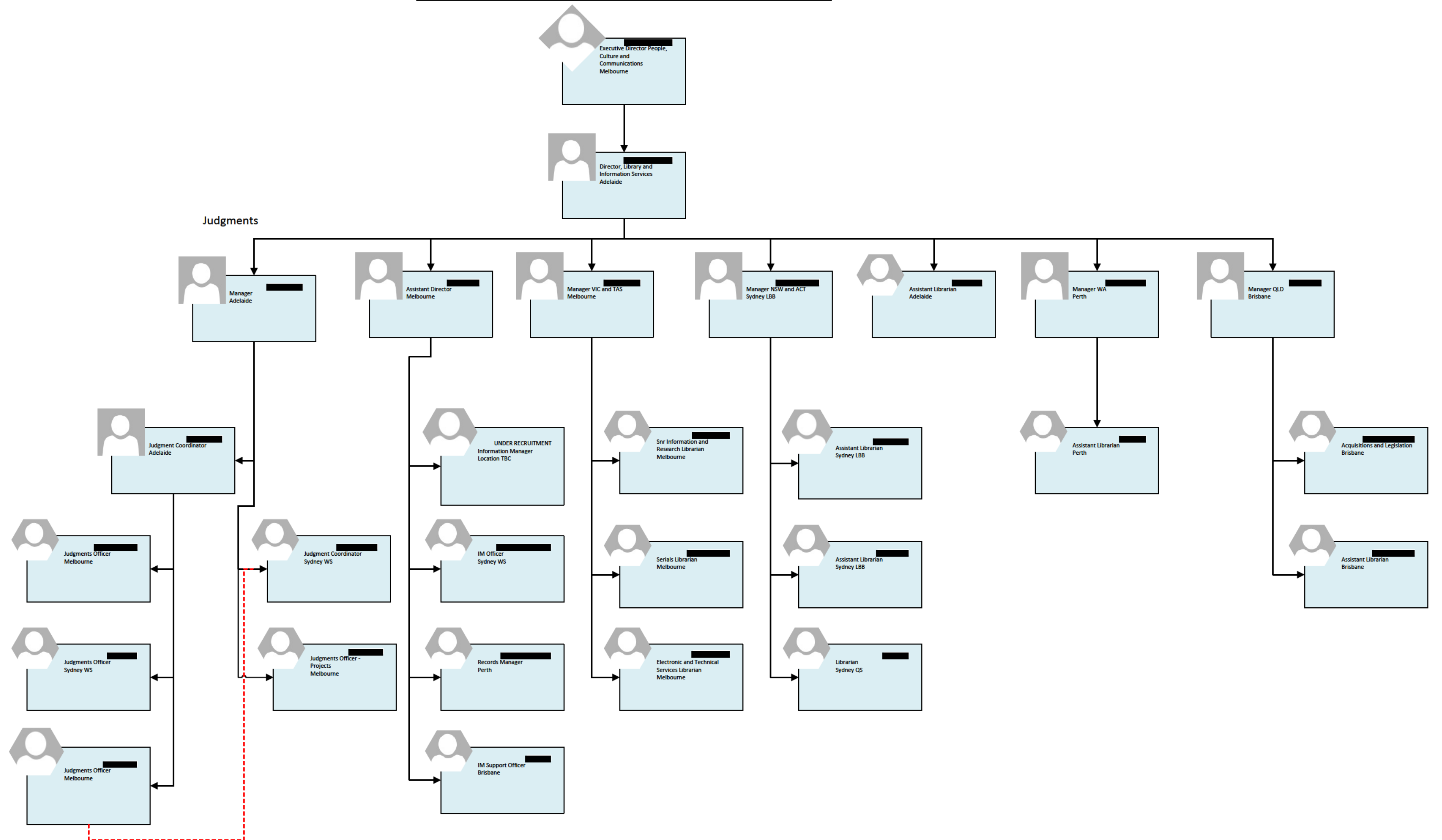

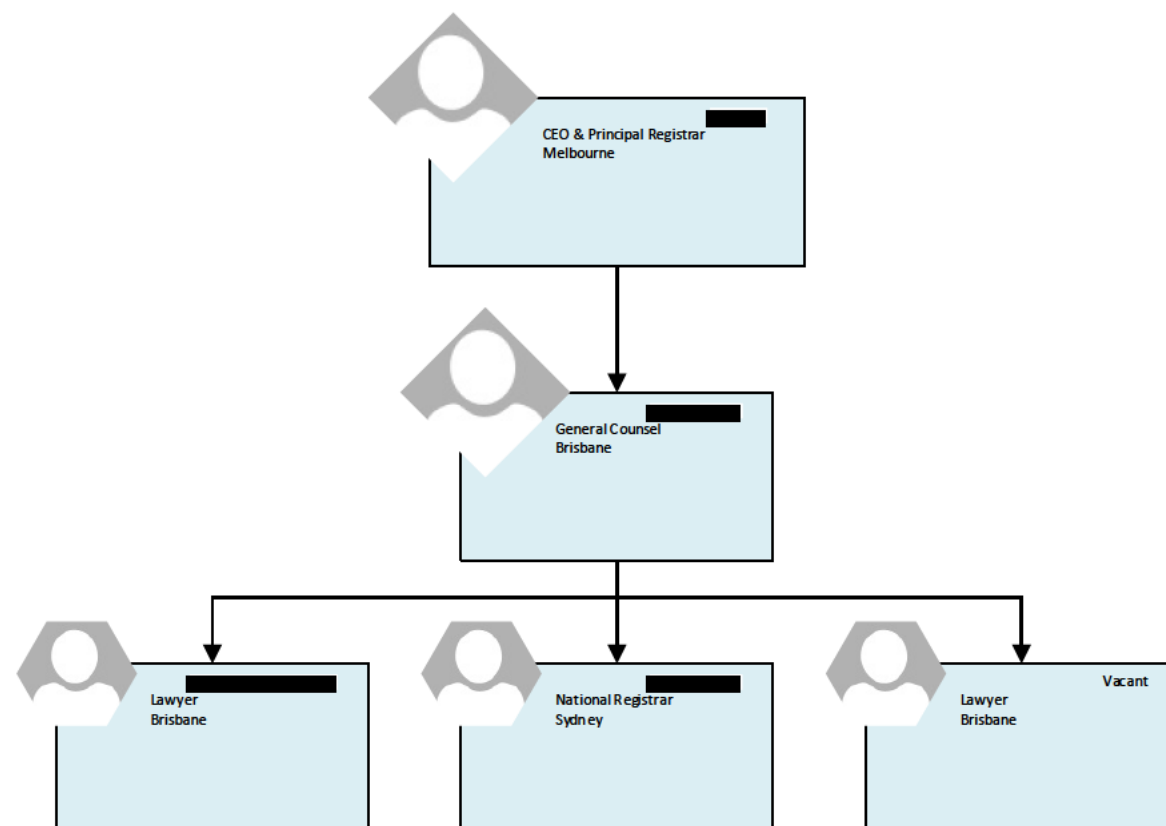


INFORMATION SERVICES ORGANISATIONAL CHART

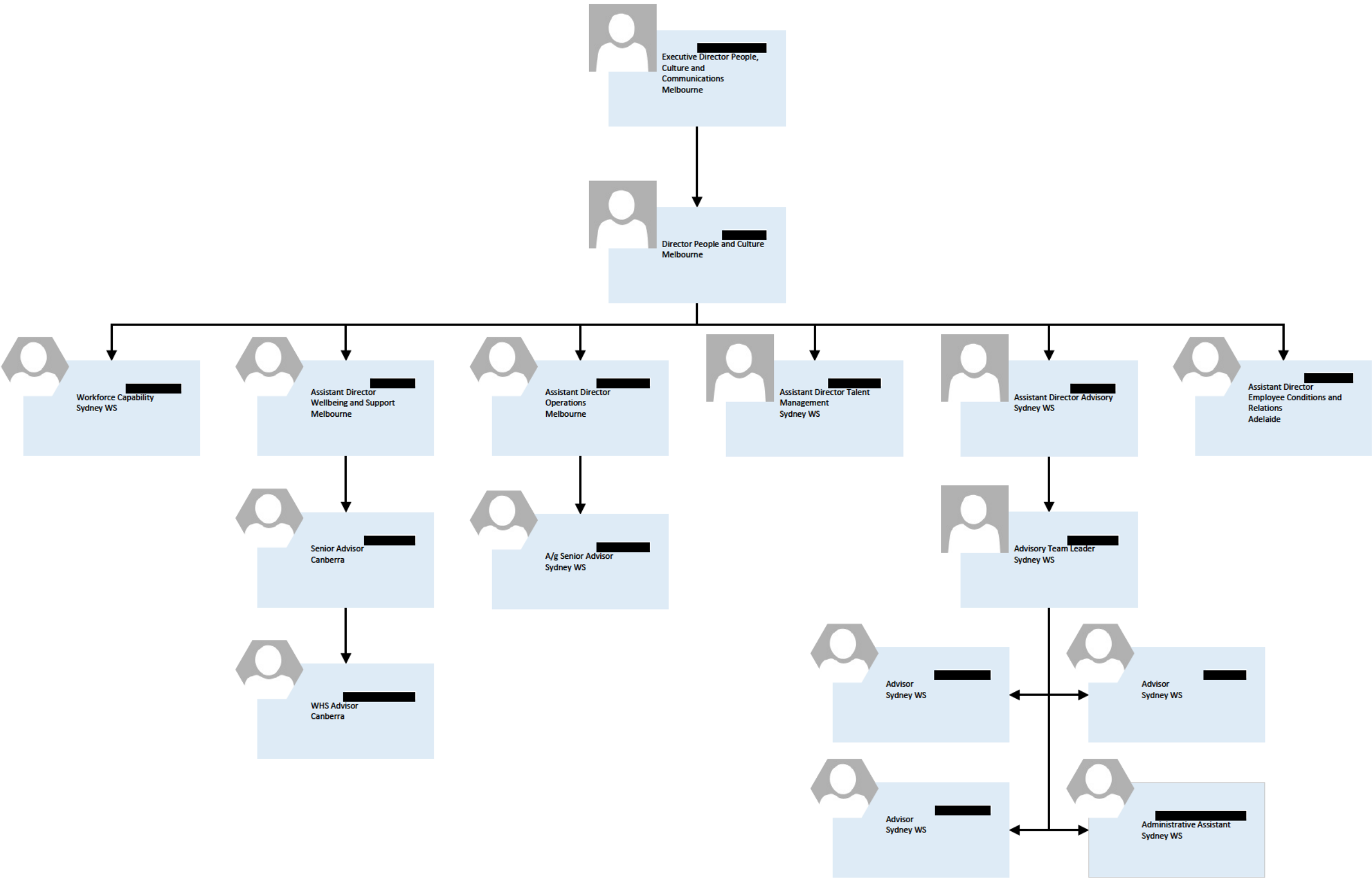

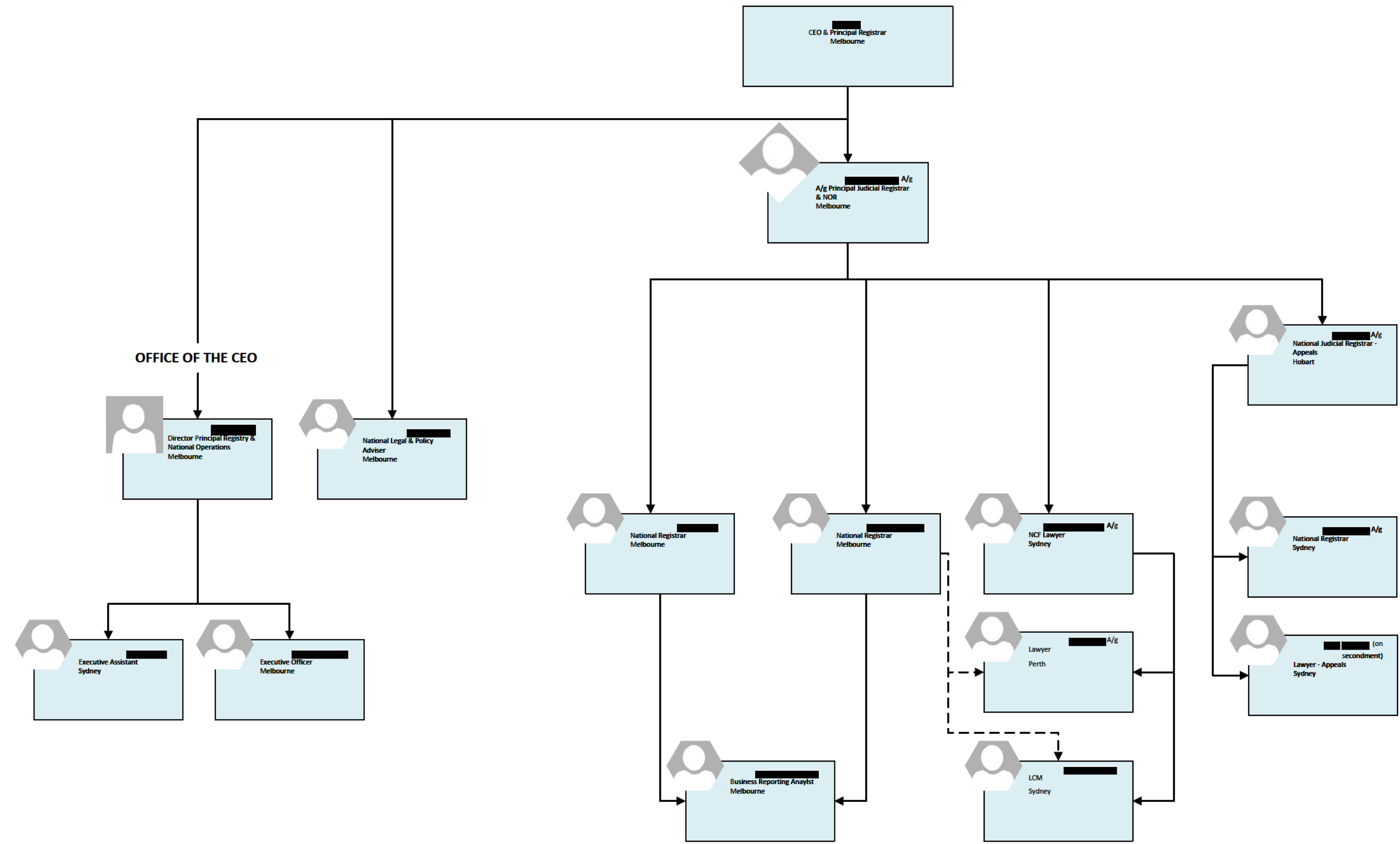


PEOPLE AND CULTURE ORGANISATIONAL CHART

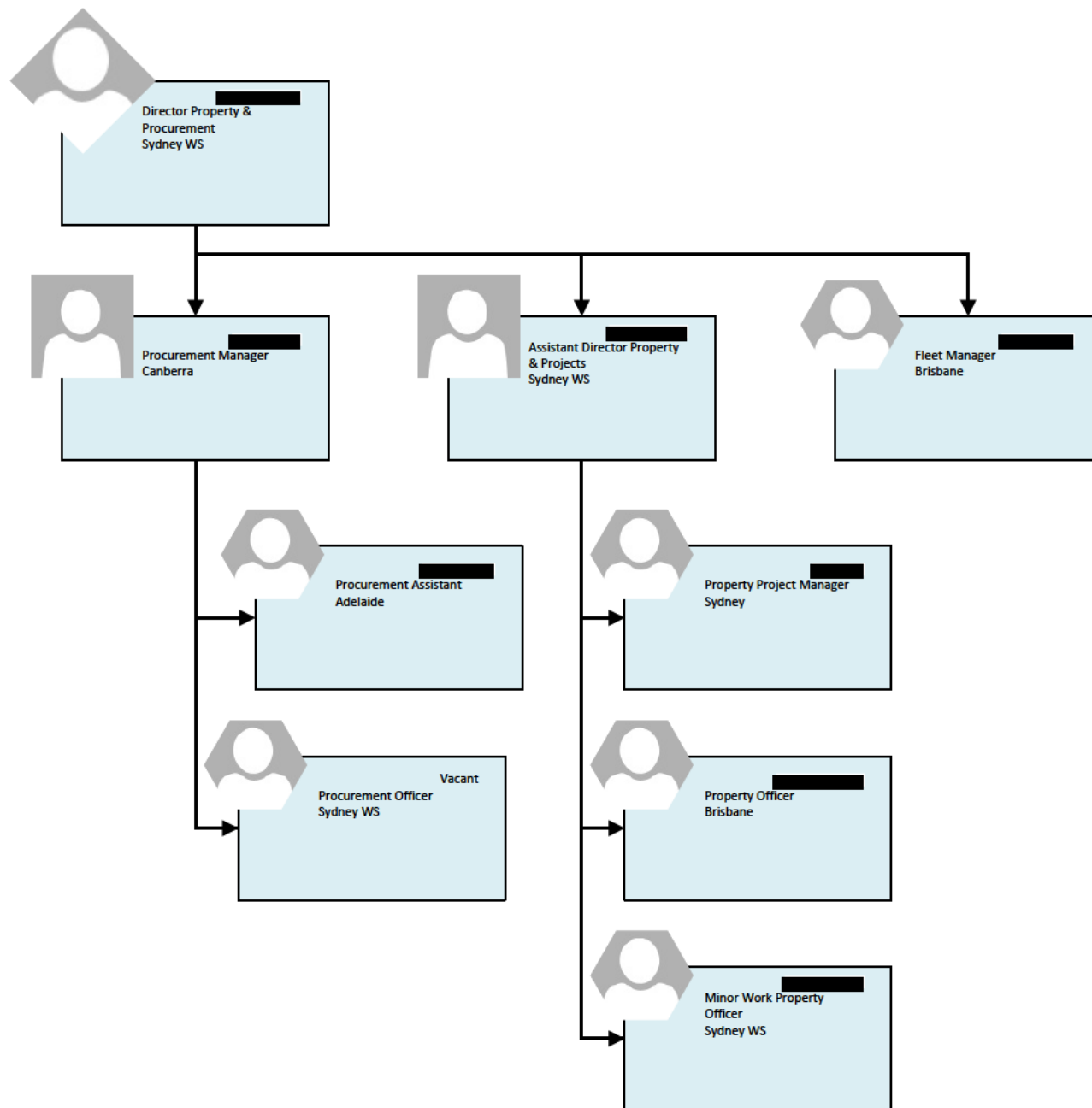

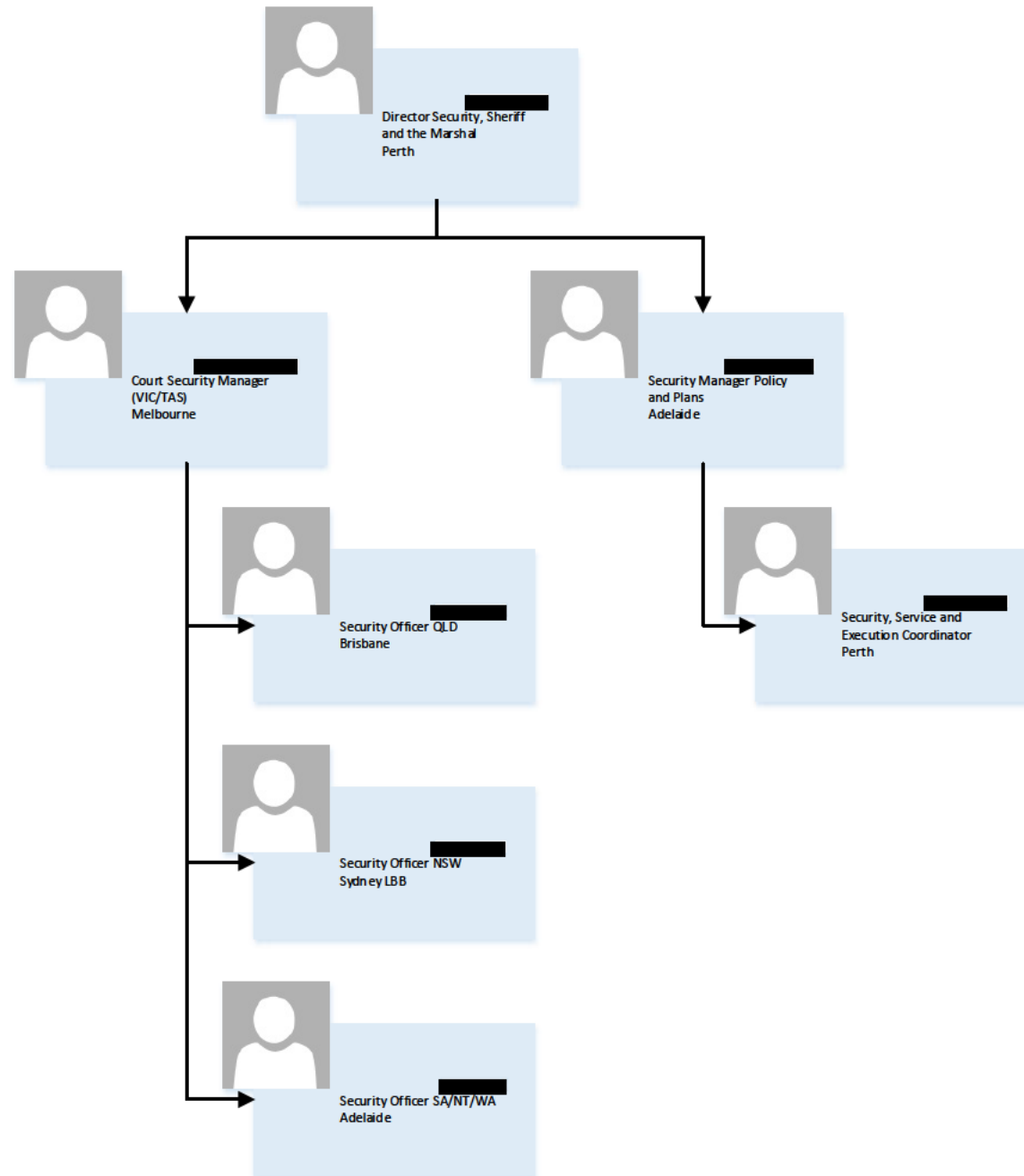
PRINCIPAL REGISTRY AND

SECURITY ORGANISATIONAL CHART



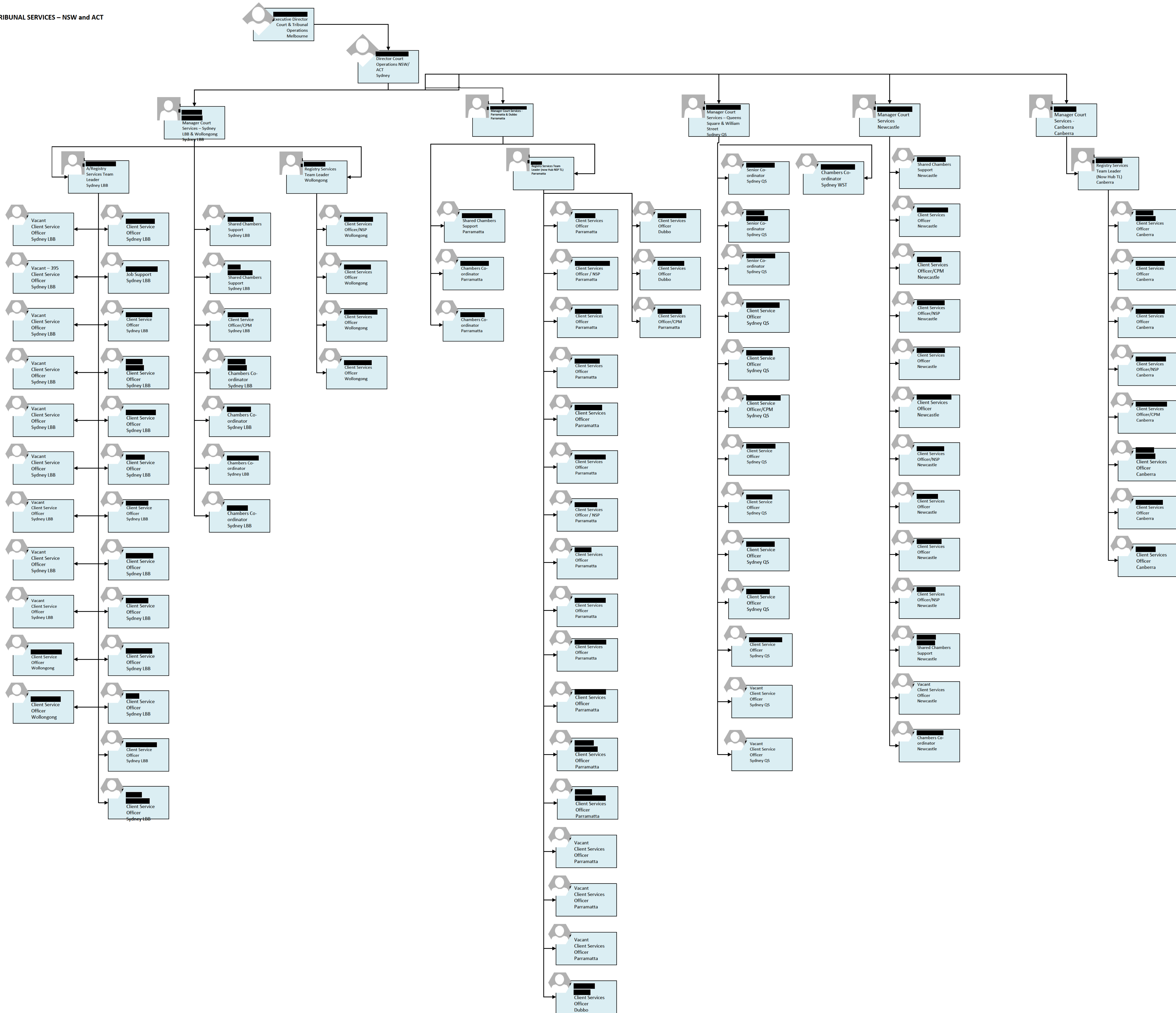

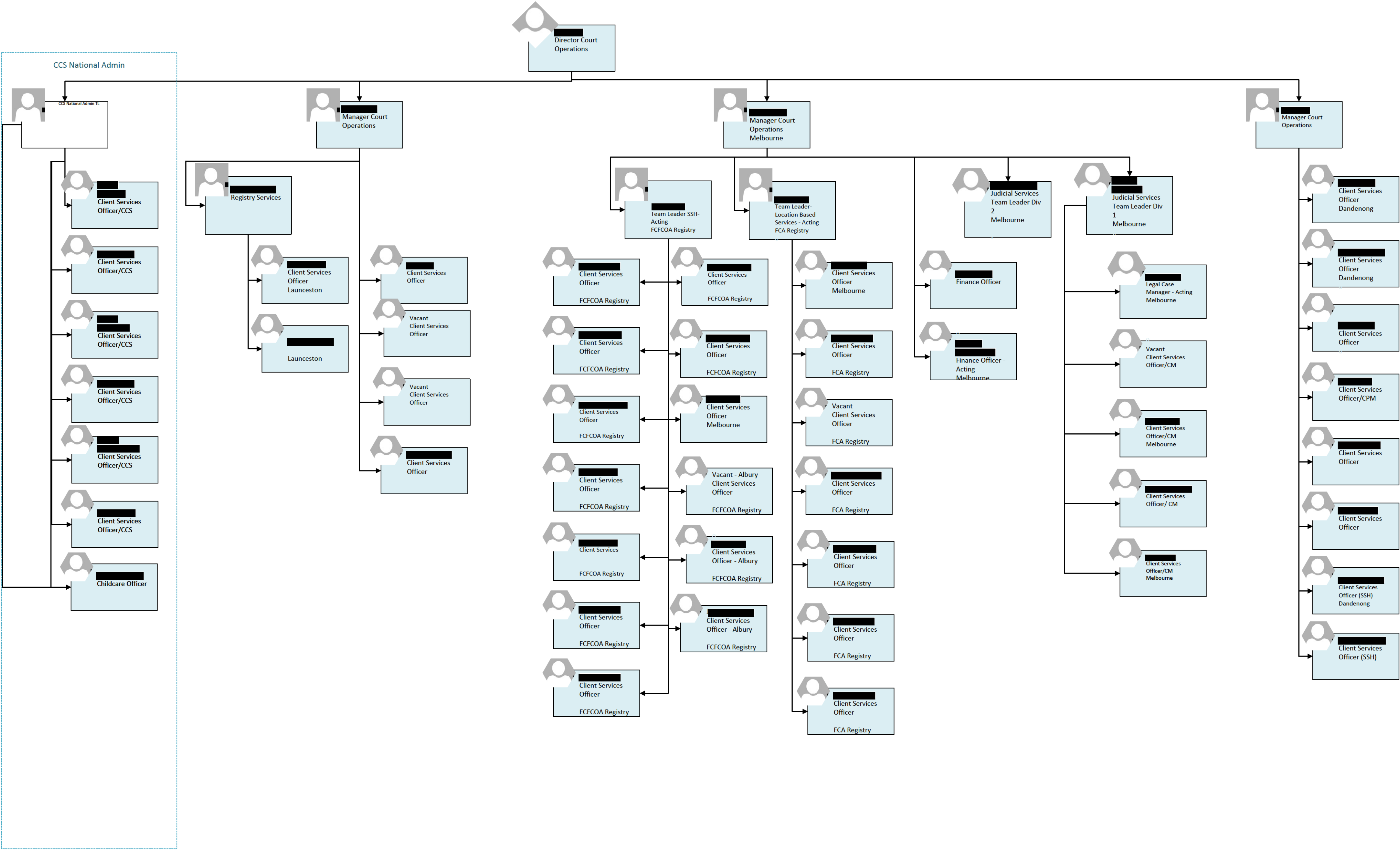
