- I, Sarah Grace Beattie of c/- Thomson Geer, Level 28, 1 Eagle Street, Brisbane in the State of Queensland, Solicitor, affirm:
- I am a Senior Associate in the Corporate Team of Messrs Thomson Geer, the solicitors for the Applicant. I was admitted to practice as a solicitor of the Supreme Court of Queensland in September 2015.
- Before making this affidavit, I read and considered the affidavit of Emma Claire Cook affirmed 18 May 2025 with Exhibits ECC-1 to ECC-5 (**Ms Cook's Affidavit**), a Partner of Messrs Thomson Geer.
- I make this affidavit based on my own knowledge and from a review of the relevant books and records maintained by Thomson Geer in respect of this matter, except where I state otherwise. Where I depose to matters on the basis of information and belief, I believe such matters to be true and correct.

#### Update as to Communications with the ASX

- I confirm that as stated at [6] of Ms Cook's Affidavit, on 15 May 2025 at 6:16 PM, I sent an email to Ms Yushra Haniff, Senior Adviser Listings Compliance at the ASX, confirming Sunstone's intention to apply to the Federal Court of Australia for relief under s 1322 of the Corporations Act for orders (amongst others) that members who have sold any uncleansed shares are relieved in whole from any civil liability in respect of their failure to comply with sections 707(3) or 727 of the Corporations Act. A copy of my email appears as Exhibit ECC-1 to Ms Cook's Affidavit.
- I am informed by Ms Cook, and verily believe, that Ms Cook called Ms Haniff of the ASX at or around 2:42 PM on 16 May 2025 and, during that conversation, Ms Haniff told her the matters Ms Cook deposes to at paragraphs 7 to 9 of Ms Cook's Affidavit.
- 6 On 19 May 2024 at 9:46 AM, I sent a further email to Ms Haniff of the ASX:

- (a) stating I understood that Ms Haniff had spoken to Ms Cook and had informed her that the ASX did not require copies of the originating application or affidavits but would like a copy of the final sealed orders;
- stating the application had been listed for hearing at 10.30 AM on Tuesday, 20
   May 2025 before Justice O'Callaghan in the Victorian Registry of the Federal Court of Australia:
- (c) requesting that she urgently confirm:
  - (i) that the ASX does not require any material/ documents ahead of the hearing; and
  - (ii) whether this means the ASX does not propose to appear at the hearing of the application or make any submissions.
