I JOHN MICHAEL CHURCHILL of Level 3, 32 Martin Place, Sydney, Solicitor say on oath:

## **Background**

- I am the solicitor on the record for the applicant in these proceedings. I have briefed Sue Chrysanthou SC to advise and appear for Mr Murdoch and she appeared at the case management hearing before the court on 23 September 2022 instructed by me.
- 2. Nothing that I say in this affidavit is intended to waive legal professional privilege.
- 3. I refer to and rely on my affidavit filed in these proceedings sworn on 22 September 2022.
- 4. During the case management hearing on 23 September 2022 Mr Hodge on behalf of the respondents said, inter alia, that the statements in paragraphs 1-16 of the Defence were relied on as facts to be established, in particular as relevant to the s29A defence and including whether the Article objectively concerns matters of public interest.
- 5. As a result of the statements made by Mr Hodge and queries raised in previous correspondence about the Defence, I wrote to the respondents' solicitors Marque Lawyers on 26 September 2022 and a copy of that letter is annexed hereto and marked "JC-17".
- 6. On 30 September 2022 at 8:23pm I received an email from Lauren Gasparini, a lawyer in the employ of Marque Lawyers which attached to it a letter addressed to myself, a document entitled "Schedule being particulars provided in respect of paragraph 8 of the

Defence" and a proposed Amended Defence, copies of these documents are annexed hereto and marked with the letters "JC-18", "JC-19", "JC-20" and "JC-21".

### **Fox Channels**

- 7. Fox Corporation is a publicly listed company on the NASDAQ which has a number of subsidiaries. Each of those subsidiaries has a different CEO and management team. One of those is Fox News Network, LLC, which includes within its Fox News Media portfolio Fox News Channel, Fox Business Network, Fox Weather, and Fox News Audio. The viewership of Fox Business Network in the United States is approximately 2-3% of that of Fox News Channel during prime time and 8-9% of Fox News Channel's total day viewership.
- 8. Fox News Channel broadcasts 24 hours per day as does Fox Business Network. In the time period covered by Respondents' Schedule, Fox Business Network broadcasts up to 14 hours of live programming per day and Fox News Channel broadcasts up to 20 hours of live programming each day.

# Schedule to paragraph 8 of the Defence

- 9. I have considered the documents served by the respondents on the evening of 30 September 2022 and discussed them with Ms Chrysanthou. We have both reviewed many of the segments listed in the Schedule which provides particulars to paragraph 8 of the Defence.
- 10. After discussing the matter with her, counsel and I are of the opinion that the information set out in the Schedule is incomplete and misleading in aspects of its presentation. For example, segments are said to have been aired on Fox News, whereas items 6, 13, 24, 27, 28, 30, 33, 36, 37, 38, 39, 40, 41, 45, 46, 48, 49, 50, 52, 53, 54, 60, 61, 66 aired on Fox Business Network. Items 20 and 23 are said to have been aired on Fox News, whereas they appear to have been aired on Fox Audio. Further, in regard to the column identified "Quote" many of the quotes are out of context and thus inconsistent with the content or incomplete in respect of the publication identified under that heading in the Schedule.

- 11. If paragraph 8 becomes an issue of objective fact in the proceeding, in my view it will be necessary to undertake a comprehensive review of all the publications identified in the Schedule, in the context in which they appear, their length and by ignoring the quote column identified above and actually having regard to the entire segment. On my information and belief the Schedule is not a comprehensive or exhaustive collection of all the broadcasts on Fox News Channel or other networks or channels operated by Fox Corporation, providing commentary, interviews and reporting on the United States of America Presidential Elections in the period 4 November 2020 to 8 January 2021.
- 12. My initial review of the segments referred to in the Schedule has led to the conclusion that a number of them are inconsistent with and not supported by their content, the contentions in paragraph 8 of the Defence and by way of example, there are:
  - a) segments that do not support the assertions contended by paragraph 8;
  - b) segments that are irrelevant to paragraph 8;
  - c) segments that prominently publish the news of the election of Joe Biden as the 46<sup>th</sup> President of the United States of America, as an example of this, a banner can be found at the bottom of a video that is listed as item 3 in the Schedule that reads JOE BIDEN ELECTED 46<sup>TH</sup> PRESIDENT: Fox News Alert:

- d) segments that include discussion of the election allegations, the right to contest elections and the policies that should be followed and/or adopted if such challenges are made, as opposed to actually adopting the allegations as fact; and segments that include discussion of the historical precedents of challenging elections in the United States of America that have been undertaken by both major political parties.
- 13. The length of each segment varies dramatically from about one minute to over 20 minutes and the context in which the particular segment contained in the Schedule appeared in the course of a broadcast is not identified. The segments in the table comprise over 8.5 hours of viewing.
- 14. Because of our preliminary review of the material in the Schedule, if paragraph 8 of the Defence forms part of the proceedings as an issue to be proved as fact (as opposed to merely matters within the knowledge of the respondents), I anticipate that substantial evidence will be adduced to contradict and/or to give context to that material.

- 15. From my own review of a wide variety of material available publicly and in particular when viewing Fox News Channel broadcasts from November and December 2020, other information was presented that is inconsistent with the respondents' contention in paragraph 8 of the Defence, for example:
  - a) on 4 November 2020, Fox News was the first network to call the State of Arizona for Joe Biden and maintained that decision despite criticism and pressure from Trump and his supporters;
  - b) from 5 November 2020 and thereafter Fox News reported on Trump's allegations of voter fraud, but also repeatedly requested such proof from President Trump and his representatives and reported on denials from various entities that voter fraud had occurred;
  - c) on 7 November 2020 Fox News projected Joe Biden to win the Presidency;
  - d) on 19 November, Fox News Host Tucker Carlson said that he had repeatedly invited Trump lawyer Sidney Powell to send to him evidence in support of her and President Trump's claims of voter fraud, which she never sent him.
- 16. To my observation of material that is publicly available, and having discussed the matter with Ms Chrysanthou who has also viewed such material, there are more examples of divergent views being expressed on Fox News in respect of the outcome of the 2020 US Presidential Election such that the maintenance of paragraph 8 of the Defence as an allegation of fact would require a review by the parties and thereafter the court of many hours of broadcast material beyond that identified by the respondents in the Schedule.
- 17. Further, in my view which has been formed in consultation with Ms Chrysanthou, for paragraph 8 (read with paragraph 9) to have any meaning whatsoever as a matter of objective fact (if that is even possible), and having regard to the wording of paragraph 42.1 of the Defence which presently includes the words "and the media environment", if the respondents' approach is allowed, the applicant would seek to tender material giving context to the "media environment" in the United States at the time from other media sources. This is likely to be an extensive and costly task that would likely cause the trial to extend beyond the 9 days presently allocated (having regard to the fact that the respondents proposed. that the trial would not exceed days).

### Mitigation

- In paragraph 37.3 of the proposed amended Defence, there is a reference to "News 18. International" which I understand to be a reference to a company that is a subsidiary of News Corporation.
- News Corporation is a publicly listed company that has a different CEO and 19. management team to Fox Corporation.
- News International owns two newspapers in the United Kingdom. The applicant has 20. never been a director or CEO of News International.
- I assume (although it is speculative given the lack of detail) that the reference in 21. paragraph 37.3 of the Defence is to the events that occurred in the United Kingdom in the period 2005 to 2011. If that is correct, the reference to "News International" is misconceived and ignorant of the applicant's role for a decade in relation to News Corporation (2005-2015) during which the issue at News International arose and was concluded.

### Reply

- As stated in my first affidavit dated 22 September 2022, the Reply was filed and served 22. on 20 September 2022 shortly after the service of the Defence.
- An objection was raised to the Reply on the evening of 21 September 2022 as to the 23. response to paragraphs 1-22 of the Defence. As stated by Ms Chrysanthou at the first case management hearing on 23 September, at the time of filing the Reply we understood those paragraphs in the Defence to amount to admissions on the part of the respondents (to the extent such admissions are relevant).
- At 2:46pm on 4 October 2022, two weeks after the Reply was filed and served, I 24. received a letter from Marque Lawyers raising an objection to paragraph 5.5 of the Reply. Annexed hereto and marked "JC-22" is a copy of that letter. I responded to that letter at 4:16pm on 4 October 2022, a copy of which is annexed hereto and marked "JC-

23".

25. I received further correspondence about this issue at 10:40am on 5 October 2022, and I responded at 11:49am and 4:32pm. I received additional further correspondence at 5:30pm and responded at 6:11pm on 5 October 2022. Annexed hereto and marked "JC-24" is a copy of the email chain between myself and Marque Lawyers containing this correspondence on 5 October 2022 concerning the belated objection to the Reply.

## Murdoch v Private Media & Ors

I refer to:

- (a) the Defence filed on 20 September (**Defence**);
- (b) the Reply filed on 20 September (**Reply**);
- (c) my letter of 20 September requesting particulars of the Defence;
- (d) your response dated 21 September relevantly declining to provide particulars;
- the submissions made in Court at the Case Management Hearing (CMH) on 23 September on behalf of your clients;
- (f) the submissions made in Court at the CMH on 23 September on behalf of the applicant;
- (g) the applicant's proposal at the conclusion of the CMH (opposed by the respondents) to clarify ambiguous matters in the Defence;
- (h) the email from the Associate on 23 September about that clarification.

As we have made plain, since receipt of the Defence, the manner in which it is pleaded is ambiguous, and liable to cause confusion and waste time and costs.

Section 29A of the Defamation Act 2005 has three separate and distinct elements:

- 1. the defamatory matter concerns an issue of public interest;
- 2. the respondents believed at the time of publication that the defamatory matter was in the public interest; and
- 3. such belief by the respondents was reasonable.

Paragraph [42] of the Defence relies on paragraphs [1]-[22] without any distinction between these different elements. This cannot be the case when one has regard to each element. For example, it is difficult to see how paragraph [21] relates to the first element of the defence.

Nor is it apparent how each of those paragraphs is capable of identifying the issue of public interest in question. What is the relevant issue of public interest? A collection of statements about the U.S. election does not amount to an issue of public interest – let alone one connected to the defamatory matter in the manner specified in s29A.

Your repeated refusal to clarify this issue renders the pleading liable to be struck out. Mr Hodge confirmed on Friday that the statements in paragraphs [1]-[16] are relied on as

objective fact and we will proceed on the basis that is how the respondents put their case unless you inform us otherwise. It is regrettable that you did not confirm that earlier in answer to my request.

The Lange qualified privilege defence has two separate and distinct elements:

- 1. the defamatory matter concerns governmental or political matters in Australia;
- 2. the conduct in publishing the defamatory matter was reasonable in the circumstances.

Paragraph [43] of the Defence relies on paragraphs [1]-[23] without any distinction provided for the different elements. It is difficult to see how any of the particulars concern government or political matters in Australia or how such particulars demonstrate reasonableness having regard to the defamatory imputations pleaded in the case.

Each of the defences in paragraphs [42] and [43] is a defence of confession and avoidance and proceeds on the basis that Mr Murdoch is defamed in the sense of one or more of the pleaded imputations (or imputations that do not differ in substance). This, together with the respondents' repeated refusal to clarify their case, has the effect that both paragraphs are ambiguous, presently disclose no reasonable defence and are liable to be struck out.

Having regard to the matters set out above and in the absence of confirmation and/or clarification of your clients' positions, as part of the application listed on 10 October 2022, the applicant will move to strike out the impugned paragraphs.

As a final matter, I note that the conduct of the case including comments made on behalf of the respondents in Court can aggravate the harm to the applicant, sounding in additional damages.

Thank you for your letter dated 26 September 2022.

#### Response to letter dated 26 September 2022

- 2. We do not agree that the Defence is ambiguous or liable to cause confusion and waste time and costs.
- 3. As to paragraph [42] of the Defence:
  - (a) the facts alleged in paragraphs [1]-[16] of the Defence, together with the fact alleged in paragraph [42.1] of the Defence, are facts that our clients will submit at trial are sufficient for the Court to be satisfied that the matter concerns an issue of public interest;
  - (b) the facts alleged in paragraphs [1]-[22] of the Defence are facts that our clients will submit at trial are sufficient for the Court to be satisfied that our clients reasonably believed that the publication of the matter was in the public interest.
- 4. In your letter you say "[a] collection of statements about the U.S. election does not amount to an issue of public interest let alone one connected to the defamatory matter in the manner specified in s29A". We are uncertain as to the meaning of this complaint in two respects.
- 5. First, it is unclear whether "[a] collection of statements about the U.S. election" is a reference to some of the allegations in paragraphs [1]-[16] of the Defence or to statements made in the Article. Assuming it is the former not the latter, our clients' position is that the conduct of the U.S. presidential election and the media environment which facilitated the incumbent President, who was unsuccessful in the election, provoking a violent insurrection aimed at preventing the



- certification of the democratically-elected President of the United States of America is undoubtedly a matter of public interest. We appreciate that your client disagrees. That is, with respect, a matter for trial.
- 6. Secondly, we are also uncertain as to which part of s29A you are referring when you say "let alone one connected to the defamatory matter in the manner specified in s29A". Your letter seems to suggest that s29A specifies a manner in which an issue of public interest must be connected to the defamatory matter. We have not been able to identify the part of s29A to which you are referring and would appreciate any further explanation you wish to offer. To assist you in considering any response, we note s29A(2) provides "In determining whether the defence is established, a court must take into account all of the circumstances of the case."
- 7. We had not appreciated that there was any ambiguity about whether [1]-[16] of the Defence were relied upon as objective facts. That is for two reasons. First, because they are pleaded as objective facts. Secondly, because not only did your letter of 20 September 2022 not ask for clarification as to whether these paragraphs were intended to be objective facts, it complained in paragraph 1 that the pleading of the objective facts in paragraphs [1]-[16] was "embarrassing and irrelevant" and objected to the paragraphs on that basis.
- 8. The wording of the *Lange* defence has been clarified. Further, for the avoidance of doubt, the Respondents say that the element of the defence articulated by the High Court in *Lange* that requires the publisher to establish that its conduct in making the publication was reasonable in all the circumstances is inappropriate and ought to be revisited. The Respondents concede that the Federal Court is bound to apply the *Lange* defence with this element but formally puts the matter in issue on the pleading. We will prepare the necessary s78B notices.
- 9. We disagree that the paragraphs are ambiguous and liable to be struck out. Please let us know as soon as convenient whether your client wishes to press his application and, if so, the precise form of relief he seeks.

### Orders made on 26 September 2022

- 10. In accordance with order 1 of the orders made by Wigney J on 26 September 2022 (Order 2), please find enclosed a schedule of the particulars of paragraph 8 of the Defence. Column 5 of the schedule identifies a link to the publication relied on by our clients as a particular to paragraph 8 of the Defence. Examples of representations are included at column 6 of the schedule.
- 11. In accordance with order 2 of the Orders, please also find enclosed our clients' proposed amendments to the Defence, identified in track changes. Please advise whether your client consents to an amended version of our clients' Defence being filed.

# Factual background

- On 3 November 2020, the United States of America conducted its 59<sup>th</sup> Presidential Election (2020 Presidential Election).
- 2. Joseph R Biden won the 2020 Presidential Election.

# **Particulars**

- (a) President Biden won 51.3% of the popular vote;
- (b) President Biden received 306 electoral college votes reflecting that:
  - (i) he won the majority of votes in the following states and all of the electoral college votes from those states were cast in his favour: Arizona, California, Colorado, Connecticut, Delaware, District of Colombia, Georgia, Hawaii, Illinois, Maryland, Massachusetts, Michigan, Minnesota, Nevada, New Hampshire, New Jersey, New Mexico, New York, Oregon, Pennsylvania, Rhode Island, Vermont, Virginia, Washington and Wisconsin;

- (iii) he won the majority of votes in the Second Congressional District of Nebraska and 1 of Nebraska's 5 electoral college votes was proportionally assigned to him.
- 3. Donald J Trump lost the 2020 Presidential Election.
- The results of the 2020 Presidential Election were certified by the Congress of the United States of America on 7 January 2021 and President Biden was therefore elected the 46th President of the United States of America.
- 5. Mr Trump:
  - 5.1 refused to concede the 2020 Presidential Election; and
  - 5.2 alleged, without any reasonable basis, that it was "stolen" by reason of widespread voter fraud.
- 6. Fox News is the number one cable network in the United States of America and reaches approximately 200 million people per month.
- 6A. Fox Corporation and News Corporation are each companies:
  - (a) operating global media conglomerates;
  - (a)(b) controlled or primarily controlled by members of the Murdoch family, being the family of which Rupert Murdoch is the patriarch.
- 6.7. Fox News is operated, either directly or through a subsidiary, by Fox Corporation.
- 7.8. From around 7 November 2020, hosts and guests of Fox News repeatedly cast doubt on the outcome of the 2020 Presidential Election and directly or indirectly promoted on air:
  - 7.18.1 the allegations, without reasonable basis, of voter fraud made by Mr Trump;
  - 7.28.2 the false claim that President Biden had not legitimately won, and Mr Trump had not lost, the 2020 Presidential Election.
- 8.9. At no time to date have Rupert Murdoch, the Murdoch family generally as owners of Fox Corporation, or the applicant (**Lachlan Murdoch**), publicly repudiated the claims made by hosts and guests of Fox News alleged in the preceding paragraph.
- 9.10. On 6 January 2021, a group of supporters of Mr Trump violently stormed the Capitol in Washington, District of Columbia, whilst the Congress of the United States of America was in session, in an effort to stop the certification of President Biden's victory in the 2020 Presidential Election.
- 40.11. As a consequence of the violent insurrection referred to in the preceding paragraph:
  - 40.411.1 Members of the Congress of the United States of America were forced to flee in terror from the Capitol;

- 10.211.2 the certification of the result of the 2020 Presidential Election was delayed to 7 January 2021.
- 41.12. Mark Meadows was the Chief of Staff to Mr Trump as at 6 January 2021.
- 42.13. On 28 June 2022, Cassidy Hutchinson, former senior aide to Mr Meadows, gave evidence at the public hearings of the United States House Select Committee on the 6 January riot.
- 43.14. Ms Hutchinson's evidence was relevantly to the effect that, on 6 January 2021, Mr Trump:
  - 13.114.1 was aware that his supporters proceeding to the Capitol building were armed and had violent intent;
  - 13.214.2 wanted to lead his supporters;
  - 13.314.3 had attempted to grab the steering wheel from his driver when the driver refused to take him to the Capitol.
- 44.15. Ms Hutchinson's evidence was given overnight or early in the morning Australian time.
- 15.16. Ms Hutchinson's evidence was widely discussed in the international media and was the immediate impetus for the publication the subject of this proceeding by the Respondents.
- 16.17. At around 8:00am on 29 June 2022:
  - 16.117.1 the second respondent (**Mr Keane**) reported to the third respondent (**Mr Fray**) that he had seen the evidence of Ms Hutchinson and that he should write about it;
  - 46.217.2 Mr Fray considered the story to be important to Australian and international audiences and given the high level of interest in the testimony, felt that expeditious publication was necessary to keep pace with the political news cycle;
  - 46.317.3 Mr Fray was aware that Australia had an editorial advantage given the time zone;
  - 46.417.4 Mr Fray agreed that Mr Keane should write about the story.
- 17.18. At the time Mr Keane wrote the article the subject of this proceeding, he:
  - 17.118.1 had extensive university qualifications in history, including a PhD;
  - 47.218.2 had extensive experience working in the Commonwealth Public Service on Australian media policy;

  - 41.142.2 they reasonably believed that the publication of the matter was in the public interest; and
  - 41.242.3 in the premises, publication of the Article was therefore in the public interest and therefore defensible pursuant to s29A *Defamation Act* 2005 and its equivalents in the States and Territories.

# Defence - Lange qualified privilege

- 43. Further, and in the alternative, if the matter complained of is found to be defamatory in that it conveyed one or more of the Imputations, which is denied, the Respondents say:
  - 43.1 , in reliance on By reason of the matters at paragraphs at [1]-[22] and [42.1] above, that the matter related to governmental or political matters; and

- 43.2 By reason of the matters at [17]-[22] above, that the Respondents acted reasonably in publishing the matter; and
- 43.3 Therefore the matter was published on an occasion of qualified privilege, being the implied Constitutional freedom of communication about governmental or political matters ("Lange defence").
- 44. In the alternative to 43.3 above, the Respondents say that:
  - (a) the concept of reasonableness must be adapted, or the requirement more strictly construed, so as to ensure that an inappropriate burden is not imposed on the implied freedom;
  - (b) the imposition of a reasonableness criterion as part of the *Lange* defence is inappropriate and should be revisited.

# Defence – failure to accept reasonable offer of amends, s18 Defamation Act 2005

- 42.45. If the matter complained of is found to be defamatory in that it conveyed one or more of the Imputations, which is denied, the Respondents say that on 27 July 2022, by their solicitors Marque Lawyers, they made an offer of amends to Lachlan Murdoch pursuant to and conformable with s13 of the *Defamation Act* 2005 (**Offer of Amends**).
- 43.46. The Offer of Amends was made as soon as reasonably practicable after they were given a concerns notice in respect of the matter (and, in any event, within the applicable period for an offer to make amends).
- 44.47. The Respondents were ready and willing, on acceptance of the Offer of Amends by Lachlan Murdoch to carry out the terms of the offer.
- 45.48. In all the circumstances, the Offer of Amends was reasonable.
- 46.49. On 29 July 2022, the Offer of Amends was rejected.
- 47.50. In the premises, the Respondents have a defence to the action pursuant to s18 *Defamation Act* 2005.
