

### **INITIATIVE EXECUTIVE COMMITTEE MEETING - RESOLUTIONS**

Apia, Samoa

6 April, 2017

The IEC resolved the following matters during the 2<sup>nd</sup> PJSI Initiative Executive Committee Meeting held in Apia, Samoa (6 April, 2017):

### **Resolution 1:**

The IEC *accepted* the PJSI Team's Progress Report and acknowledged the progress made under the PJSI to-date.

### **Resolution 2:**

The IEC *accepted* the PJSI Team's Financial Report. The IEC *approved* the following additional activities to enable the PJSI Team to further develop / scope and implement the:

- 1. Additional support to orientation & decision making training;
- 2. Contingency to be retained;
- 3. Develop an ICT Options Paper in time for the next IEC Meeting (September 2017);
- 4. Support to the PacLII Ministerial Delegation for two chief justices, a senior member of the PJSI Team, and the PacLII Director;
- 5. Develop Session Planning Toolkit;
- 6. Efficiency (location TBC);
- 7. Any balance of underspends to be allocated to Additional LIF activities (if feasible).

Activity costs and fees will remain in-line with the approved unit amounts in the PJSI budget.

### **Resolution 3:**

The IEC *noted* the '*Chief Justices' Recommendations*' (attached in the *Annex*). The meeting endorsed all recommendations and the updated scheduling sheet, with the exception of:

- *Recommendation 1:* to task the PJSI Team to draft a letter for the IEC Chair with regards to engaging with the USP School of Law, and drafting a Memorandum of Understanding to formalise arrangements if and as required.
- Recommendation 10: which was refined in line with IEC Resolution 2 to task the PJSI Team to: develop an ICT Options Paper in time for the next IEC Meeting (September 2017); and support the PacLII Ministerial Delegation for two chief justices, a senior member of the PJSI Team, and the PacLII Director.

#### **Resolution 4:**

The IEC *requested* that the planned Leadership Workshop (5-7 September, 2017) should focus on: change leadership; change management; and team leadership. Consequently, the originally

proposed focus on Gender and Family Violence would no longer form part of this workshop and be relocated to subsequent regional workshop.

### **Resolution 5:**

The IEC *approved* the publication of PJSI materials developed, on the website.

#### **Resolution 6:**

The IEC *confirmed* that the next meeting of the IEC will be held remotely on Thursday 28 September, 2017 (4:00pm Tonga-time).

### Annex: Chief Justices' Leadership Forum Recommendations

### PACIFIC JUDICIAL STRENGTHENING INITIATIVE

# Second Chief Justices' Leadership Forum Recommendations Apia, Samoa - 3-5 April, 2017

We, the Chief Justices and Chief Justices' Representatives of the Pacific Judicial Strengthening Initiative (PJSI) - in the absence of Nauru - comprising 13 Pacific Island Countries (PICs) being Cook Islands, Federated States of Micronesia, Kiribati, Niue, Palau, Papua New Guinea, Republic of Marshall Islands, Samoa, Solomon Islands, Tokelau, Tonga, Tuvalu, and Vanuatu - have convened at the Chief Justices' Leadership Forum held in Apia, Samoa (3-5 April, 2017), make the following recommendations for the consideration of the Initiative Executive Committee (IEC) of the PJSI.

The Forum:

1. *Endorsed* the strategy developed for the *Career Gateway* activities (with USP Law School) and further *endorsed* PJSI's ongoing support to this activity. Chief Justices requested further: clarification of the proposed target audience for the Certificate / Diploma of Justice courses; options for various implementation modalities (in particular remote delivery, blended delivery, and in-country delivery options); and detail and focus provided on the draft curriculum developed to-date. Chief Justices authorised extending discussions with USP regarding engaging with the School of Law, and to drafting a Memorandum of Understanding to formalise arrangements. A number of PICs expressed interest in participating in the pilot course, including: Cook Islands, Kiribati, Niue, Palau, Papua New Guinea, Republic of Marshall Islands, Samoa, Solomon Islands, Tokelau, Tonga, and Vanuatu.<sup>1</sup>

The Forum *established* a sub-committee to oversee this activity between meetings comprised of: Chief Justice Muria; Chief Justice Palmer; and Chief Justice Injia.

2. *Endorsed* the strategy developed for the *Career Pathways* activity (with PNG CJE). The Forum noted that this activity is exploratory in nature, and *endorsed* further PJSI support being provided to this activity subject to the five 'red lines' identified in the concept paper being met notably including appointment of a permanent Executive Director.

The Forum *established* a sub-committee to oversee this activity between meetings comprised of: Chief Justice Muria; Chief Justice Palmer; and Chief Justices Injia.

- 3. *Endorsed* the draft Human Rights Toolkit and the strategies and approach developed to pilot the draft toolkit.
- 4. *Endorsed* the draft Gender and Family Violence Toolkit and the strategies and approach developed to pilot the draft toolkit.
- 5. *Noted* that Chief Justices' Leadership Fora are intended to be closed meetings (as noted by the first Forum in Port Moresby) and Chatham House Rule applies. Where a Chief Justice is

unable to participate, s/he may nominate an appropriate representative to attend the Forum. Non-judicial officers would only have observer status.

- 6. Noted the recent passing of Senior Justice of the Peace Mr. John Kenning, the Lay Judicial Officer Representative on the PJSI Initiative Executive Committee (IEC). Chief Justices are asked to identify possible new Lay Judicial Officer Representatives (sent by email to the MFAT representative, Ms. Elise Trewick) for the IEC's consideration.
- 7. **Noted** that the maintenance of PacLII is essential to the operational effectiveness of courts in the Pacific. The Forum **endorsed** the proposal that a delegation approaches the Australian Department of Foreign Affairs and Trade and the New Zealand Ministry of Foreign Affairs and Trade. The delegation will be led by the PJSI Chair, Chief Justice Palmer, and include the PacLII Director.

The Chief Justices *requested* the PacLII Director to develop a collective Memorandum of Understanding (MoU) with the PJSI Chief Justices as a group. The draft MoU will be circulated by the PacLII Director after the conclusion of the Forum for Chief Justices' consideration. Individual MoUs can then also be concluded between PacLII and each jurisdiction.

- 8. Noted that: technology and the courts; judicial control of budget; separation of powers; and the use of specialist courts to address specific justice issues are of interest to a number of the PJSI partner courts. The PJSI Team was requested that time is allocated in open / discussion sessions at the next Chief Justices' Leadership Forum for Chief Justices whose courts have relevant experience to discuss and showcase their experiences.
- 9. **Endorsed** the Approach to Judicial Orientation and Other Training developed by the PJSI and the strategic, andragogic, and implementation approach adopted by PJSI in its training and capacity building activities.
- 10. Endorsed the scheduling of activities as discussed at the Forum and the proposed additional activities, including: support to orientation and decision making training (retired Judicial Officers); the retention of appropriate contingency amounts; the development of a Leadership Adviser role; the development of a Session Planning Toolkit for Judicial Officer Orientation; an additional Efficiency activity; and reallocation of any remaining underspends to additional LIF activities, if possible.
