Hi Rebel,

None of us understand the personal relationships at AI. Golly, from the little we see of it, it looks complicated from the outside!

But what is apparent is this: Danny and Vince desperately want to close the deals on the film so that it all functions properly and Len keeps cash flowing the film through to delivery. They believe in you and they believe in the film you're making. And which they are paying for. Absent any formal complaint from Charlotte or solid evidence of actual wrongdoing, they don't seem to think that there is anything to deal with on the Amanda beyond calming the situation and helping get relationships back on track.

As regards what we know for sure, that's the stuff about the commercial deals. Yes we were rightly annoyed at the approach that A and G took to EP fees and stage rights. But that was a commercial dispute and we have settled it. We didn't like their approach, but it wasn't wildly unusual. It was about some deal making. A few sharp elbows here and there are sort of par for the course, sadly. Point is this: we got there on the deal and the deal is a good deal for you.

For you personally, the first thing is to do the right thing and guard your reputation. That you make sure that you have acted properly in making the producers and the financiers aware of the behaviour of Amanda and Gregor. You've done that by providing your statement and we've raised the red flag issues with Danny. Furthermore, given that Charlotte has made no formal complaint about Amanda, and given that you have been there to support both Charlotte and her agent, shows you acting in good faith and with proper concern for all your cast and crew.

And then there's what you do as a producer and a director: in working with your lead producer on the ground, in showing your constant support to cast and crew in creating a good environment for their work, so they feel loved, respected and supported by you. Everything you're telling us about what you're doing on your set shows you acting in a totally professional and ethical manner. Keep at it!!

I'm back in the documents on the financing now and Vince is chasing me for signatures.

Hi Danny,

Filming has commenced and is going exceptionally well, despite yesterday Gregor halting filming after lunch for an hour until I signed a document stating I have no issues with Amanda and she can return to set. This was done under complete duress as Gregor was saying he will walk out the door and send everyone on the set home IMMEDIATELY unless I agreed to do this. He constantly purported that Len wanted this. Which seemed highly odd.

This was complete bullying. I am on set trying to do my job and don't need this destructive behavior.

For the record, please find below the email proof of Gregor instructing the Australian producers to add \$900k of additional personal fees, above and beyond what was approved for them in the co-production deal. Only after this was brought to Len's attention by my partner Ramona on Sunday October 10th were these taken out of the budget. Subsequent to this phone call, and to my alerting you of Amanda's inappropriate behaviour with a cast member during music pre-records, there have been constant threats from both Amanda and Gregor to pull financing from the film. For obvious reasons, this is not constructive behavior and if it continues to happen I will have to walk away from this job. All I have done is flag inappropriate behavior, which I have a duty to do, whilst continuing to do my job at the highest standard.

Please let me know if I should be contacting Len personally regarding this. I know he is extremely busy and with what's going on in the world right now, I didn't want to disturb him unnecessarily.
