A. THE PARTIES

1. The Applicant is:
 - (a) Jewish and a dual Australian-Israeli citizen;
 - (b) the Chief Executive Officer of the Zionist Federation of Australia; and
 - (c) an active member of the Australian Jewish Community.
2. The Respondent:
 - (a) is a former newsreader for SBS World News; and
 - (b) operates, and at all material times operated, a public account on the website X (formerly Twitter) under the handle @MaryKostakidis which had, in January 2024, approximately 28,000 followers.

B. JEWISH COMMUNITY IN AUSTRALIA

- ~~3. There are approximately 115,000 people in Australia who identify as Jewish.~~
3. There are approximately 115,000 people in Australia who identify as being of the Jewish race or of Jewish ethnic origin (**Jewish Australians**).
- ~~4. The vast majority of Australian Jews:~~
 - ~~(a) consider themselves to be Zionist;~~
 - ~~(b) feel a personal connection to the State of Israel and the Israeli people; and~~
 - ~~(c) have concern for the safety of Israelis.~~

Particulars

~~The Applicant refers to the research contained in 'Crossroads 23: Surveying Australian Jews on Israel', Monash University and Plus61J Media, dated June 2023 and 'Gen17 Australian Jewish Community Survey: Preliminary Findings Australian Centre for Jewish Civilisation', Monash University and JCA, first published March 2018.~~

4. The vast majority of Jewish Australians:
 - (a) consider themselves to be Zionist;
 - (b) feel a personal connection to the State of Israel and the Israeli people; and
 - (c) have concern for the safety of Israelis.

Particulars

The Applicant refers to the research contained in 'Crossroads 23: Surveying Australian Jews on Israel', Monash University and Plus61J Media, dated June 2023 and 'Gen17 Australian Jewish Community Survey: Preliminary Findings Australian Centre for Jewish Civilisation', Monash University and JCA, first published March 2018.

4A. There are approximately 11,000 people in Australia of Israeli national origin (**Israeli Australians**).

4B. The vast majority of Israeli Australians:

- (a) consider themselves to be Zionist;
- (b) feel a personal connection to the State of Israel and the Israeli people; and
- (c) have concern for the safety of Israelis.

C. HEZBOLLAH AND HAMAS

5. Hezbollah is a terrorist organisation based in Lebanon.

Particulars

Hezbollah was listed as a terrorist organisation under the *Criminal Code Act 1995* (Cth) on 10 December 2021.

- 6. Between 1992 and 2024, Hassan Nasrallah was the Secretary-General and leader of Hezbollah.
- 7. Hezbollah is committed to the destruction of the State of Israel and the killing of Jews.

Particulars

Hezbollah's 2009 Manifesto refers to Israel as '*an eternal threat to Lebanon*'.

Hezbollah has been responsible for numerous attacks on Israel and Israeli targets and Jewish targets, including:

- (a) the bombing of the Israeli embassy in Buenos Aires in 1992 killing 29 people and injuring over 240 people;
- (b) the car bombing of a Jewish community centre in Buenos Aires in 1994, killing 85 people and injuring over 300 people;

- (c) the abduction of two Israeli soldiers in 2006 leading to the 2006 Lebanon war;
 - (d) a suicide bombing on a bus transporting Israeli tourists in Bulgaria in 2012, killing five Israelis, one Bulgarian and injuring 32 more Israelis; and
 - (e) Hezbollah has launched ongoing rocket attacks on Israel targeting Israeli civilians over the last three decades.
8. Mr Nasrallah has made repeated statements calling for Hezbollah or Muslims generally to rise up against and destroy Israel and Jews.

Particulars

The Applicant refers to the following examples:

- (a) in 1997, Mr Nasrallah described Hezbollah's ideology as including '*the continued need to struggle against the Israeli enemy*';
 - (b) in 2000, Mr Nasrallah stated '*If we searched the entire world for a person more cowardly, despicable, weak and feeble in psyche, mind, ideology and religion, we would not find anyone like the Jew. Notice, I do not say the Israeli*';
 - (c) in 2002, Mr Nasrallah stated '*If Jews all gather in Israel, it will save us the trouble of going after them worldwide*';
 - (d) in 2013, Mr Nasrallah described Israel as a '*cancerous growth*' and said that '*the elimination of Israel is not only a Palestinian interest. It is the interest of the entire Muslim world and the entire Arab world*'; and
 - (e) in 2020, Mr Nasrallah called for the annihilation of Israel.
9. Hamas is a terrorist organisation based in the Gaza strip.

Particulars

Hamas was listed as a terrorist organisation under the *Criminal Code Act 1995* (Cth) on 4 March ~~2022~~2024.

Hamas' paramilitary wing, the Izz al-Din al-Qassam Brigades, was first listed as a terrorist organisation under the *Criminal Code Act 1995*

(Cth) on 5 November 2003 and most recently re-listed on 4 August 2021.

10. Hamas is committed to the destruction of the State of Israel and the killing of Jews.

Particulars

In its preamble, Hamas' 1988 Charter sets out that *'Israel will exist and will continue to exist until Islam obliterates it, just as it obliterated it before'*.

Article 7 of Hamas' 1988 Charter provides that *'The hour of judgment shall not come until the Muslims fight the Jews and kill them, so that the Jews hide behind trees and stones, and each tree and stone will say: "Oh Muslim, oh servant of Allah, there is a Jew behind me, come and kill him"'*.

Article 19 of Hamas' 2017 Charter provides that *'There shall be no recognition of the legitimacy of the Zionist entity'*.

In 2020, Ismail Haniyeh, the Chairman of Hamas from May 2017 until his assassination in July 2024, said that Hamas rejects ceasefire agreements, preferring to remain at war with Israel until a Palestinian state is established from the River to the Sea: *'We cannot, in exchange for money or projects, give up Palestine and our weapons. We will not give up the resistance... We will not recognize Israel, Palestine must stretch from the [Jordan] River to the [Mediterranean] Sea'*.

Hamas official, Hamad Al-Regeb said in an April 2023 sermon that he prayed for *'annihilation'* and *'paralysis'* of the Jews whom he described as filthy animals: *'[Allah] transformed them into filthy, ugly animals like apes and pigs because of the injustice and evil they had brought about'*. Al-Regeb also prayed for the ability to *'get to the necks of the Jews'*.

D. OCTOBER 7 ATTACK AND RISE IN ANTISEMITISM

11. On 7 October 2023, Hamas terrorists invaded Israel and:
- (a) murdered approximately 1,200 Israelis;
 - (b) took approximately 240 people hostage;
 - (c) injured approximately 6,000 people;

(d) committed acts of sexual violence; and

(e) destroyed property.

(the **October 7 Attack**).

12. The October 7 Attack constituted the greatest loss of Jewish life on any single day since the Holocaust.
13. The following day, and before Israel had taken any responsive step to the October 7 Attack, Hezbollah began launching rockets into Israel.

Particulars

Since the October 7 Attack, Hezbollah has fired thousands of rockets from southern Lebanon at Israel, killing at least 7024 people and displacing approximately 70,000 Israelis.

14. Since the October 7 Attack there has been a significant increase in antisemitism and/or racism towards ~~Jews~~ Jewish Australians and Israeli Australians. ~~Israelis in Australia.~~

Particulars

The Applicant relies on the Reports by the Executive Council of Australian Jewry concerning Antisemitism in Australia in 2023 (**2023 Report**) and 2024 (**2024 Report**).

The 2023 Report recorded an increase of antisemitic incidents in Australia, including a 738% increase in antisemitic incidents in October and November 2023 compared to the number for the months of October and November in 2022.

The 2024 Report recorded a 316% increase in antisemitic incidents for the 12-month period ending 30 September 2024.

Some of the incidents of antisemitism since the October 7 Attack include:

- (a) protests outside the Sydney Opera House on 9 October 2023 where participants celebrated the October 7 Attack;
- (b) antisemitic graffiti on identifiable Jewish property such as synagogues or Jewish owned childcare centres;
- (c) almost 600 Jewish Australians were doxed in February 2024 when the names and personal details of members of a private

WhatsApp group formed by Jewish writers, artists, musicians and academics were disseminated by anti-Zionist activists;

- (d) the arson attack at the Adass Israel synagogue in Melbourne on 6 December 2024;
- (e) multiple incidents of cars set alight and vandalised with antisemitic graffiti in Jewish neighbourhoods;
- (f) a Jewish childcare centre in Sydney was firebombed with antisemitic graffiti left on its walls in January 2025; and
- (g) a video went viral in February 2025 in which two nurses in Sydney threatened to kill Israeli patients and boasted about refusing to treat Israelis.

E. THE RESPONDENT'S CONDUCT

- 15. The Respondent is an active social media user who posts frequently on X.
- 16. Since the October 7 Attack, the Respondent has posted on X about Israel and/or Jews.

Particulars

A compilation of a sample of the Respondent's posts on the topic are detailed in Annexure A to this Statement of Claim.

- 17. The Respondent's posts on X about Israel and/or Jews have:
 - (a) spread and endorsed antisemitic conspiracy theories, including that:
 - (i) Israel has control of, or significant influence over, the US Congress, the US Government, the US military, the US media, UK politics and the narrative in the Western World (including Australia);
 - (ii) Israel assassinated President John F. Kennedy;
 - (iii) there was an alliance and collaboration between Zionists and the Nazis; and
 - (iv) Israeli Mossad agents were involved in the 9/11 attacks;

Particulars

The Applicant refers to the posts in the Annexure numbered 7, 21, 22, 23, 24, 26, 27, 28, 30, 32, 33, 34, 35, 37, 42, 46, 47, 50, 51, 55, 56, 58 and 61.

- (b) suggested that Zionism is equivalent to Nazism;

Particulars

The Applicant refers to the posts in the Annexure numbered 14, 20 and 44.

- (c) suggested that Israel is a supremacist apartheid state;

Particulars

The Applicant refers to the posts in the Annexure numbered 18 and 38.

- (d) suggested that Israel was complicit in slaughtering its own citizens in the October 7 Attack;

Particulars

The Applicant refers to the posts in the Annexure numbered 10 and 43.

- (e) sought to deny and/or justify the actions of Hamas in perpetrating the October 7 Attack; and

Particulars

The Applicant refers to the posts in the Annexure numbered 1, 2, 8, 11, 12, 13, 25, 31, 40 and 41.

- (f) characterised Israel's response to the October 7 Attack as being:

- (i) genocidal; and
- (ii) akin to the actions of the Nazis in carrying out the Holocaust.

Particulars

The Applicant refers to the posts in the Annexure numbered 4, 5, 6, 8, 14, 16, 28, 29, 30, 36, 39, 44, 45, 49, 52, 54, 57 and 60.

4 January Post

18. On 4 January 2024, the Respondent published a post on her public X Account (**4 January Post**) which included:

- (a) her own statement which contained the following words:

The Israeli govt getting some of its own medicine.

Israel has started something it can't finish with this genocide.

#Gaza

- (b) reposted a post from an X Account, @CensoredMen, which contained (**First Nasrallah Post**):

- (i) the following words:

The leader of Hezbollah, Hassan Nasrallah, tells the Israelis they will never be welcome in the region.

“Here you don't have a future, from the river to the sea the land of Palestine is for the Palestinian people, and the Palestinian people only.”...

- (ii) and a link to a video of a speech of Mr Nasrallah (**Nasrallah Video**) which is translated into English, where Mr Nasrallah states:

The number of military vehicles and the number of tanks that are being destroyed every day, the psychological situation, Yediot Ahronot said that one of the results of the Al-Aqsa Flood Battle is that 300,000 new people have sought therapy – have sought psychological therapy. So, you want to stay here, that's very difficult. Here, it's going to be very difficult for you. If you want to be secure, if you want to feel secure, you have an American passport, go back to the United States. You have a British passport go back to the UK. Here, you don't have a future, and from the river to the sea, the land of Palestine is for the Palestinian people and for the Palestinian people only – the resilient Palestinian people, the mujahideen.

~~19. The audience of the 4 January Post was reasonably likely to include (**Jewish and/or Israeli audience**):~~

~~(c) people of Israeli national origin in Australia; and/or~~

~~(d) people of Jewish ethnic origin and/or race in Australia.~~

19. The audience of the 4 January Post was reasonably likely to include:

(a) Jewish Australians; and/or

- (b) Israeli Australians.

13 January Post

20. On 13 January 2024, the Respondent reposted (**13 January Post**) a post on her public X Account from an X Account, @CensoredMenrichimedhurst, which included (**Second Nasrallah Post**):

- (a) a statement which contained the following words:

Nasrallah's message to Israelis:

"If you want to be secure and safe, you have a US passport, go back to the US. You have a British passport, go back to the UK.

Here you don't have a future. From the river to the sea, the land of Palestine is for the Palestinian people only."

- (b) and a link to the **Nasrallah Video**.

- ~~21. The audience of the 13 January Post was reasonably likely to include the Jewish and/or Israeli audience.~~

21. The audience of the 13 January Post was reasonably likely to include:

- (a) Jewish Australians; and/or
 (b) Israeli Australians.

F. BREACHES OF s 18C

4 January Post

- ~~22. In all the circumstances, the 4 January Post was reasonably likely to offend, insult, humiliate and/or intimidate Australian Jews and/or Israelis in Australia.~~

Particulars

The Applicant relies inter alia on the following:

- (a) ~~the connection of the Australian Jewish population to the State of Israel and the safety of Israelis as set out in paragraph 3 above;~~
- (b) ~~the atrocities committed by Hamas in the October 7 Attack as set out in paragraph 11 above;~~
- (c) ~~the significant rise in antisemitism in Australia following the October 7 Attack set out in paragraph 14 above;~~

- (d) — ~~Hezbollah's philosophy of antisemitism and history of anti-Israeli activity as set out in paragraphs 7 to 8;~~
- (e) — ~~the rocket attacks launched by Hezbollah on Israel as set out in paragraph 13 above;~~
- (f) — ~~the 4 January Post was reasonably likely to convey to the Jewish and/or Israeli audience that Jews and/or Israelis are not indigenous to Israel and ought 'go back' to other places, and that all the land 'from the [Jordan] river to the [Mediterranean] sea' [including all of the land on which the State of Israel exists] is for the Palestinian people only';~~

- (j) — ~~the phrase 'from the river to the sea' has been used historically to intimidate Jews and/or Israelis and oppose Israel's right to exist; and~~
- (k) — ~~the Respondent's posts prior to the 4 January Post as set out in part in paragraph 17 above and at Annexure A.~~

22. In all the circumstances, the 4 January Post was reasonably likely to offend, insult, humiliate and/or intimidate Jewish Australians and/or Israeli Australians.

Particulars

The Applicant relies inter alia on the following:

- (a) the connection of Jewish Australians and Israeli Australians to the State of Israel and the safety of Israelis as set out in paragraphs 4 and 4B respectively, above;

- (b) the atrocities committed by Hamas in the October 7 Attack as set out in paragraph 11 above;
- (c) the significant rise in antisemitism in Australia following the October 7 Attack set out in paragraph 14 above;
- (d) Hezbollah's philosophy of antisemitism and history of anti-Israeli activity as set out in paragraphs 7 to 8;
- (e) the rocket attacks launched by Hezbollah on Israel as set out in paragraph 13 above;
- (f) the 4 January Post was reasonably likely to convey to Jewish Australians and/or Israeli Australians that Jews and/or Israelis are not indigenous to Israel and ought 'go back' to other places, and that all the land 'from the [Jordan] river to the [Mediterranean] sea' [including all of the land on which the State of Israel exists] is for the Palestinian people only';

- (d) the Respondent making the 4 January Post; and
- (e) the Respondent's posts as set out in paragraph 17 above and Annexure A.

Further particulars may be provided prior to trial.

27. By reason of the matters set out in paragraphs 25 and 26, the Respondent, by making the 13 January Post, breached s 18C of the *Racial Discrimination Act 1975* (Cth).

G. RELIEF

28. The Applicant seeks:
- (a) a declaration that the making of the 4 January Post and/or the 13 January Post breached s 18C of the *Racial Discrimination Act 1975* (Cth);
 - (b) an apology;
 - (c) an order that the Respondent publish a corrective notice above the text in the 4 January Post and the 13 January Post acknowledging that the Court has made a declaration that the Posts breached s 18C of the *Racial Discrimination Act 1975* (Cth), with wording to be determined by the Court;
 - (d) costs; and
 - (e) any other order this Honourable Court might think fit.



The mission team, specifically the forensic pathologist and the digital analyst, reviewed over 5,000 photos, around 50 hours and several audio files of footage of the attacks, provided partly by various state agencies and through an independent online review of various open sources, to identify potential instances and indications of conflict-related sexual violence. The content encompassed the actual attacks and their immediate aftermath, captured through militants' bodycams and dashcams, individual cellphones, CCTV, and traffic surveillance cameras. Additionally, the materials included photos and videos documenting the process of recovering and identifying the deceased.

74. In the medicolegal assessment of available photos and videos, no tangible indications of rape could be identified.

77. The digital evidence discovered during independent open-source review appeared authentic and unmanipulated. While the mission team reviewed extensive digital material depicting a range of egregious violations, no digital evidence specifically depicting acts of sexual violence was found in open sources.

Beyond this, from inquiries put to three bodies in the defense establishment by Haaretz, it emerges that the intelligence material collected by the police and the intelligence bodies, including footage from terrorists' body cameras, does not contain visual documentation of any acts of rape themselves.
