It was a term of the Henderson BSA that Ms Henderson and Henderson Media each agree to indemnify and keep indemnified CBC and ARN against all expenses, losses, liabilities, damages and costs (including but not limited to reasonable legal costs on a solicitor and own client basis, and whether incurred by or awarded against CBC or ARN, that are incurred by CBC or ARN) directly arising out of any uncured breach of the Henderson BSA.

2. Paragraphs 59(b) and 59(c)(i) of the Defence to the Statement of Claim are repeated.
3. By reason of Henderson Media and Ms Henderson's repudiation of the Henderson BSA, CBC has suffered loss and damage.

Particulars

1. CBC has suffered loss or damage in the form of lost advertising revenue, or lost profits.
2. Particulars of the quantum of loss will be provided after service of expert evidence.
4. In the premises, Henderson Media and Ms Henderson are jointly and severally liable for damages for breach of contract.
5. Further and alternatively, CBC, ARN, or both of them have incurred expenses, losses, liabilities, damages or costs directly arising out of the uncured breach of the Henderson BSA by Henderson Media and Ms Henderson.

Particulars

1. CBC, ARN, or both, have suffered loss or damage in the form of lost advertising revenue, or lost profits.
2. CBC, ARN, or both have incurred legal costs directly arising from the uncured breach.
3. Further particulars will be provided after the completion of interlocutory steps.
6. In the premises, each of Henderson Media and Ms Henderson is required to indemnify CBC and ARN in respect of the expenses, losses, liabilities, damages or costs alleged above.
7. The Court should declare that each of Henderson Media and Ms Henderson is liable to so indemnify CBC and ARN.
