Hi,

On Monday (2023-03-06) I emailed a complaint to the Federal Court of Australia addressed to the NSW Registry.

Yesterday I drove over 880km to attend the office of the AGD in Adelaide as I indicated that I would in that complaint. I was advised when I got there that they knew nothing about it. I am now concerned that you did not receive my complaint as I have received reply indicating receipt of my complaint, nor did I receive any notice that you would not participate or attend as requested.

Obviously, I am concerned that the Federal Court of Australia would demand respect from others and yet shows contempt and a complete disregard to common courtesy. I consider not even acknowledging receipt of my complaint and failing to inform the Adelaide office of the AGD a failure in judicial integrity, as you obviously continue to consider my concerns frivolous.

I don't consider my matter to be frivolous at all and I think it's time that you seriously consider the issues that I have raised. I have an absolute and irrefutable right to seek redress and I have an absolute right and expectation that the Federal Court of Australia to act professionally. Common courtesy costs nothing and is repaid in kind. If you cannot demonstrate it, then you cannot expect it in return.

This whole matter can be resolved without the necessity to incur any loss of face, because, this is

a constitutional crisis and a deliberate act of treason and I am not afraid to ask if the Federal Court of Australia is involved.

Have the common courtesy and decency to acknowledge receipt of my complaint, who it was passed and who is the contact person.

Restore my trust in the judiciary and the judicial process.
