Morning everyone,

Just got off a long call from David. Below is the detail he has sent through. There is lots here to work with.

Next Monday looks like the best day for us to meet with them both in Sydney as Angus will be back then. She is meeting up with Samantha Maiden on Thursday. Just confirming, Britt doesn't want this to break until March, which Sam knows and has agreed to.

For Monday, David is a little worried about too many people in our meeting as Britt is still pretty fragile, and while she is absolutely sure in her resolve that she wants to do this, she is still processing the reality of it all.

Because she is still employed in Michaelia Cash's office for the next few weeks, David said that she could make some excuse for taking half the day off, so rather than driving up, could we possibly fly them both up?

Let me know your thoughts.

Begin forwarded message:

Hi Lisa,

Thank you for your time over the phone today, and your sensitivity around what I truly feel is an injustice.

I'm sending this on behalf of Britt, purely because, and this sounds paranoid, we just don't know who might be keeping a close eye on her.

As discussed, we're happy for you to send this to your producer (and thank you for speaking to your EP for us).

Brittany really needs to be out of the Parliament House when both the story breaks, and the police report is relaunched. She's also happy to come to Sydney but doesn't want to be having these conversations in Canberra. I'm happy to pay for her flights etc.

In addition to this I've gone and looked up the ACT Policing crime stats for 2019 and there was one reported sexual assault during the time Britt's incident occurred, and there has been nothing since (see attached image).

You can always chat to me over the phone if you need more, and I can put Britt on.
