1. Until further order of the Court, all investigations, inquiries or other actions by the Second Respondent or the National Anti-Corruption Commission relating to the Applicant are stayed.
2. The Second Respondent, by himself or through officers, employees or agents of the National Anti-Corruption Commission is restrained from taking any step in any current or proposed investigation, proceeding or action concerning the Applicant until further order of the Court.
3. The Second Respondent, by himself or through officers, employees or agents of the National Anti-Corruption Commission is restrained from taking any action relating to the non-disclosure notation of 12 September 2024 and the confidentiality direction of 23 October 2024 as a result of filings, submissions, material or participation in these proceedings.
4. The Second Respondent is ordered to preserve all records, notes, data and transcripts concerning the raids on 5 June 2024, hearings of 22-23 October 2024 and any associated determinations made by the NACC, until final determination of this proceeding or further order.
5. Costs of this Application be in the cause.
6. Any other order the Court considers necessary.
