Details of claim

On the grounds stated in the statement of claim, the Applicants claim:

1. With respect to the alleged contravention of s 340 of the *Fair Work Act 2009* (Cth) (**FW Act**) by the First Respondent (**CBC**), the First Applicant (**Ms Henderson**) and the Second Applicant (**Henderson Media**) seek:
 - a. a declaration that CBC contravened section 340 of the FW Act;
 - b. an order pursuant to section 545 of the FW Act that CBC pay Ms Henderson and Henderson Media compensation for the loss and damage they have suffered by reason of CBC's contravention of section 340 of the FW Act;
 - c. an order pursuant to section 547 of the FW Act for interest on the amount determined in order 1(b);
 - d. an order pursuant to s 546 of the FW Act that CBC pay a pecuniary penalty as a consequence of its contravention of section 340 of the FW Act; and
 - e. an order pursuant to s 546(3) of the FW Act that the pecuniary penalties referred to in order 1(d) be paid to Ms Henderson.

2. With respect to the alleged breach of contract by CBC, Ms Henderson and Henderson Media seek:
 - a. a declaration that CBC repudiated the Broadcast Services Agreement dated 30 October 2023 (**Agreement**);
 - b. an order that CBC pay Ms Henderson and Henderson Media compensation for the loss and damage they have suffered by reason of CBC's repudiation of the Agreement; and
 - c. an order pursuant to section 51A of the *Federal Court of Australia Act 1976* (Cth) that CBC pay pre-judgment interest on the amount determined in order 2(b).

- 2A. With respect to the alleged breach of contract by the Second Respondent (**ARN**), Henderson Media seeks:
 - a. a declaration that ARN breached a Loan Share Agreement dated 30 October 2023 (**Loan Share Agreement**);
 - b. an order that ARN pay Henderson Media compensation for the loss and damage it has suffered by reason of ARN's breach of the Loan Share Agreement; and
 - c. an order pursuant to section 51A of the *Federal Court of Australia Act 1976* (Cth) that ARN pay pre-judgment interest on the amount determined in order 2A(b).



3. With respect to the alleged breach of section 18 of the Australian Consumer Law (Schedule 2 of the *Competition and Consumer Act 2010* (Cth)) by the ~~Second Respondent~~ (ARN), Ms Henderson and Henderson Media seek:
- a. a declaration that ARN contravened section 18 of the Australian Consumer Law;
 - b. an order pursuant to sections 236 and 237 of the Australian Consumer Law that ARN pay Ms Henderson and Henderson Media compensation for the loss and damage they have suffered by reason of ARN's contravention of section 18 of the Australian Consumer Law; and
 - c. an order pursuant to section 51A of the *Federal Court of Australia Act 1976* (Cth) pre-judgment interest on the amount determined in order 3(b).
4. Costs.
5. Any further or other order as the Court deems fit.
