- I, Bruce Gleeson, Registered Liquidator of Level 13, 189 Kent Street, Sydney New South Wales 2000, say on oath:
- 1. At the time of swearing this Affidavit, an Exhibit folder has been prepared on my behalf and I will refer to the documents in the Exhibit Folder as **EX BG**.
- 2. In this Affidavit and in my Affidavit sworn on 10 February 2022 (my confidential Affidavit), I refer to "Interested Parties" for the purpose of Order 6 of the Judgment delivered by the Honour Justice Markovic in these proceedings on 22 November 2021 (the Judgment).
- 3. Paragraph 6 of the Judgment provides that:

"Before taking possession of or realising any of the Receivership Property, the Receivers shall:

- (a) give notice to any interested party of their intention to do so and inform those parties in writing that they should:
  - (i) advise the Receivers within 15 business days if they object to the taking possession of or sale of any of the Receivership Property and specify the basis of their objection; and
  - (ii) provide documentary evidence in support of their objection; and
- (b) seek directions from the Court in relation to their intention to do so."

- The term "Interested Party" is defined in the Third Further Amended Originating Process filed on 24 November 2021 to include "Anthony Koletti, Adam Grimley and Edward and Barbara Grimley, National Australia Bank Limited as the mortgagee of the Real Property and the Investors identified by the Final Receivers from time to time".
- 5. Consistent with the Judgment, I considered and identified other parties that may be affected by a proposal to take possession of and/or realise Receivership Property. For the purposes of this Affidavit, the term "Interested Party" or "Interested Parties" includes the parties identified in paragraph 4 of this Affidavit and all other identified parties that I have determined may be affected by a proposal to take possession of and/or realise Receivership Property.
- I have carefully considered (and taken legal advice) as to who may be considered "Interested Parties" as having possible claims to any of the Receivership Property. To the best of my ability, I have arranged service upon all such Interested Parties. I have prepared an excel spreadsheet which appears at **EX BG-1**. The excel spreadsheet separates the Interested Parties into categories, for ease of reference, they are as follows:
  - (a) Out of Pocket Investors. This refers to Investors who had invested monies with Maliver Pty Limited (In Liquidation) (Maliver) or Melissa Louise Caddick (Ms Caddick) and were out of pocket in relation to their investment;
