THE COURT ORDERS THAT:

1. The Sex Discrimination Commissioner is granted leave to appear as *amicus curiae* in this proceeding pursuant to s 46PV of the *Australian Human Rights Commission Act 1986* (Cth) and rule 9.12 of the *Federal Court Rules 2011* (**Rules**), (in relation to the same topics on which leave was granted by the primary judge).
2. The respondent's application for an extension of time to file a cross-appeal is granted.

Application for Security for Costs and Costs Cap

3. By 4pm on 25 February 2025:
 - a. the respondent is to file and serve any application for security for costs with a supporting affidavit and submissions in support of the application; and
 - b. the appellants are to file and serve any further affidavit material and submissions in support of their application for a costs cap.

 - a. the respondent is to file and serve any material in response to the appellants' application for a costs cap; and



- b. the appellant is to file and serve any material in response to the application for security for costs.
5. By 4pm on 25 March 2025:
- a. the respondent is to file and serve any material in reply in relation to the application for security for costs; and
 - b. the appellants are to file and serve any material in reply in relation to the application for a cost cap.

Application by the Australian Christian Lobby to appear as amicus

- 6. By 4pm on 26 February 2025, the Australian Christian Lobby is to file and serve any further affidavit material and submissions in support of its application to appear as *amicus curiae* in this proceeding pursuant to rules 9.12 and 36.32 of the Rules.
- 7. By 4pm on 18 March 2025, the appellants and the respondent are to file and serve any material in response.
- 8. By 4pm on 25 March 2025, the Australian Christian Lobby is to file and serve any material in reply.

Interlocutory Hearing

- 9. The interlocutory applications referred to above are listed for hearing at 10.15am on 7 April 2025.
