(Aristocrat – Product Madness – Big Fish)

### OPT OUT NOTICE

Federal Court of Australia Proceeding No. VID1105/2023

#### WHY IS THIS NOTICE IMPORTANT?

A class action has been commenced in the Federal Court of Australia by Ms Nicole Preece against Aristocrat Leisure Ltd, Product Madness, Inc and Big Fish Games, Inc.

The Federal Court of Australia has ordered that this notice be published for the information of persons who might be members of the class on whose behalf the action is brought and may be affected by the action. You may be a group member in the “Social Casino Games Class Action”.

As explained below, you may do one of two (2) things in response to this notice:

1. **opt out** of this class action by **4.00pm** on **5 November 2025** (Melbourne time). If you opt out, you will not be bound by, be entitled to share in or be included in any order, judgment or settlement in the class action. If you opt out, you may still bring your own claim against Aristocrat Leisure Limited, Product Madness, Inc. and/or Big Fish Games, Inc.(together, the **Respondents**); or
2. **do nothing** and continue to be part of this class action. You will be bound by any settlement or judgment of the class action unless you opt out of the class action. **You should read this notice carefully. Any questions you have about the matters contained in this notice should NOT be directed to the Court or the Respondents. If there is anything in this notice that you do not understand, you should seek legal advice.**

#### A. SOME THINGS YOU SHOULD KNOW ABOUT THIS CLASS ACTION

##### *What is a class action?*

- 1) A class action is an action that is brought by one person (‘applicant’) on his or her own behalf and on behalf of a group of people (‘group members’) against another person/s or entity/ies (‘respondent’ or ‘respondents’) where the applicant and the group members have similar claims against the respondent.
- 2) Group members in a class action **are not** individually responsible for the legal costs associated with bringing the class action. In a class action, only the applicant is responsible for the costs.
- 3) Group members are ‘bound’ by the outcome in the class action, unless they have opted out of the proceeding. A binding result can happen in two ways being either a *judgment* following a trial, or a *settlement* at any time. If there is a judgment or a settlement of a class action, group members *will not* be able pursue the same claims and *may not* be able to pursue similar or related claims against the respondent/s in other legal proceedings. Group members should note that:



- a) in a *judgment* following trial, the Court will decide various factual and legal issues in respect of the claims made by the applicant and group members. Unless those decisions are successfully appealed, they bind the applicant, group members and the respondent/s. Importantly, if there are other proceedings between a group member and the respondent/s, it may be that neither of them will be permitted to raise arguments in that proceeding which are inconsistent with a factual or legal issue decided in the class action; and
  - b) in a *settlement* of a class action, where the settlement provides for compensation to group members it is likely to extinguish all rights to compensation which a group member might have against the respondent/s which arise in any way out of the events or transactions which are the subject-matter of the class action. In order for a *settlement* of a class action to be binding and have the effect set out above, it needs to be approved by the Court as fair and reasonable in the interest of group members.
- 4) If you consider that you have claims against a respondent which are based in your individual circumstances or otherwise additional to the claims described in the class action, then it is important that you seek independent legal advice about the potential binding effects of the class action **before** the deadline for opting out (see below).

***What is this class action about?***

- 5) This class action, the ‘Social Casino Games Class Action’, is brought by the Applicant, Ms Nicole Preece, on her own behalf and on behalf of all persons who are Group Members as defined in the Statement of Claim, against Aristocrat Leisure Limited, Product Madness, Inc. and Big Fish Games, Inc (together, the **Respondents**).
- 6) The Applicant alleges, among other things, that the Respondents have developed, marketed and distributed the **Apps** (described below at paragraph 10), and that the Respondents have:
- a) provided prohibited interactive gambling services to customers in Australia in breach of the Interactive Gambling Act 2001 (Cth); and
  - b) engaged in conduct that was in all the circumstances unconscionable within the meaning of section 21 of the Australian Consumer Law.
- 7) The Respondents deny the allegations made against them.

***What is ‘Opt Out’?***

- 8) The Applicant in a class action does not need to seek the consent of group members to commence a class action on their behalf or to identify a specific group member. However, group members can cease to be group members by opting out of the class action. An explanation of how group members are able to opt out is found below in the section headed ‘*Option 2 – Opt Out and cease to be part of this class action*’.

***What compensation is claimed***

- 9) By reason of the alleged conduct above, the class action seeks to recover as compensation the monies spent by persons who have played any of the Apps between 22 December 2017 and 12 December 2024 (inclusive) (**Relevant Period**) and who at the time of playing the Apps were physically present in Australia.



*The relevant Apps*

10) The Apps are as follows:

- a) Heart of Vegas;
- b) Cashman Casino;
- c) Big Fish Casino;
- d) Lightning Link Casino;
- e) Jackpot Magic Slots;
- f) Mighty Fu Casino (previously called Fafafa Gold); and
- g) Epic Diamond Slots (previously called Vegas Party Slots).

11) The solicitors running this class action are William Roberts Lawyers, and a company named LCM Funding Pty Ltd (**LCM**) is currently funding the class action by paying the lawyers and covering the Applicant's exposure to pay the Respondents' legal costs.

***Am I a Group Member?***

12) **You are a group member in this class action if you:**

- a) have played the games on the Apps (as described at paragraph 10) above) that are listed in any of Annexures 2 and 3 attached to this notice (collectively referred to as **Social Casino Games**) during the Relevant Period;
- b) have made purchases using real money while playing the Social Casino Games during the Relevant Period;
- c) were physically present in Australia at the time of the conduct referred to in (a) and (b) above; and
- d) you do not opt out of this class action as described below.

If you meet all of the above criteria, you are a group member in this class action.

13) If you are unsure whether or not you are a group member, you should contact William Roberts Lawyers by email to [WR-Aristocrat@williamroberts.com.au](mailto:WR-Aristocrat@williamroberts.com.au) or seek your own legal advice without delay.

***This notice is not a scam***

14) This notice is not a scam. You can get copies of the relevant documents about this class action either:

by downloading them from William Roberts Lawyers' website at <https://www.williamroberts.com.au/class-actions/aristocrat-social-casino-games-class-action/>; or

***Will you be liable for legal costs if you remain a group member?***



- 15) Group members are not, and **will not be, liable for any “out of pocket” legal costs** by remaining in this class action. The costs of running it are being borne in the first instance by LCM and William Roberts Lawyers and, subject to the approval of the Court, are to be deducted upon the resolution of the proceedings as set out in paragraphs 15) to 17) below.
- 16) If the class action is successful, in return for funding the class action, LCM charges funding fees to group members who have signed a funding agreement with LCM based on a percentage of the amount recovered in the class action. In the event any compensation becomes payable to you as a result of any order, judgment or settlement in the class action, the Applicant and/or LCM may seek an order from the Court that every group member who is entitled to receive compensation in the Social Casino Class Action pay a share of some of that compensation to:
- a) help pay the legal costs of William Roberts Lawyers which are incurred by the Applicant in running the class action but which are not able to be recovered from the Respondents; and
  - b) pay LCM a percentage of the amount of the compensation as a commission for funding the proceeding.

Such an order will not be made unless the Court is satisfied that it should be made. If such an order is sought, group members will be provided with further information and will have an opportunity to object to it should they wish to do so.

- 17) The total amounts deducted for legal costs and LCM’s commission from any compensation payable to group members will not exceed the amount group members may be entitled to in the event of a successful outcome.
- 18) If the class action is unsuccessful, or is not as successful as you might have wished, you will have no liability to pay any legal costs, funding fees or commissions. You will not be able to pursue the same claims and may not be able to pursue related claims against the Respondents in other legal proceedings.

## **B. YOUR TWO OPTIONS**

### ***Option 1 – Do nothing and continue to be part of this class action***

- 19) If you wish to remain a group member, there is nothing you need to do at the present time. The Applicant will continue to bring the case on your behalf up to the point where the Court determines those questions that are common to the claims of the Applicant and the group members. However, you are invited to contact the Applicant’s lawyers, William Roberts Lawyers, by the email referred to at paragraph 25) below and express your interest in the class action so that future notices about the class action can be sent to your preferred address.

### ***Option 2 – Opt Out and cease to be part of this class action***

- 20) If you do not wish to remain a group member you must opt out of the class action. If you opt out you will not be bound by or entitled to share in the benefit of any order, judgment or settlement in the class action, but you will be at liberty to bring your own claim against the Respondents, provided that you issue Court proceedings within the time limit applicable to your claim. If you wish to bring your own claim against the Respondents, you should seek your own legal advice about your claim and the applicable time limit **prior** to opting out.



21) If you wish to opt out of the class action, you will need to complete the "Opt out notice" at Annexure 1 to this notice and send it to the Registrar of the Federal Court of Australia at the address listed on the form. **IMPORTANT: the Notice must reach the Registrar by no later than 4:00pm (Melbourne time) on 5 November 2025**, otherwise it will not be effective.

22) You should submit the Opt out notice if:

- a) you qualify as a group member and you wish to opt out of the class action; or
- b) you believe that you have been incorrectly identified as a group member, because you do not meet the criteria set out in the section headed 'Am I a Group Member?' above.

23) Each group member seeking to opt out should fill out a separate form.
