- 1. I am a principal hydrogeologist in the Melbourne office of Jacobs Group (Australia) Pty Ltd.
- I have been engaged by Allen & Overy, the solicitors for the second to sixth Respondents in these
 proceedings, to provide an expert hydrogeology report. I prepared a report dated 4 March 2024.

- 3. In preparing that report, I relied on materials that were provided to me by Allen & Overy. I list those materials in Appendix C (page 25) of my report. I also relied on the materials that I list in section 12 (page 22) of my report.
- 4. In my report, I provided references to relevant sources in Appendix C or section 12, in the places where I relied upon that material.
- 5. I reviewed my report on 3 and 4 April 2024. Having done so, I provide the following specific references to materials listed in Appendix C and in section 12, by way of further clarification:

- (f) In paragraphs [32] and [51] of my report, I refer to a Figure 7-1. I reproduce Figure 7-1 at paragraph [50]. Figure 7-1 is a reproduction of a map titled "100_MP_OP_0198_001_r0.pdf", which is listed as document 15 in Appendix C of my report.
- (g) In paragraph [51], I have relied on the groundwater data, which is contained in the spreadsheet titled "Regional Groundwater Levels_rev1" which is listed as document 16 in Appendix C of my report.
