Launch of the PJSI

In June 2016 the Government of New Zealand's Ministry of Foreign Affairs and Trade selected the Federal Court of Australia as the Managing Services Contractor for the Pacific Judicial Strengthening Initiative (PJSI).

The PJSI will operate in 14 Pacific Island Countries which include the Cook Islands, Federated States of Micronesia, Kiribati, Marshall Islands, Nauru, Niue, Palau, Papua New Guinea, Samoa, Solomon Islands, Tokelau, Tonga, Tuvalu and Vanuatu.

Vision for the PJSI

PJSI's goal is *Building Fairer Societies*, and it will contribute to this goal by supporting partner courts to develop more accessible, just, efficient and responsive court services.

Following an intensive technical needs assessment and design process, five thematic pillars have been identified to guide implementation of the Initiative, namely:

- **Regional Leadership** building institutional capacity, systems, processes and tools at the regional level for stakeholders to proactively manage judicial development at the local level.
- Access to Justice improving the accessibility of court remedies, and enable right-holders to exercise their legal rights.
- **Professionalisation** building professional competence, and institutional capacity, to administer justice that is accessible, fair, efficient and timely.
- **Substantive Justice** improving the substantive fairness that is, the qualitative or 'thick' dimensions of justice service delivery; specifically in relation to human rights law generally, and gender and family violence specifically.
- **Procedural Justice** improving the efficient and timely delivery of court services.

Leadership Meetings - PNG: 7-10 September, 2016

The first PJSI Chief Justices' Leadership Forum and Initiative Executive Committee (IEC) meetings were held in Port Moresby, Papua New Guinea from 7-10 September, 2016. A key recommendation from the meetings was to pursue a "Certificate of Justice" qualification to be administered by a regional education provider.

The IEC also agreed to hold some future meetings remotely eliminating the need for members to travel and reducing the time away from judiciaries.

Upcoming Activities

Activities scheduled for the next six months are listed as follows:

- Piloting of Human Rights resource / toolkit -Solomon Islands: 6-17 February, 2017 - this activity aims to support Chief Justices' to develop an institutionalised approach to fostering human rights within the region's courts.
- Piloting of Gender and Family Violence resource / toolkit **Tonga, April 2017** this activity aims to explore ways in which courts can better meet the needs of victims of gender and family violence.
- Project Management and Evaluation Workshop -Vanuatu, 20-24 February 2017 - This workshop aims to strengthen participants' capacity to produce desired results through the delivery of projects.
- Monitoring and Evaluation assistance Samoa, 27 March-7 April, 2017
- 2nd Chief Justices' Leadership Forum & IEC meeting Samoa, 3-7 April, 2017

Leadership Incentive Fund

The Leadership Incentive Fund (LIF) was launched in October 2016. The LIF aims to support the achievement of national courts objectives not otherwise addressed by the PJSI. Five grants of up to AUD 10,000 per year and two grants of up to AUD 35,000 per year will be made available.
