2. I commenced working for the first applicant, Westpac Banking Corporation (**Westpac**), in 2002. Since that time I have held a variety of roles across various Westpac teams including Westpac's Business Lending Operations, Business and International Operations, Operations and Technology, Global Market Operations and Institutional Banking and Asia Operations Teams.
3. In November 2018, I transferred to Westpac Institutional Bank (**WIB**), a business division of Westpac which provides financial services to corporate and institutional customers. Between November 2018 and November 2020, I held the role of Head of Customer Lifecycle Management within WIB. Since November 2020, I have held the role of Head of Operations within WIB.

### **Payment processing and repayment**

4. As the Head of Operations within WIB, I oversee approximately 600 staff within the WIB Operations Team (**Operations Team**) who manage ingoing and outgoing payments for WIB's Asset Finance transactions. For ease, I refer to the WIB Asset Finance team, who negotiates and manages the transactions with WIB customers and/or third party introducers (the third party responsible for introducing the transaction opportunity to WIB (**Third Party Introducer**)), as the **Asset Finance Transaction Team**.
5. The Operations Team facilitated drawdown requests provided to it by the Asset Finance Transaction Team in relation to the Eqwe/Forum asset financing programme which involved the following parties:
  - (a) Forum Finance Pty Limited (**Forum**) as the asset provider; and
  - (b) Eqwe Pty Limited (formerly known as BHD Leasing Pty Limited and BHO Funding Pty Limited) (**Eqwe**) as the Third Party Introducer to Westpac, (known as the **Eqwe/Forum Programme**).
6. Based on my knowledge obtained from my role, I understand that the process of drawdowns and repayments in accordance with the Eqwe/Forum Programme was as follows:
  - (a) A member of the Asset Finance Transaction Team sent an email to a member of the Operations Team via [assetfinance@westpac.com.au](mailto:assetfinance@westpac.com.au) which:

- (i) requested that the Operations Team create a liability for the underlying customer;
  - (ii) attached a settlement pack including relevant documents such as:
    - (A) a Sale Notice;
    - (B) a Transfer of Rights and Title to the Payments and Goods Letter,
    - (C) a Pricing Sheet which is signed by two members of the Asset Finance Transaction Team;
    - (D) an underlying Customer Payment Agreement; and
    - (E) a New Customer Sheet,  
**(Settlement Pack)**, and
  - (iii) attached in some cases a separate pricing spreadsheet (in excel or PDF format) and / or a purchase of receivables spreadsheet (which was provided by the Third Party Introducer.
- (b) A member of the Operations Team reviewed the Settlement Pack and, where necessary, requested amendments or additional documents. For simplicity, in the below paragraphs I refer to the person who conducted the review of the transaction as the **Operations Officer**. In my experience of observing the staff in the Operations Team, a review of a Settlement Pack by an Operations Officer took approximately 30 minutes on average. In this review, the Operations Officer:
- (i) confirmed all the required documents had been provided by the Asset Finance Transaction Team (and communicated with that team if any documents or information were missing or incomplete);
  - (ii) validated the pricing quoted by the Asset Finance Transaction Team against the amount to be financed, the rental repayments and the invoice from the Third Party Introducer in the Lending Advisor system (a leasing front end system which contains customer details and generates quote pricing based on the rate, tenure and amount of an asset finance transaction) and the Lending Workflow system (which

- contains PPSR registration details and the InfoLease customer number and contract numbers) (**TLA/TLW**);
- (iii) reviewed InfoLease to confirm that the drawdown amount did not exceed the underlying customer's credit limit. InfoLease is a Westpac platform used by its leasing and asset management businesses. InfoLease offers a comprehensive solution for booking, billing and collection throughout the lifetime of the contracts; and
  - (iv) confirmed the transaction documents appeared to have been correctly executed by an authorised signatory or asked for confirmation from the Asset Finance Transaction Team for confirmation (an example of which is at page 19 of [WBC.5000.0001.0055](#)).
- (c) The Operations Officer confirmed that the documents appeared to have been correctly executed by an authorised signatory through:
- (i) reviewing the name of the person who purported to have signed the transaction document against a file containing signatories for each underlying customer provided by the Asset Finance Transaction Team; and
  - (ii) reviewing a company search in circumstances where a director of a company executed the transaction document.
- (d) Where the Settlement Pack was considered by the Operations Officer to contain sufficient information and be satisfactory to effect a drawdown, the Operations Officer:
- (i) validated the customer name, facility type, status of facility and credit limit in InfoLease;
  - (ii) completed the customer drawdown checklist (**Checklist**). When completing the Checklist, the Operations Officer:
    - (A) confirmed the drawdown amount did not exceed the existing approved credit limit for the underlying customer by entering the current credit limit of the customer, the current balance outstanding, the drawdown amount and the credit limit less the

current balancing outstanding and the drawdown into the Checklist;

- (B) entered the customer information and transaction details; and
- (C) indicated that they confirmed the documents were executed by authorised signatory/ies, the required documents were provided by the Asset Finance Transaction Team to them and that they had validated the quotes in TLA/TLW.

A copy of the Checklist is [WBC.5000.0012.0133](#);

- (iii) prepared the transaction in TLA/TLW (which interfaces with InfoLease to allow scheduled transactions to be viewed in InfoLease);
  - (iv) created a future payment in WIB's Corporate Online system based on the details within the Settlement Pack. The staff number of the Operations Officer was recorded on the Payment Detail Report under the heading "Additional Payment" as the "1st Authorisation." The system was set up so that it would not remit any funds before approval for the payment was entered by a supervisor (referred to as "2nd Authorisation"). A copy of an extract of WIB's control policy (Control ID CT000041582) which is the policy for how WIB payments are remitted is [WES.5000.0011.0268](#). A copy of Westpac's guide to preparing a new customer drawdown is [WBC.5000.0012.0134](#); and
  - (v) sent the Settlement Pack and Checklist to the supervisor for review via SharePoint. SharePoint is a document and workflow management system. Ching Hong Leong (also known as Sam Leong), Supervisor of the Asset Finance Operations Team, was the supervisor in each of the 100 transactions which occurred in the Eqwe/Forum Programme that I understand to be the subject of the proceedings. A table indexing the supervisor review package for each of the 100 transactions is annexed to this affidavit and marked "A."
- (e) The supervisor providing approval for the settlement in Sharepoint reviewed the Settlement Pack and Checklist to ensure that they were complete and contained sufficient information to effect a drawdown. If the supervisor considered that the Checklist did not comply with the requirements, the

supervisor rejected it and requested the Operations Officer to redo and resubmit the Checklist. If the Settlement Pack and Checklist were considered satisfactory, the supervisor approved the settlement in Sharepoint. The Operations Officer submitted the transaction in TLA/TLW to InfoLease and recorded that they did that in Sharepoint which then notified the supervisor it was ready for their review. The supervisor confirmed the transaction was entered correctly in InfoLease (as per the pricing sheet and Settlement Pack) and provided "2nd Authorisation" for the payment in the Corporate Online system and completed the Sharepoint for the settlement flow. To the extent that any Payment Detail Reports do not record having a "2nd Authorisation" this is a result of a new version of the report not being generated after the payment was processed. As outlined in paragraph 6(c), payments could not be processed without "2nd Authorisation."

- (f) The payment was remitted by Westpac to the bank account listed in the Sale Notice provided in the Settlement Pack through the Corporate Online system on the 'payment cut-off' date (the date listed within the pricing sheet or in an email instructions), provided the two levels of authorisation were obtained. A table indexing each remittance for the 100 transactions (which was generated by the Corporate Online IT team) is annexed to this affidavit and marked "B."
  - (g) Following the remittance of the drawdown, the Operations Team usually provided remittance confirmation to the Asset Finance Transaction Team.
  - (h) Repayments in satisfaction of the loan were paid into a Westpac bank account listed on the Transfer of Rights and Title to the Payments and Goods Letter (**Westpac Bank Account**).
  - (i) Westpac direct debited the Westpac Bank Account to collect the repayments owed.
7. By way of illustration of the process I have described in paragraph 6 above, on 6 October 2020 Lily Quach, who was then a Senior Associate in the Asset Finance Transaction Team, sent an email to [assetfinance@westpac.com.au](mailto:assetfinance@westpac.com.au) requesting that a drawdown be processed for HWL Ebsworth Lawyers. She attached a pricing sheet dated 7 October 2020, a Settlement Pack dated 7 October 2020 and a payment agreement dated 30 September 2020. A copy of this email is [WES.5000.0006.7192](#) and its attachments are [WES.5000.0006.7194](#), [WES.5000.0006.7195](#) and

[WES.5000.0006.7200](#). In this case, Meye Cohen, an Officer in the Operations Team, reviewed the Settlement Pack on behalf of the Operations Team. On 7 October 2020, Ms Cohen emailed Ms Quach to advise that the pricing sheet needed to be amended by 26 cents. Later that day, Ms Quach replied attaching an amended Settlement Pack. A copy of this email chain is [WES.5000.0006.7260](#) and the updated Settlement Pack attached to Ms Quach's last email is [WES.5000.0006.7263](#). Following this, Ms Cohen emailed Ms Quach again on 7 October to advise that the transaction was settled. A copy of this email is [WES.5000.0006.7269](#).

8. At the time of the transactions the subject of these proceedings, the email address [assetfinance@westpac.com.au](mailto:assetfinance@westpac.com.au) was monitored by (and able to be accessed by) multiple people within the Operations Team to ensure that asset finance transactions were promptly reviewed and actioned by a nominated member of the Operations Team who had the capacity to process the transaction for the Operations Team.
9. The Operations Team is not responsible for registering or monitoring the registration of security interests or performing due diligence on assets. However, once a month, the Operations Team would review the Westpac Bank Account to confirm that the necessary monthly repayments were being made.


