Northern Territory Stolen Wages Class Action Settlement

Up to \$202 million for the Northern Territory Stolen Wages Class Action





Some important things you should know:

- The Northern Territory Stolen Wages Class Action was brought against the Commonwealth Government on behalf of all Aboriginal and Torres Strait Islander people (including people who have died) who worked in the Northern Territory between 1933 and 1971 and were paid little or no wages.
- The class action has settled, but the Federal Court has to approve the settlement before compensation can be paid to eligible people.
- If you are an Aboriginal or Torres Strait Islander person who worked between 1933 and 1971 in the Northern Territory you may be eligible to receive a payment from the settlement, but **YOU MUST REGISTER BY 31 August 2025** with Shine Lawyers.
- You can also register for your spouse (married or de facto) and/or your parents, if they worked during that time for little or no wages and have passed away.
- To register you must fill in a Registration Form, either on paper, online or by calling Shine Lawyers.
- Shine Lawyers will be travelling throughout the Northern Territory over the next **11 months** to hold information meetings and help people register.
- If you have already spoken to Shine Lawyers to register your claim, you should get a text or call from them for more information so that you can get compensation.
- The Court hearing to decide whether the settlement should be approved is going to be held on **7 November 2024**, in **Alice Springs**. If you don't agree with the settlement you should tell the Court, and you should contact Shine Lawyers to find out how.



1 What is the settlement?

The Commonwealth Government has agreed to pay up to \$202 million including costs to settle the Northern Territory Stolen Wages Class Action.

The Commonwealth Government has agreed to pay into a settlement fund \$18,000 for each eligible claimant up to a maximum of \$180 million.

This does not mean each person who registers will get \$18,000. The Court will work out how much eligible claimants will get paid from the settlement, according to what it thinks is fair and reasonable.

The Commonwealth Government has also agreed to pay some separate amounts:

- (a) up to \$15 million as a contribution to legal costs;
- (b) up to \$6 million as a contribution to the costs of the independent administrator (who will be in charge of assessing eligibility and paying people);
- (c) up to \$1 million as a contribution to the costs of a costs assessor (who will make sure the legal costs and costs of the administrator are reasonable).

The settlement is a compromise with the Commonwealth Government to avoid the risk that the applicant and group members could lose the case if it went to hearing and get nothing.

The settlement agreement will not take effect unless it is approved by the Federal Court. If it is approved then group members will receive a share of the amount paid by the Commonwealth Government, **only if they register** using the registration form and have eligible claims.

2 Who can get compensation money?

You can register for compensation money if:

- A. you are an Aboriginal or Torres Strait Islander person;
- B. you were born before to 12 November 1961; and
- C. you worked in the Northern Territory between 1 June 1933 and 12 November 1971 for little or no wages;

OR

D. you are the spouse or the child of a deceased person who fits the description above.

As long as they **register** and provide the necessary information, every living person who fits the description in A, B and C above will be eligible to receive a payment from the settlement.

Spouses who register and provide the necessary information will be eligible to receive the payment their deceased spouse would have received. When we say "spouse" we mean husbands, wives and partners of the deceased person – whether legally married, traditionally married, or de facto.

Children can register for one or both deceased parents who fit the description in A, B and C above. If no living spouse is eligible, children who register and provide the necessary information will be eligible to receive the payment that the deceased parent would have received. If more than one child registers, all registered eligible children will share the payment that their deceased parent would have been entitled to.

If you are eligible **and** your deceased spouse or parent would also have been eligible, you should register for both your own claim and theirs.

3 How do you register?

If you think you are eligible to make a claim in the class action, you should complete the **Registration Form**. You can do this by:

- (a) completing the hardcopy Registration Form that comes with this Notice and sending it back to Shine Lawyers:
- (b) completing the Registration Form on the Shine Lawyers website; or
- (c) calling Shine Lawyers to complete the registration form over the phone.

You must complete, sign and send the Registration Form to Shine Lawyers before the deadline of 31 August 2025. If you haven't registered already, or haven't registered for your deceased spouse or parents, you should complete and send a registration form in before 31 August 2025.

If you have already spoken to Shine Lawyers to register your claim, you should get a text or call from them for more information so that you can get compensation.

If you aren't sure if you have registered, please contact Shine Lawyers.

As part of the **Registration Form**, some information and ID documents need to be provided so that claims can be checked by the Independent Administrator. Shine Lawyers will be available to help you register claims on your own behalf, or on behalf of your deceased parents or spouse (married or de facto).



4 How much will eligible claimants receive

The Court will work out how much eligible claimants get paid from the settlement, according to what it thinks is fair and reasonable. The Court might approve more money to go some people (for example, older people who worked for a longer time in the claim period for little or no wages).

Although we are not sure, we hope that at least \$10,000 will end up being paid to each Aboriginal or Torres Strait Islander person who worked in the Northern Territory between 1 June 1933 and 12 November 1971 for little or no wages (or to their surviving spouse or shared between their surviving children).

The Court will also be asked to check and say yes to the amounts of money that might be paid to other people for the costs and expenses of bringing the class action. These costs and expenses will be paid before payments are made to eligible claimants, but will only be deducted if the Court says they are fair and reasonable:

- (1) First, a litigation funder called "Litigation Lending Services" or "LLS" paid for a lot of the legal costs and carried other financial risks of bringing the class action. The Court will be asked to approve a commission payment to the funder of 20% of the amount the Commonwealth pays under the settlement. That means that if the Commonwealth pays the maximum settlement payment of \$202 million, then the 20% commission payment would be \$40.4 million. In addition to its commission, LLS will also be seeking payment of \$1,045,000 for the cost of insurance. If the Court is satisfied that such deductions are fair and reasonable, they will be deducted from the settlement fund.
- (2) Second, the legal costs which were spent in bringing the case. A lot of that amount will come from the separate amount of \$15 million that the Commonwealth Government has agreed to pay for legal costs, but this will not cover all the legal costs of bringing the case, doing the registration process and asking the Court to approve the settlement. The total amount is not yet known. The Court will appoint an independent person to assess the Applicant's reasonable costs and report to the Court. The Court will only allow a deduction of the costs it considers fair and reasonable.
- (3) Third, extra payments to the lead applicant and the five sample group members for the time they spent running the case on behalf of everyone else. Those payments are proposed to be \$70,000 in total. If the Court is satisfied that such a deduction is fair and reasonable, it will be deducted from the settlement fund.
- (4) Fourth, the cost of the independent person who administers the settlement fund (this cost is presently not known as quotes have to be obtained). It is expected that this cost will be partly covered from interest earned on the settlement and the balance from the payment of up to \$6 million for these costs by the Commonwealth. If the Court is satisfied that such a deduction is fair and reasonable, it will be deducted from the settlement fund.
- (5) Fifth, the cost of the independent person who will assess and report to the Court on the reasonableness of any legal costs and administrator costs that are deducted from the settlement fund. It is expected that this cost will be covered by the payment of up to \$1 million for these costs by the Commonwealth.

If you register, you will be told if you are eligible or not. If you are eligible, you will only get told exactly how much you will receive for your claim, or your deceased spouse or parent's claim, when it has been worked out following the Court approval hearing, and the checks that the independent administrator has to do before it pays anyone.

5 When will people get paid?

If the settlement is approved, the Court will try to make sure that payments are made as quickly as possible. It is expected that older people who worked in the Northern Territory in the period and are still living will get paid first.

Your claim will be checked by the independent administrator of the settlement. The independent administrator may contact you if they need more information to confirm that you are eligible.

6 Legal effect of the settlement

If the settlement is approved by the Court then it will be 'binding' on everyone who fits the definition of a 'group member' even if a person does not register. Being 'bound' means that you will not be able to bring your own case for the same or similar or related issues against the Commonwealth Government (including its officers), and your legal rights are replaced by the rights given to you under the settlement.

If the Court approves the settlement but you do not **register** your own claim or a claim for your parents who have died or a spouse (married or defacto) who has died, those rights will be lost, and you will receive no money.

7 What if you don't agree with the settlement?

People who are part of the class action have the right to tell the Court that they do not agree with and do not want the Court to approve the settlement (or parts of it). This is called "objecting" to the settlement.

If you want to object to the settlement, you need to ask Shine Lawyers for an objection form, using the details at the bottom of this notice. You then need to return that form to Shine Lawyers or the Victorian Federal Court Registry before **7 November 2024.**

If you object to the settlement, you should fill out the registration form anyway. That way, if the Court ends up approving the settlement, you will still be able to receive compensation money if you are eligible – even if you have objected.

If you want to attend the Court hearing to decide whether the settlement should be approved, you should speak to Shine Lawyers (using the contact details below) and they will give you information on how you can attend.






