- I am the Non-Executive Chair and a director of the applicant, Sunstone Metals Ltd ACN 123 184 412 (Sunstone). I have been a director of Sunstone since 1 April 2014 and from that time until 11 September 2024, I was the Managing Director and CEO of Sunstone. Hence, I was Managing Director and CEO of Sunstone through the relevant period.
- I was responsible for hiring Mr Gavin Leicht, the former Company Secretary of Sunstone, who was appointed to and held that role between 28 April 2015 and 30 June 2024.
- 3. In that role, Mr Leicht was responsible (as Mr Lucas Welsh is now as the present Company Secretary) for ensuring that Sunstone complied with its disclosure obligations under the Corporations Act 2001 (Cth) (Corporations Act) and under the ASX listing rules. He (like Mr Welsh is now) was also responsible for ensuring compliance with reporting to ASIC and the lodgement of financial and other regulatory documents mandated by law.
- 4. During his tenure, I do not recall Mr Leicht ever raising with me or the Board a concern or issue or point of uncertainty in relation to Sunstone's disclosure obligations or any failure of Sunstone to comply with its statutory or regulatory obligations. I recall his reporting indicating, and my understanding being, that at all times proper compliance was being achieved, and I recall cleansing notices being issued along with multiple placements and other share issues to properly meet Sunstone's disclosure obligations. Sunstone makes frequent announcements and disclosures to market. I had no reason to believe that cleansing notices were not being issued on all occasions when they were required.
- 5. I have, of course, now been made aware by Mr Welsh of certain shortcomings he has discovered in relation to compliance by Sunstone with its disclosure obligations. I fully support and endorse the steps now being taken to ask the Court to regularise any potential irregularity in relation to recent and historical share issues by Sunstone. I also fully support and endorse the new disclosure compliance protocols and checklists Mr Welsh will be developing, as well as the retainer of Thomson Geer Lawyers as an extra layer of oversight of each share issue for the next 12 months, so that we can ensure all aspects of the disclosure and other requirements for compliance are properly understood and can ensure the effective implementation of the new procedures.
