Te reirei aio are waaki inanon 5 te bong e bon kaeaki irouia teningaun ma ruaman Taan Moti ao Kiraaka n te kabowi iaon Tarawa Teinainano ao abamakoro ake I tinanikun Tarawa. Te reirei e kairaki iroun te tia Moti n te Bowi ae Rietata ae Justice David Lambourne n onea mwiin te tia Moti ae Rietata I Kiribati ae Justice Sir John Muria n raonaki ma taan Moti ao taan angareirei n irekereke ma te Tua n aban Tinaniku n aron Nutiran ao Aotiteria.

E boboto te reirei aio iaon karikirakean ao kanakoraoan ana mwakuri te tia Moti ma te Kiraaka ni karaoan tabeia aika a kakaokoro ibukin kaotinakoan te Eti ao te Riai iaon Kiribati ni kabutaa. Tibwanga aika a kakawaki a boboto naba iaon karaoan te kabowi ae eti man aki tabe itera inanon waakinan tain te kabowi, aroaro ma anua aika riai, aron waakinan ongoraeen te kabowi ni kaburebure ao kakeru n te mwenga ma mwakuri n tangako.

## **Kiribati Courts Conducts Training for Magistrates**

The Kiribati High Court is conducting an Orientation Course for Lay Magistrates in Betio, Tarawa, between 21-25 January 2019.

This intensive 5-day workshop is attended by thirty-nine lay Magistrates and court clerks from South Tarawa and the outer islands. Prior to the workshop, faculty members attended a Training-of-Trainer (ToT) course. This training is being lead by Justice David Lambourne of the High Court on behalf of the Chief Justice Sir John Muria together with local Magistrates and judicial trainers from across the region including New Zealand and Australia.

The aim of this workshop is to promote the competence of lay magistrates and court clerks to perform their judicial duties, to build the capacity of local trainers to conduct ongoing judicial training, and to promote excellence in the delivery of justice across Kiribati. Important topics include fair trial and due process, judicial ethics, conducting criminal and civil hearings, decision-making, and family and sexual violence.

This workshop is one of many workshops conducted by the Pacific Judicial Strengthening Initiative across the Pacific. This initiative is funded by New Zealand Ministry of Foreign Affairs and Trade and managed by the Federal Court of Australia which has supported promoting the rule of law across the Pacific over recent years.
