161. Person 12, a commander of the NDS, was not with us during that mission. I did not observe Person 12 in Darwan at all. I had previously been informed on or about 31 July 2012 at a command group meeting that Person 12 had been stood down and replaced as Commander of the NDS soldiers after he shot a mongrel dog and shrapnel wounded an Australian Patrol Commander.

168. I did not see Person 12 nor do I recall seeing the interpreter Person 13 during the mission. They were not ever in my presence and I did not have any conversation with them during the mission. As noted above, Person 12 was not present as it was my understanding that Person 12 had been stood down well before this time. As I did not have any NDS soldiers in my patrol, I had no need for an interpreter.
