I, Nader El Sayed, of

Western Australia, Chief Executive

Officer, affirm as follows:

- I am the Chief Executive Officer of Jaytona Pty Ltd t/a Multiplant Holdings (Jaytona), which is an engineering and construction business. I have occupied this role since September 2012.
- I hold a Bachelor of Commerce (major in Banking and Finance) and Master of Accounting from the Curtin University of Technology and a Graduate Diploma with the Australian Institute of Chartered Accountants.
- The contents of this affidavit are true to my knowledge, unless otherwise stated, in which
 case they are true to the best of my information and belief and the source of my
 information and belief is stated.

- 4. Exhibited to this affidavit and marked Exhibit NES-1 is a bundle of documents separated by numbered tabs. In this affidavit, unless otherwise indicated, a reference to a tab number is a reference to the corresponding numbered tab of Exhibit NES-1. Where I refer to a page number of a document, I refer to the paginated number of Exhibit NES-1.
- 5. In addition to my regular role with Jaytona, I am also involved in a number of other companies with my business partner, Mr Jaysen Taylor (Jaysen), which are relevant to this application, being 365 Plant Hire Pty Ltd and Nameo Pty Ltd. At tab 1 is a true copy of the company extracts of those companies and Jaytona.

PURPOSE OF THIS AFFIDAVIT

- 6. This affidavit is affirmed by me in support of:
 - (a) an originating process to be filed by the plaintiffs to this action (OP); and
 - (b) an interlocutory process to further be filed by the plaintiffs to this action (IP).
- 7. This application is made on an urgent basis, in the absence of the defendant, Mr Christopher Brown (Chris), and without notice to him. This is because I am extremely concerned that Chris, being a person who may be in possession of a substantial sum of money (in excess of \$300m) in circumstances where he owes a similarly substantial sum to other people (including myself):
 - (a) has misrepresented the amount and status of the money held in his accounts;
 - (b) may dissipate assets, which would otherwise be available to me and other persons that he holds money on behalf of (**Creditors**); and
 - (c) is incapable of managing those assets for the benefit of the Creditors.
- 8. As a result, the relief sought in the IP (and the OP) includes:
 - (a) asset preservation orders; and
 - (b) orders for the appointment of a receiver and manager to the property of the defendant.

SUMMARY OF RELATIONSHIP WITH CHRIS AND CONCERNS

9. My relationship with Chris is based on an investment arrangement whereby I, and others, have advanced money to him to pursue a strategy related to betting, primarily on horse racing through online betting agencies, in a way that takes advantage of naturally occurring arbitrage positions (buy and sell value discrepancies) in the relevant markets to create what I understand to be a risk free position.

10. Through pursuing that strategy I have advanced \$ through Nameo to Chris, and me and my business partner, Jaysen, have further advanced approximately \$

through Jaytona and 365 Plant Hire to Brown. The basis on which that money has been advanced is that we will be distributed a portion of the profits from those investments, as well as return of the principal sum. Chris will keep a portion for himself.

- 11. From regular updates provided by Chris to Jaysen and me, since the beginning of our involvement in this investment in October 2018, I am aware that Chris owes Nameo the sum of at least \$34,379,518 and Jaytona the sum of at least \$1,663,730. Chris has acknowledged those debts as owing but, after repeated request, he has not provided any return of money to me, Jaytona or the other companies.
- 12. I believe that Chris has consistently misrepresented to me the status of the funds held in his bank accounts, including in relation to whether those funds are able to be released and where they are held, if it all. During the course of our relationship, I have reason to believe, as set out below, that Chris has impersonated people in positions of authority, including the Managing Partner of a law firm (and that he has provided false emails claiming to be from banking institutions and more recently AUSTRAC.
- 13. As of Thursday 11 March 2021, I have developed reason to believe that an amount of approximately \$172m, which I understand Chris has certified in a Federal Court affidavit as being held in his account, may not actually exist in that account at all.
- 14. In view of this, and the information outlined below, I have serious concerns as to what money Chris holds in his bank accounts, which includes the sum of at least \$34,379,518 owed to Nameo. I also have serious concerns that, having recently been alerted to the fact that the sum of \$172m may not exist in the relevant account, Chris may have sought, or may be seeking, to dissipate those funds or transfer them to a location that I may not be able to follow.

INTRODUCTION TO CHRIS AND INVESTMENT METHODLOGY

- 15. I was introduced to Chris in October 2018 through Jaysen who explained to me that he had become aware of an investment opportunity with Chris.
- 16. Chris was someone who was familiar to me as I had known his father, Gavin Brown, for about 12 months at the time. I knew him and his wife, Toni, from a trip I had taken to Melbourne where I spent time with them.
- 17. In around October 2018, Jaysen brought Chris along to a meeting at Atomic Café in South Perth. I recall it was around this time, as it was not long before the Victorian Racing Derby, which was on 4 November of that year. Jason, Chris and I were present at the meeting.

- 18. Chris explained to us the background of his education and what he had been doing professionally. Chris told us that he had a commerce degree. I cannot recall if he mentioned that he had other degrees, but Chris struck me as very intelligent.
- 19. Chris explained that he had been working in the resource sector as an analyst. At this point he went on to explain his interest in trading in gambling platforms, specifically in relation to horse races, which I observed that he had a very good understanding of.
- 20. Chris explained to me that he had met a lot of people with interests in horse racing and that he had a good line of sight over what horses would run well. He explained that he would get information, for example, from contacts as to whether or not a horse would be scratched leading up to a race (which would impact the odds on the remaining horses). I observed that Chris had excellent knowledge of historical and recent races. He could recite previous winners and losers and explain why they won and why they did not. It was clear to me that he knew what he was talking about.
- 21. Chris told me he had been investing in horse racing for a period of time. He also referred to his activities as investing rather than gambling.
- 22. At that meeting, Chris explained to Jaysen and me the strategy behind his investment proposal. From that meeting I left with a clear understanding of what Chris was doing. In summary the position that I understood was as follows:
 - (a) Chris' investment strategy was focused on online gambling platforms (for example, Betfair, Sportsbet, Bet365 and other similar platforms).
 - (b) Chris would monitor the betting market, particularly in relation to horse racing, and would place bets at an early point in time so as to gain the most favourable (or longest) odds available. For example, a bet could be laid on a horse one month prior to the race and at that time the odds were much higher (for example odds of 10 to 1).
 - (c) Having put down bets, as the time period grew closer to the relevant race, Chris would then use the opportunities available through Betfair to act at the same time as a bookmaker. That is, Betfair has a platform where an individual can offer odds on a race to other punters, as though that person was a bookmaker (selling bets).
 - (d) As the bets offered by Chris to other punters were offered closer in time to the race, those odds would be significantly shorter than the odds he had placed bets on for himself (for example, instead of offering bets to punters at the price of 10 to 1 that Chris had obtained, he would offer odds to punters at 3 to 1).
 - (e) While this is a simplistic summary, in effect, through carrying out the above, Chris explained to me that he could ensure that, irrespective of the outcome of the race, he would make a profit. This is what I understood as taking an arbitrage position that

is, buying and selling the same product in different markets to take advantage of differing prices.

- 23. Chris explained to me that, as a result of the above, there was no risk in terms of losing money. He did not give me a guaranteed rate of return, as the amount won would depend on liquidity in the gambling market and other factors, but I understood that it was a no risk position.
- 24. At the time of the meeting, I was not familiar with Betfair, but I went away and googled hedging and betting strategies in Betfair. I was convinced by my independent assessment that Chris had a clear strategy and that it was akin to investing rather than gambling. I also observed from my background in accounting and my general understanding of mathematics and investment strategies that Chris' strategy was supported by the underlying principles that he explained.
- 25. From the meeting with Chris I obtained the impression that the funds invested would be returned to me, together with a return on profit, in a short period of time. Jaysen and I further discussed with Chris at the meeting that the profits from the investment would be split 50:50. That is, 50% to Chris and the other 50% to Jaysen and Nameo equally.
- 26. Not long after the meeting, Chris sent me a power point presentation with a case study on his strategy. At tab 2 is a true copy of an email dated 23 October 2018 from Chris to me with a copy of that presentation titled "Trading Case Study Winx Cox Plate 2018".

INITIAL MONEY ADVANCED AND REPORTS

- 28. On 29 October 2018, after Jaysen and I had made our first advance of \$ ______ Chris sent me a further email with the subject line "forward planning". At **tab 3** is a true copy of that email together with a spreadsheet titled "*Program-Derby Week CBJTNES*", which I understood outlined Chris' investment strategy for the upcoming races at Flemington in Victoria. This is the first email that I recall receiving from Chris specifically in relation to the above arrangement.

- 29. At the time of receiving this email, Jaysen and I observed that our first advance of \$\$\$ to Chris had produced a positive return. Jaysen and I then advanced further moneys to Chris to continue to participate. I understood that our initial capital would be returned following this further investment. I was happy to participate because I saw the profits being generated from the result that came in from the races and the betting strategy that Chris would advise of prior to those races occurring.
- 30. I was also happy, on occasion, to roll the profits from a previous investment into a subsequent investment. Where those profits were accumulating, I understood that I would get the principal of my investment back.
- 31. **Tab 4** is a true copy of an excel spreadsheet titled "JTNES Program 0203221" that Chris initially prepared as a record of our investments and the return generated. Chris initially sent this spreadsheet to Jaysen and I, but as time went on Jaysen began to maintain this spreadsheet based on bets that Chris advised would be placed, and then by monitoring their results. This spreadsheet is current as at the end of February 2021.
- 32. In relation to this spreadsheet I note the following:
 - (a) Tab "JTNES" of this spreadsheet represents the investment strategy adopted and the amount of the bets placed for Jaytona.
 - (b) Tab "Nader personal" of this spreadsheet represents the investment strategy adopted and the amount of the bets placed for Nameo directly.
 - (c) Column B "Event" in tab "JTNES" represents the horse that the investment was placed on.
 - (d) Column E "Return" in tab "JTNES" represents the rate of return that was obtained on the investment for us (i.e. the rate of return on our 50% share in the winnings).
 - (e) Column F "Result" in tab "JTNES" represents the total proceeds obtained from the investment on that horse.
 - (f) In relation to columns C and D in tab "JTNES", they represent amounts invested by us and also amounts rolled over from one investment to the next. I observe that there are some inconsistencies in this spreadsheet, and so a generalisation as to what these columns represents is difficult. I am able to provide a further explanation of this if required.

MONEY ADVANCED TO CHRIS & PROFITS GENERATED

33. From a review of the spreadsheet attached at tab 4 of this affidavit, I observe the following:

Many

- (a) It records, at Column F Row 154 in tab "JTNES", \$ as having been advanced in total through Jaytona and 365 Plant Hire. I confirm this amount is accurate to the best of my knowledge and belief.
- (b) It further records, through the total amount in column E rows 4 to 12 in tab "Nader personal", that there was an additional \$ advanced from Nameo. I further confirm this amount is accurate to the best of my knowledge and belief.
- (c) The amount of return on the investment by Jaysen and I together is outlined at row 152 column F in tab "JTNES", in the amount of \$50,521,035. Once the initial investment of \$ is taken into account the profit total, Row 159 column F in tab "JTNES" is displayed as \$48,249,035 of which Nameo's half share profit entitlement is recorded at \$24,124,518. I further confirm this amount is accurate to the best of my knowledge and belief.

REQUESTS FOR RETURN OF MONEY & EXPLANATIONS PR'OVIDED

Initial requests and advise re release of funds

- 34. From as early as November 2018, Jaysen and I have both made a number of requests to Chris for return of our funds invested, together with the profits that we have been informed have been made and which have been reflected in documents provided to us.
- 35. After a number of verbal requests, I received an email from Chris on 16 November 2018. At **tab 5** is a true copy of that email together with a screenshot of what I understood to be a bank transfer of \$427,655.00 to Jaysen's account. In relation to that screenshot I understood that, given the email originated from Chris, the account details described as "pay from" were Chris' account details.
- 36. I recall waiting for that sum to settle in Jaysen's account (being the pay to account), however I was informed by Jaysen, and I believe, that nothing was received.
- 37. I also recall that I did not think too much of the money not being received. I thought that with large transfers sometimes things take time or banks encounter issues with authorisation.
- 38. On 27 November 2018, I then received another email from Chris addressed to Jaysen and me with the subject "current state + payment reports via NAB". At **tab 6** is a true copy of that email with its attachments. I note from those attachments that they also contain two payment detail reports (one for the previous transfer of \$427,655.00 and another for \$267,000.00), together with a copy of our running investment balance (being the document attached at tab 4 above as it was at that time). Despite having received this email I am informed by Jaysen, and I believe, that these funds were never received in his account.

- 39. At the time of receiving these emails I was preoccupied with work matters and working remotely (in the north of Western Australia) and so did not give these issues too much thought.
- 40. I recall that I was further informed by Jaysen, and I verily believe, that he was dealing directly with Chris at the time in trying to obtain access to our funds.
- 41. In around late December 2018, after I returned from up north, I informed Jaysen that I was getting concerned and impatient with regards to the access to our funds.

Meeting with Chris & Representation

- 42. In early January 2019 I then arranged a meeting with Chris and his father (Gavin), and one of my business associates (Alex Hewlett) at a coffee shop in Bullcreek. The purpose of that meeting was to request an understanding as to why no money had been returned to Jaysen's account. I observed at that meeting that Chris was shaking when I was talking to him and he was unwilling to make eye contact. Chris told me he did not want to talk in front of his father.
- 43. I recall that Gavin and Alex then left the table and I spoke privately with Chris. Chris showed me emails from (of shown a specific email which appeared to be from and which contained details concerning potential Anti Money Laundering (AML) compliance issues that Chris was having with his bank accounts. This was the first time that Chris had explained to me that he had potential financial issues, or issues with access to his funds.
- 44. After that meeting I formed the view that Chris had a reasonable explanation for not being able to release the funds owing to me and others. I also gained some comfort in knowing that a law firm was dealing with the matter.

Further representation regarding release of funds & closure of NAB account

- 45. Following this meeting Chris was providing continuous updates verbally to Jaysen and I as to the status of his accounts and our funds.
- 46. In early February 2019, I was then informed by Chris that NAB were going to close his account. Chris provided me with an email from NAB advising that they were going to pay the money into his Westpac account. At tab 7 is an apparent email from NAB to Chris dated 8 February 2019 together with a payment details report for \$6,183,171.63 to Chris' Westpac account.
- 47. On 20 February 2019 I then received an email from Chris regarding the transfer of \$6,408,171.63 to his Westpac account as part of the account closure. At the time of receiving that email I believed it to be an email from NAB and saw it as explanation as to

- why Chris had not earlier received that similar sum of money in his Westpac account. At tab 8 is a true copy of that email.
- 48. At that point, I was happy that Chris appeared to be moving to Westpac. Jaysen and I were Westpac customers and, through our business operations, I had a banking manager at Westpac who I believed could assist in showing that we were trusted sources and so there would be less issue in Chris transferring funds to us if he was encountering general AML compliance issues. It did not surprise me at the time that Chris would have been encountering such issues. While I have never suspected Chris of money laundering, I was not surprised that large transactions of money would raise red flags, especially in light of the fact that monies were being deposited from betting agencies.
- 49. On 13 and 15 March 2019 I then received further emails forwarded from Chris, which appeared to forward emails from . At **tab 9** is a true copy of those emails, which concern the release of funds that were apparently being transferred to Chris' Westpac account. Those emails, being purportedly from again gave me some assurance that issues with the funds were being progressed.

Further meetings and discovery of

- 50. At around that time, in March 2019, Jaysen and I organised a further meeting with Chris as we were concerned that nothing was happening. We still had not seen any funds. I told Chris we wanted to speak with Nathan.
- 51. Around Anzac Day 2019 Jaysen, myself, Chris and Mr Adam Wilson (who is a supplier and friend of Jaysen and mine) were in Melbourne to watch a football match. I am an Essendon supporter and I recall they were playing.
- 52. A few months later, in around June 2019, I had a meeting with Adam and a business partner of his (Kade Lang) at the Windsor Hotel in South Perth.
- 53. At that meeting, Adam told me that he had invested with Chris but had not received any funds back from his investment. I informed Adam that Chris was having issues with access to his funds but that was managing it. We subsequently arranged a meeting with
- At that meeting (on 17 May 2019) informed me that he did not act for Chris, but that he knew Chris from informed me, and I believe, that he was not the author of the emails that Chris sent me. I am informed by and I believe that he subsequently lodged a formal complaint that Chris was pretending to be him in those emails.

M

- 55. This process of being informed that we would receive money, but then the money never coming, has then continued over approximately the next two years. During that period of time I have received a number of statements from bank accounts showing significant balances of money in Chris' accounts, but I am consistently informed by Chris that he is having issues with his accounts being frozen.
- 56. Chris has explained to me that that were a lot of people going into the bank branches to ask about his accounts, including to impersonate him. As the bank saw money from betting agencies, they were concerned there were illegal activities and as such the bank did not release his funds. At **tab 10** is a true copy of an email from Chris to an email address described as Scam Assist at Westpac, together with an attachment described as a "sheet for the tracking of funds and below parties that are creditors".

Preparation of Loan Agreement & Further Bank Account Representations

Loan Agreement

- 57. In July 2019, Chris explained to Jaysen and I that, given his issues with the banks, we now needed some formal documentation in place to assist with Know Your Client (KYC) requirements that banks had imposed. I was under the impression that by documenting our agreement this would assist in gaining access to our funds. At tab 11 is a true copy of a loan agreement executed between Jaysen and Chris dated 1 September 2018.
- 58. I was directly involved in the preparation of this agreement, having drafted it myself. I am aware that it was prepared reflecting our general understanding of the terms on which we had advanced money to Chris for the investment.
- 59. I note that there is no specific loan amount noted in the agreement. Instead, the amount of the loan is described to be based on cash calls made by Chris with interest to accrue from the date of payment. I understood these cash calls to represent the additional funds advanced to Chris to invest. Accordingly, the amount of \$1.45m that Chris promised to pay Jaysen under the agreement (with interest and charges (cl 4)) represented the amount advanced to Chris by Jaysen and I (through our jointly operated companies) at the time of this Agreement.
- 60. The reference to the special interest that Chris is to pay based on the trading performance reported by Chris represents the allocation of the winnings to Jaysen and Nameo.
- 61. Given that all money had been transferred from Jaysen's account to Chris directly, in relation to any advances made, I formed the view that it was appropriate for the written agreement to be solely between Chris and Jaysen.

Further Bank Issues & Introduction to Josh Hunt of HopgoodGanim

- 62. Following the apparent transfer of funds from NAB to Westpac, after the closure of Chris' NAB account, I understand that Chris started experiencing similar problems with Westpac. Chris then informed me that he was moving his money to Macquarie. Jaysen and I continued to request verification from Chris as to this.
- 63. At **tab 12** is a true copy of an email from Chris to me dated 1 August 2019 attaching a bank statement purportedly evidencing the transfer of funds from Westpac to Macquarie in the amount of \$15,617,831.81, together with a Westpac bank account statement from Chris. I note the transfer and statement is certified by Lenny Rego as a Westpac Bank Manager.
- On 2 August 2019, I received an email from Lenny to Chris (copied to me) enclosing documents stamped with Lenny's signature and various pages of account transaction summaries relating to Chris' accounts. I noted that within that bundle of documents was the statement of transfer from Chris' Westpac account to his Macquarie account. I also observed within this bundle of documents that certain pages appeared to be bank generated and others appeared to be from Chris' personal intranet account with Westpac. I observed this based on the information appearing at the footer of each page which was different in parts. At **tab 13** is a true copy of that email from Lenny to Chris together with an attachment titled "20190801160737339.pdf" enclosing the various documents of Chris' accounts stamped and signed by Lenny.
- 65. Upon review of those documents, I recall remaining concerned that something was wrong and being unsure as to why I had still not seen any money from Chris or why there was not confirmation that the money had moved to his Macquarie account.
- 66. On 12 August 2019 I received a further email from Lenny Rego at Westpac. This email was in response to a query from me as to what happens with the funds if they are not received by Macquarie. I noted, immediately upon reading that email, that Lenny confirmed that he did not assist Chris to complete the transfer of funds and that he had only certified that "the receipt that Chris presented...was the Payment Summary (page 26). I did not need to confirm the transfer took place." At tab 14 is a true copy of an email from Lenny to me dated 12 August 2019.
- At around this time I first met Adam Fletcher who is a party to this action. I know that Adam was good friends with a business contact of mine, Mr. Peter Aleksander. I first met Adam through Peter, who introduced Jaysen and I to Adam for the purposes of a property investment that Adam was involved in. From that Jaysen and I built a relationship with Adam. I then met Stuart Campbell (who is also a party to this action) through Adam.

- 68. In around mid to late 2019 (September/October) I learnt that Chris was dealing with Josh Hunt of HopgoodGanim and I was under the impression that Josh could assist Chris with access to money issues.
- 69. Due to my frustration I started to distance myself from being a point of contact with Chris and allowed Jaysen to handle things from then on. Notwithstanding this, and Josh's involvement, I continued to observe that there was a lack of progress being made with any access to funds.
- 70. In around September 2020 Chris then informed me that Adam and Stuart were involved in this same investment. Adam and I started talking about our similar issues with an inability to obtain access to funds once we realised the mutual connection.

RECENT DEVELOPMENTS - URGENCY

71. While matters regarding the access to funds continued to linger, from around mid to late last year my concerns started to grow. They have now severely increased.

Further closure of accounts

- 72. In around early 14 August 2020, Josh and I were involved in a meeting with Macquarie which I understood was going to be for the purposes of talking about future strategy with dealing with Chris' investment and how we could access our funds despite what I was being told by Chris were AML compliance issues. That meeting was initiated by Chris.
- 73. I was informed by Chris that Macquarie was willing to deal with Chris as a customer based on his investment and that there would not be issues regarding AML compliance. I hoped this was correct and, having my own trading account through Macquarie, I was hopeful that it would be a simpler process than what we had previously encountered.
- 74. At that meeting both Josh and I were present with Chris at Macquarie's office at 240 St Georges Terrace. Unfortunately, it became clear to me that the people at the arranged meeting were part of Macquarie's wealth management team and would unlikely deal with the issues Chris was confronted with. When I explained the situation, they could not assist.
- 75. Following that meeting Chris tried to transfer money to my Macquarie bank account in the amount of 1 cent. Chris told me that he was doing this to link the accounts because that would make the transfer of future money more efficient. That transaction was successful, the 1 cent was credited to my account. Shortly after that transaction my account was closed by Macquarie without any notification or explanation.
- 76. I did not receive any notification of this in writing, but my stockbroker, Hugo McChesney of Shaw and Partners, informed me that my bank account at Macquarie was being closed and that I had a period of time in which to set up a new account and to transfer

funds out to another bank. Hugo informed me that he had spoken with a Macquarie representative and they were not at liberty to disclose why they were closing my account. Hugo informed me that he had never seen this before and that he understood, from his telephone conversation with the Macquarie representative, that I would not get any information from Macquarie.

77. Based on this, at that time, I considered there appeared to be genuine banking issues with Chris' accounts.

ATO, AUSTRAC and ASIC Representations

- 78. At around this time, I was also informed by Chris that the ATO was the reason that the banks had locked down his accounts. At this time Chris sent me a photo showing part of a notice of assessment from the ATO for approximately \$36m. At tab 15 is a true copy of the screenshot that Chris sent me.
- 79. The following month, in or around late November early December, I was further informed by Chris that ASIC had been making enquiries in relation to his business activities and whether he needed an AFSL and that Josh Hunt was managing this. I was later informed by Josh that he was not managing this.
- 80. At around this time Chris also started advising me that he was having issues with AUSTRAC and they had locked down his accounts.
- 81. On or around 15 January 2021, Chris informed me that he had made a "settlement payment" with AUSTRAC for \$4.5m. Chris had previously informed me that he had made another "settlement payment" of \$1.5m to AUSTRAC. This caused me to question Chris' version of events, as I am not aware of any proceedings being commenced by AUSTRAC against Chris or by or any other regulatory authorities. Furthermore, Chris stated that he had signed a settlement deed with AUSTRAC. On or around 15 January 2021, when I requested a copy of the settlement deed, Chris stated that he did not have one. At tab 16 is a true copy of an email which appears to be from AUSTRAC to Chris dated 22 January 2021.

Acknowledgements of debt and location of funds

82. 83.



- 84. At around that time I had become increasingly concerned about the security of our funds with Chris, however after receiving letters of this type I at least felt that the funds were in existence and could be made available once such issues were sorted.
- 85. Despite having received the above assurances from Chris and Josh Hunt, I am now however, extremely concerned as I currently have no assurance that there is any money in any of the bank accounts that Chris shown to me.
- 86. Further, Jaysen has told me that Chris had previously provided him with login access for his BOQ account and his NAB account. I am informed by Jaysen, and I believe that previously there was money going into his BOQ account, but now there is no money going into this account and the balance of this BOQ account is zero.
- 87. I am also informed by Jaysen, and I believe, that Chris' Macquarie account was closed down in December 2020 with \$109m in it and there is no longer any visibility on this account.
- 88. Chris has also informed me that ING account was closed down in January 2021 with approximately \$3.5m in it. Chris told me this, and Jaysen has shown me screen shots of that account which show that it is closed. Chris has told Jaysen and I that he hasn't received a cheque from that account despite its closure.

Ability to alter NAB Trade Account Balance - 11 March 2021 Meeting

- 89. Chris has further told Jaysen, who informed me on or around 3 March 2021, that he now has approximately \$172m in his NAB trade account and he has provided Jaysen with login access to that account. I had recently sighted that account and confirmed that the money appeared to be there.
- 90. Given my growing concerns, however, on Wednesday 10 March 2021 Chris told me that he would take Jaysen or Adam to NAB to explain what the process is with the banks and why the money is being held up. I tried to arrange a meeting with Chris to call NAB with each of Jaysen and Adam on the call. Chris said he was going to have that call and then cancelled, or never organised for it to happen.

- 91. On 11 March 2021, I was then informed by Adam, and I believe, that he attended the offices of Josh Hunt of HopgoodGanim for a meeting with Chris regarding issues concerning access to the funds.
- 92. Immediately prior to that meeting I was in the airport lounge with Jaysen returning on a work flight from the Port Hedland and Jaysen handed me his phone where he had logged into Chris' NAB trade. I wanted to verify for myself how the money was in there and wanted to try and play around with the account. During the course of that I discovered the ability to manually alter the balance to zero. I was also able to change the balance to read \$100.00.
- 93. I immediately telephoned Adam to tell him to get Chris to log on to his account and view the balance. I am informed by Adam and I believe that Chris was shocked when he logged on, that he swore and that he appeared to be physically shaking. I am further informed by Adam that, at that meeting, Adam was shown an affidavit sworn by Chris, which was filed in the bankruptcy proceedings, verifying that the \$172m was in his NAB account. Adam informed me that he was assured, at that meeting, that the money is with Chris.
- 94. All of the above events have left me extremely confused as to what is the status of funds that I invested with Chris and have caused me serious concern that those funds, and any profit derived from them, may either not exist or may have been transferred to a location that I am not aware of. This has caused me to wonder whether the \$172m ever existed in Chris' account or whether the appearance of those funds were just created by him.
- 95. I am further concerned that, as a result of the 11 March 2021 meeting, Chris will be "spooked" from being confronted about the ability to change a balance in the NAB account. I am concerned that this may lead Chris to take action concerning funds held in his accounts, particularly if he is aware that these proceedings have been commenced.

Undertaking

96 I understand that the plaintiffs in this action are required to give an undertaking as to damages in support of the freezing order and related relief sought in the absence of the defendant. I confirm, as a director of Nameo, Jaytona and 365 Plant Hire the following:

Conclusion

- 97. In view of the material outlined above, I respectfully request that this matter be heard on an urgent basis in the absence of Chris because I am concerned that if the orders sought by the IP, and particularly the freezing orders, are not made on an *ex parte* basis, then there is a heightened risk that Chris will seek to transfer or dissipate the funds so that I and other investors are left without any recourse to our money.
- 98. For the reasons given above, I seek the IP be heard on an urgent *ex parte* basis in the first instance.
