- 1. As you are aware, we act for Westpac Banking Corporation.

  - (b) Order 1 of the Court's orders made on 29 June 2021 permitting the search party named in Annexure C in respect of the Sydney Premises to re-enter the premises for the purposes of conducting the search until such time as the search has been completed; and

- 3. We understand from the conduct of the Search Order at the Sydney Premises that:

  - (b) the Server is hosted on behalf of your client by a third party named OurKloud (**Third Party Provider**) in a warehouse located in Alexandria, New South Wales.
- 4. We are advised by the Independent Solicitor appointed by the Court in relation to the Sydney Premises, Felicity Healy, that Mr Sun has been unable to extract any data from the Server. We understand from Mr Sun that the extraction of server data may take several weeks to download via the internet connection at the Sydney Premises and he will need a backup copy of the servers from the Third Party Provider.
- 5. We request that your client make urgent arrangements, including with the Third Party Provider, to provide Mr Sun a backup copy of the Servers from the host site in Alexandria. Please confirm no later than **5pm** on **6 July 2021** the arrangements that have been made.
- 6. In the event that your client does not assist in relation to the request at paragraph 5 above, our client reserves its rights to approach the Court to obtain further orders to secure access to the Server from the Third Party Provider on an urgent basis.

Find below a requested summary of the Office 365 environment and the virtual servers for the Forum Group.

### Microsoft Office 365 Environment

- 1. The emails for Forum Financial are stored within the Microsoft Office 365 environment.
- 2. The documents for Forum Financial are stored in both OneDrive and Sharepoint within the Microsoft Office 365 environment.
- 3. There is approximately 5.6TB of data stored on the Microsoft Office 365 environment.
- 4. Approximately 3.2TB has been downloaded from Office 365 as at 7pm on 6<sup>th</sup> July 2021.
- 5. Data was migrated from the virtual servers in 2020. The IT manager was unable to provide an exact time of the migration.

### Virtual Servers in Alexandria data centre

- 6. Previously, documents and emails for Forum Financial were stored on the virtual servers mail16-01.fg.internal and fg-file01 at a datacentre in Alexandria, NSW.
- 7. Although the data on the two servers mail16-01.fg.internal and fg-file01 were migrated to Office 365, it is unclear whether all data on the two servers were migrated in its entirety.
- 8. The accounting system used by Forum Financial is BMS and is hosted in a virtual server at a datacentre in Alexandria, NSW.

- 9. Filebound is a software solution used by Forum Financial to scrape data from invoices. The system is also stored in a virtual server at a datacentre in Alexandria, NSW.
- 10. There are also various number of servers which are hosted at a datacentre in Alexandria, NSW.

- 11. The servers at the data centre is managed and operated by a third party IT service party called Our Kloud.
- 12. Collection of data on the virtual servers can be performed using one of the below methods:
  - a. Obtain a copy/backup of the Virtual Servers from the 3<sup>rd</sup> party IT service provider "Our Kloud" this is the cleanest and most efficient way to obtain a copy of the servers and allows for the servers to be started and replicated in alternate environments. The ability to replicate the servers and have them in an operable state is extremely important when dealing with servers at a later stage which hosts accounting and financial systems. If backups were in place, a snapshot or copy of the servers at a specific point in time can also be obtained.
  - b. Access the virtual servers from the Forum Group Sydney office and copy the servers to a storage device in the Forum Group Sydney office this method requires an uninterrupted and stable internet connection to the data centre from the office. It could take weeks for the copying of the servers to complete based on the estimated data size of the Office 365 environment. This method usually does not allow a server to be operable in an alternate environment.

### Telephone call with Our Kloud

- 13. On 30<sup>th</sup> June 2021 at 1310 Hrs, I was contacted by Mr Paula Salibe ("Mr Salibe") of Our Kloud. During the whole duration of the call, I was in the presence of the independent solicitor.
- 14. I asked Mr Salibe to prepare a list of all Forum Group servers along with their corresponding storage size.
- 15. I also asked Mr Salibe provide a backup of all Forum Group servers.
- 16. Mr Salibe indicated he will come back to me with the requests and the likely timing of providing a copy of the Forum Group Servers.
