- 9. I first met the plaintiff (**Mr Palmer**) in or about 2005 or 2006. I first met Mr Palmer in my capacity of Chairman of Australasian Resources Ltd and in connection with the possible acquisition of iron ore resources in Balmoral, Western Australia. I refer further to that project in paragraph 11 below.
- 10. Since that time I have got to know Mr Palmer very well. On the business side I have been a director of a number of his associated companies including Australasian Resources Ltd (which became associated after the abovementioned transaction concluded), Resourcehouse Ltd, Gladstone Pacific Nickel Ltd, Mineralogy Pty Ltd and others. In addition I have advised him on a number of proposed business transactions. On the personal side I have got to know Mr Palmer and his family very well. Our families have enjoyed numerous social occasions together and my wife and I have travelled extensively in Australia and Europe for many years with the Palmer family. During this time I have become a close personal friend to Mr Palmer.

I am involved in business and corporate advisory assignments across a number of States, primarily New South Wales, Western Australia, Queensland and Victoria. I have a particularly strong network in the mining and resource community in those States and most importantly in the investment, institutional and stockbroking communities that fund and support mining projects. I also have a network of senior public company directors developed over my years since being CEO of Deloitte. I mix in these circles socially as well. In addition my firm provides pro bono services to some charitable operations and I have an involvement in those circles. Mr Palmer is well known in these circles due to his substantial involvement in the mining and resources industry in Western Australia and Queensland and his propensity for philanthropic commitments.

- 18. That link includes the actual publications which are referred to as the first to sixth matters complained of in Mr Palmer's Statement of Claim. I refer to those below as "the matters complained of".
- 19. I do not recall precisely where I was or when at the time when I first became aware of each of the matters complained of. However, I recall that I saw television news footage of Mr McGowan saying some of those things and that I read some of them in print and online newspaper publications on about the dates when the Premier of Western Australia was making the relevant statements.
- 20. I speak to Mr Palmer on a regular basis. Often when I see press about him I will call him or he will call me to discuss it. I have an office in Perth so I keep a keen eye on Western Australian news reports both in television and online newspapers etc. On seeing news reports of the matters complained of, I telephoned Mr Palmer to see how he was doing given the comments which had been made about him by Mr McGowan. Mr Palmer said words to the effect that he was deeply hurt by those comments and referenced the enormous contribution he has made over the years to Western Australia. He said words to the effect that these comments not only dismissed and ignored that contribution but falsely portrayed him in a light of a predator working against Western Australia in an avaricious and self-serving manner.

Mr Martino commenced his career initially in Chartered accountancy and corporate finance in Western Australia. There he established and built a Chartered Acountancy firm specialising in the mining industry and corporate transactions. With offices in Perth and Kalgoorlie Mr Martino as managing partner of the firm was instrumental in building the firm into one of Perth's 6 largest accountancy firms. In 1994 the firm was sold and merged into Deloitte Touch Tohmatsu (Deloitte) one of the big 4 accounting and consulting firms and Mr Martino and his partners became partners of Deloitte. Mr Martino was appointed the Western Australian Managing Partner of the Western Australian Deloitte practise at the time of the merger.

In 1998 Mr Martino transferred with Deloitte to Sydney where he was promoted to the Managing Partner of the New South Wales practice and ultimately the Chief Executive Officer of Deloitte in Australia from 1998 to 2003. During that time he was also a member of the Global Executive Committee of Deloitte Touche Tohmatsu International. He was a Partner of Deloitte and its predecessor firms from 1981 to 2003 during which time, in addition to a number of management operational roles, he specialized in the corporate finance area, including mergers and acquisitions, initial public offerings and strategic opportunities.

Since leaving Deloitte Mr Martino established Indian Ocean Corporate Pty Ltd a boutique corporate advisory and investment banking firm with offices in Sydney, Perth and Guangzhou China. It specialised in mining and resources projects, food and technology projects and Cross boarder Australia/China deals. Mr Martino has also during this time been instrumental in a number of corporate and business deals.

In the early 2000's he established the ASX listed Sydney Gas Ltd of which he was Chairman and founding shareholder. Sydney Gas Ltd developed the first coal bed methane project in NSW in the Camden area supply gas to Sydneys network. This field still operates today providing gas to AGL's network. Sydney Gas Ltd was ultimately taken over by AGL Ltd

In 2006 Mr Martino was instrumental in establishing Australiasian Resources Ltd listed on the ASX which acquired a billion tonne iron ore project at Balmoral Western Australia. Mr Martino raised circa \$60million from strategic Chinese and Hong Kong investors to complete a comprehensive banakable feasibility study for the project.

In 2010 Mr Martino established with mining engineer Peter Lynch ASX listed Cokal Ltd focussed on building a global metallurgical coal business in Indonesia's Central Kalimantan region. Initially as a director and subsequently as Chairman after the untimely death of Peter Lynch Mr Martino has raised circa \$100million over the last 10 years for Cokal Ltd also introducing a major industry strategic investor to the company. Cokal used thes funds to explore and then establish a substantial resource and ultimately develop a world class metalurgical coal project which is commencing production in 2021.

Mr Martino initially funded Lang Technologies Pty Ltd (Lang) a company that developed the innovative CCE technology for the extraction of juice from fruit more efficiently while retaining greater nutritional value than conventional processes. After raising further capital for Lang to develop its technology and business Mr Martino arranged the ASX listing of Lang through a reverse takeover establishing the ASX listed The Food Revolution Group

Ltd (FOD). Simultaneously with listing FOD acquired the juice factories in Mill park Victoria and ultimately the juice brands "The Origonal Juice Co" and "Black Label" from Heinz. Fod's clients include Australian supermarkets Coles, Woolworths and Aldi as well as a number of export clients in China and Japan. It is the holder of a number of innovative, health and food related patents.

Subsequent to listing FOD Mr Martino arranged and closed the deal for Norman Li's Careline group to invest circa \$15million in FOD and in conjunction bringing the Careline Groups extensive Chinese distribution networks to FOD. FOD a successful drinks manufacturer in Australia with clients like Coles, Heinz, Woolworths and Aldi is now connected to the Chinese market through Carelines Cmart online sales network and Careline's offline Chinese distribution capability through its substantial Shanghai operation. Mr Martino's relationships and foresight in joining these two groups has helped create one of Australia's next substantial food and beverage companies operating in the Australian market and exporting to China.

Mr Martino has also been a Director/Chairman and founding shareholder of a number of other listed public companies including as a founding Director and former Chairman of Oil and Gas companies Blue Energy Limited (formerly Energy Investments Limited) and South Pacific Resources Ltd .
